## Independent Auditor's Report

To the Plan Administrator of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Compu Dynamics, LLC Retirement Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. **Notes to Financial Statements**

**(1) Description of the Plan**

The following description of the Compu Dynamics, LLC Retirement Trust (the Plan) provides only general information. Participants should refer to the Plan document and any amendments for a more complete description of the Plan's provisions.

**General:** Compu Dynamics, LLC (the Company) established a defined contribution plan on January 1, 2002, covering all employees of the Company who are eligible to participate based on the eligibility requirements listed below. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

**Eligibility:** Employees except for union employees, nonresident aliens, leased employees, residents of Puerto Rico, and independent contractors of the Company are eligible to participate in the Plan. A participant becomes eligible upon date of hire.

**Contributions:** Eligible participants may elect to contribute a percentage of their eligible compensation, not to exceed the limits set by federal law. The annual limit for elective deferrals for the years ended December 31, 2024 was \$23,000. Individuals age 50 or over by the end of the plan year are allowed to make additional contributions to a 401(k) plan, in excess of the standard limits. Such additional contributions were limited to \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified defined contribution plans.

The Company is required to make certain QACA (Qualified Automatic Contribution Arrangement) contributions equal to the sum of 100% of a participant's elective deferrals that do not exceed 1% of a participant's compensation, plus 50% of a participant's elective deferrals that exceed 1% of a participant's compensation but do not exceed 7%. The Company may also make nonelective employer contributions. During 2023, the Company made a nonelective employer profit sharing contribution up to 0.50% of employee compensation eligible employees that participated in the Plan. The Company made \$475,613 employer matching contributions for the year ended December 31, 2024.

Contributions are subject to certain limitations.

**Participant Accounts:** Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, if any, and (b) Plan earnings/losses, and may be charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The participant can redirect their investments at any time to any of the available funds in the Plan as frequently as daily.

**(1) Description of the Plan (continued)**

**Vesting:** Participants are immediately vested in their elective deferrals, rollover contributions, safe harbor matching contributions (prior to the Plan adopting a QACA contribution) plus actual earnings thereon. Vesting in the Company's current contributions is based on years of service. All employer nonelective contributions are 100% vested upon entering the Plan. All QACA safe harbor contributions become 100% vested after two years of credited service.

Effective December 31, 2022, the Company adopted an amendment that made all participants in the Plan during 2020 through 2022 100% vested in all employer contributions.

Effective January 1, 2023 participants are no longer 100% vested in employer nonelective contributions upon entering the Plan but are 100% vested after 2 years.

**Notes Receivable from Participants:** Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made. Loan terms range up to five years; however, this limit can be extended if the loan is used by the participant for the purchase of a primary residence. The loans are secured by the vested balance in the participants' accounts and bear a reasonable rate of interest as negotiated between the Plan administrator and the participant. The Plan may charge a fee for the administrative expenses of processing the new loan. Principal and interest is paid ratably through payroll deductions. Interest rates on outstanding loans range from 4.25% to 9.50% as of December 31, 2024.

**Payment of Benefits:** Upon termination of service, death, disability or retirement at age 65, a lump sum of the participants' vested account balance will be distributed to the participant or beneficiary. Involuntary distributions can be made by the Company if the vested balance is less than \$5,000.

A terminated or retired participant with a vested balance of greater than \$5,000 may elect to receive payment from their account as soon as it is administratively feasible following severance of employment or postpone payment until a later date. If payment is postponed, the account will continue to share in investment earnings. Upon the death of a participant before retirement or termination of employment, the current balance of such participant's individual account shall become payable as of the valuation date coincident with or next following his or her death.

In-service withdrawals and hardship withdrawals are permitted if certain criteria are met.

**Forfeited Accounts:** The Plan currently allows for forfeitures to be used to reduce employer contributions. At December 31, 2024 and 2023, there were forfeiture balances available of \$0 and \$1,142, respectively. Forfeitures totaling \$70,441 were used during the year ended December 31, 2024.

**(2) Summary of significant accounting policies**

**Basis of accounting:** The accompanying financial statements are presented on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis and is charged on the loans at rates ranging from 4.25% to 9.50%. Related fees are recorded as administrative expenses and are expensed when they are incurred. The Plan has not identified any uncollectible notes receivable at December 31, 2024 and 2023. Notes that become uncollectible are reported to the participant as a deemed distribution.

**Funding policy:** Contributions are funded as accrued.

**Administrative expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Payment of benefits:** Benefit payments to participants are recorded when paid.

**(3) Information prepared and certified by the Plan’s custodian**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company, the custodian, has certified as to the completeness and accuracy of the following information included in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related activity reflected in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the accompanying Notes to Financial Statements.

**(4) Fair value measurements**

Accounting Standards Codification Topic 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability. The Plan does not have any Level 2 investments.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The Plan does not have any Level 3 investments.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Registered investment companies (mutual funds):* The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

*Common Collective Trust Fund:* The fair value of the stable value fund is based on the net asset value (NAV) of participation units. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investments for an amount different than the NAV. Participant transactions (purchases and sales) may occur daily. The fund provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit. If the Plan initiates a full redemption, the issuer reserves the right to require twelve months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**(5) Related party transactions and party-in-interest transactions**

The Plan paid certain expenses related to plan operations and investment advisory services to various service providers. These transactions are party-in-interest transactions under ERISA. The administrative expenses paid by the Plan to these services providers totaled \$51,157 for the year ended December 31, 2024.

**(6) Termination**

Although it has not expressed any intent to do so, the Company has the right under the terms of the Plan to discontinue its match contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

**(7) Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the Statements of Net Assets Available for Benefits.

**(8) Tax status**

The Plan is a qualified cash or deferred arrangement established under Section 401(k) of the Internal Revenue Code. The Plan sponsor has executed a non-standardized form of a prototype plan sponsored by a third party administrator and relies on the determination letter dated June 30, 2020. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has an uncertain tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan Administrator has evaluated the Plan's tax positions and has concluded that there are no uncertain positions taken or expected to be taken that would require adjustments to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is generally no longer subject to income tax examinations by federal, state, or local tax authorities for years prior to 2021.

**(9) Operational defects and errors**

It was discovered that a Plan provision was not properly applied in the operation of the Plan. The definition of compensation for participant and employer contributions as per the Plan document was not properly applied when calculating contribution amounts. The error occurred in how items were marked in the payroll system which improperly excluded certain payroll codes from plan compensation. An initial assessment of the impact to the Plan for this error was reviewed and it was deemed insignificant. The error within the payroll system were corrected during September 2025.
