This representation letter is provided in connection with your audit of the financial statements of Enverus 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (collectively, the “financial statements”).

We elected to have the audit of the plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (DOL) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). We acknowledge that the audit did not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier, that is regulated, supervised, and subject to periodic examination by a state or federal agency, a qualified institution, that prepared and certified the investment information in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. The Company has not applied for a determination letter from the IRS to determine if the Plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan document was based upon a prototype non-standardized profit sharing plan with cash or deferred arrangement (“CODA”) plan instrument from Principal Life Insurance Company which received an IRS opinion letter dated March 31, 2014. Effective February 18, 2022, the Plan document was amended based upon a non-standardized pre-approved profit sharing plan with CODA plan instrument from Principal Life Insurance Company which received an IRS opinion letter dated June 30, 2020. The plan instrument has been updated for legislative and regulatory changes. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements. U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
- 32) The Plan is qualified under the appropriate section of the Internal Revenue Code, and we intend to continue the Plan as a qualified plan. The Plan sponsor has operated the Plan in a manner that did not jeopardize this tax status. Required nondiscrimination testing related to Code Section 401(k) and 401(m) arrangements, as applicable, has been completed for the Plan, and any excess deferrals or contributions have been disposed of in accordance with regulations.

- 35) We have obtained appropriate fee disclosures from covered service providers and have concluded the fees are reasonable. The Plan is in compliance with DOL regulations regarding ERISA Section 408(b)(2).
- 36) We acknowledge our responsibility for presenting the Schedule of Assets Held for Investment Purposes at End of Year (the “Supplemental Schedule”), in accordance with U.S. GAAP and in conformity with the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. We believe the form and content of the Supplemental Schedules are fairly presented in conformity with the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. The methods of measurement and presentation of the supplemental schedule have not changed from those used in the prior period, and we have disclosed to you any significant assumptions or interpretations underlying the measurement and presentation of the supplemental schedule.
- 37) Except for the corrections listed below, the Plan has complied with the DOL’s regulations concerning the timely remittance of participant contributions to trusts containing assets for the Plan. We understand that the DOL regulation states that participant contributions must be submitted to the Plan as follows:
- i) “The earliest date on which the contributions can reasonably be segregated from the employer’s general assets.”
 - ii) There is no “Safe Harbor” for timely submitting participant contributions.

Based on our history of participant contributions during the year ended December 31, 2024, we remitted participant contributions between two days before and three days after the payroll date, with our average being 1 day from the payroll date. With the exception of the note at #38 below we do not believe that contributions that are 2 days from the payroll date should be considered late contributions to be reported on “Schedule of Delinquent Participant Contributions”, but we understand that the DOL may reach a different conclusion in the event they review the Plan.

- 38) During 2020, the Plan Sponsor failed to remit participant contributions in a timely manner. The Plan Sponsor identified one instance during the year ended December 31, 2020, where \$528 in participant loan repayments were remitted to the Plan in violation of DOL regulations. The missed earnings and interest were corrected in August 2024 outside of the DOL's Voluntary Fiduciary Correction Program ("VFCP").
- 39) In February 2025, the Plan Sponsor processed and submitted the annual safe harbor employer match true-up in the amount of \$340,765, including the related lost earnings and interest, to the Plan on behalf of the affected participants. The Plan has recorded an employer contribution receivable of \$340,765 as of December 31, 2024.
- 40) In regard to the financial statement preparation services performed by you, we have—
 - 1) Assumed all management responsibilities.
 - 2) Designated an individual who has suitable skill, knowledge, or experience to oversee the services.
 - 3) Evaluated the adequacy and results of the services performed.
 - 4) Accepted responsibility for the results of the services.
 - 5) Ensured that the data and records are complete and we have sufficient information to oversee the services.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Enverus, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Note 1 – Description of the Plan

The following description of the Enverus 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

Enverus, Inc. (the “Plan Sponsor”) adopted the Plan effective January 1, 2005. Effective January 1, 2023, the Plan Sponsor amended the Plan Document to reflect its corporate name, Enverus, Inc, and amended the plan name from Drilling Info, Inc. 401(k) Plan to Enverus 401(k) Plan.

The Plan is a defined contribution plan covering all eligible employees of the Plan Sponsor, and its subsidiaries, who are at least 21 years of age, as defined by the Plan Document, with exception of certain classes of employees identified in the Plan Document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Administration

The Plan is administered by the Plan Sponsor. Plan assets are held by the Principal Trust Company (the “Trustee”). The financial records of the Plan are maintained by Principal Financial Group (the “Recordkeeper”).

Participant Contributions

Contributions are made to the Plan by the Plan Sponsor on behalf of each eligible participant based upon the participant’s elected compensation deferral through payroll deductions. The Plan Sponsor funds the contributions at the end of each payroll period. Eligible participants may elect to contribute 1% to 100% of their eligible compensation, in whole percentages, to the Plan up to the statutory limit of \$23,000 for 2024, as permitted by the Internal Revenue Code of 1986, as amended (“IRC”). The Plan has an automatic enrollment. Unless the participant elects not to make contributions, participants are enrolled in the Plan with a 5% contribution. Effective January 1, 2023, the Plan automatically increases participant contributions by 1% annually, not to exceed 10%. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participants age 50 and older as of December 31 of the Plan year are permitted to make elective catch-up deferrals in accordance with Section 414(v) of the IRC.

Employer Contributions

The Plan Sponsor contributes Safe Harbor employer matching contributions equal to 100% of the first 3% of compensation that a participant contributes to the Plan and 50% of the next 2% of compensation that a participants contributes to the Plan.

The Plan Sponsor may also elect to make a discretionary contribution of an equal dollar amount to all eligible participants, in addition to the matching contribution. For the year ended December 31, 2024, the Plan Sponsor did not make a discretionary contribution to the Plan.

Note 1 – Description of the Plan (continued)

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution and allocations of (a) the Plan Sponsor's contribution and (b) plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Rollovers and Transfers

Participants who have a balance in another qualified employee benefit plan, as described in Section 401(a) of the IRC, may transfer or rollover the lump sum values of their account directly into the Plan, provided it meets the requirements of the IRC.

Vesting

Participants are immediately and fully vested in their contributions plus actual earnings and in the Safe Harbor employer matching contribution plus actual earnings.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000, or 50% of their vested account balance, whichever is less. The notes receivable are secured by the balance in the participant's account. The rate of interest on the note will be determined by the Plan Administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Only two note receivables may be initiated in one calendar year, and two note receivables may be outstanding at a time unless one loan is a principal residence loan amortized for a period greater than five years.

All notes must be repaid in level payments through after-tax payroll deductions each pay period over a five-year period unless it is for the purchase of the principal residence in which case the note repayment period may not extend beyond 10 years from the date of the note.

Payment of Benefits

Benefits become available to participants on the earliest of four events: (1) termination of employment, (2) death of the participant (benefits are payable to the participants spouse or beneficiary), (3) disability of the participant, or (4) the participant's retirement.

A participant may receive the value of the vested balance in his or her account as a lump-sum distribution, installment distributions, partial distribution or may roll the amount over into another qualified plan. If the vested account balance is \$7,000 or less, the Plan Administrator may direct the Trustee to distribute the amount as a lump-sum to the terminating participant regardless of whether participant consent is received. Participants are permitted to remain in the Plan if their account balance exceeds \$7,000.

The benefits can be left in the Plan until the participant retires. Benefits cease to vest upon termination of employment. Non-vested benefits will be forfeited on such date. However, the participant is required to begin taking minimum distributions no later than April 1 of the calendar year following the calendar year the participant turns 72, and 73 (depending on the date of birth), or terminates employment, whichever is later.

Active participants can withdraw benefits once they reach 59 ½ years of age. In-service distributions are permitted due to hardship, as defined in the Plan and subject to the satisfaction of the Plan Administrator.

Note 1 – Description of the Plan (continued)

On termination of employment due to death prior to retirement, 100% of the Plan Sponsor contributions become immediately vested. The value of the account shall be paid in accordance with the above stated distribution procedure.

Upon a participant obtaining the normal retirement age 65, while still employed, 100% of the Plan Sponsor contributions become immediately vested. Should a participant reach age 65 and not elect to terminate employment, the participant can take an in-service distribution from the vested account balance.

If the participant becomes disabled and is eligible for Social Security disability benefits or is determined disabled by a physician selected by the Plan Administrator, the full value of the participant's account becomes 100% vested and shall be paid in accordance with the above-stated distribution procedure.

Forfeited Accounts

The portion of the participant's employer contribution accounts that are not vested if any upon termination of service shall be forfeited as of the earlier of (1) the date the vested portion is distributed or (2) the date the participant incurs a five-consecutive-year period of severance from his or her original termination date.

At December 31, 2024 and 2023, the available forfeited non-vested accounts totaled \$0. These accounts may be used to reduce future plan administrative expenses and employer contributions. During the year ended December 31, 2024, \$0 of forfeitures were used to reduce employer contributions and employer expenses.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts and distributions would be made as soon as administratively practical after the Plan terminates.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment adviser and Trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and Plan management deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded. During the year ended December 31, 2024, \$84,919 was recorded as interest income on notes receivable from participants.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

Risks and Uncertainties

Financial instruments which potentially subject the Plan to concentrations of credit risk consist primarily of investment securities in which the Plan invests. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Reclassifications

Certain prior year amounts have been reclassified for consistency with current year presentation. These reclassifications had no effect on the reported net assets available for benefit payments.

Note 3 – Information certified by the Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee has certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedule as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits, as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan's independent auditor did not perform auditing procedures with respect to the certified information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

Note 4 – Tax Status

The Plan Sponsor has not applied for a determination letter from the Internal Revenue Service ("IRS") to determine if the Plan is designed in accordance with applicable sections of the IRC. The Plan document is based upon a non-standardized pre-approved profit sharing plan with CODA plan instrument from Principal Life Insurance Company which received an IRS opinion letter dated June 30, 2020. The plan instrument has been updated for legislative and regulatory changes.

The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the Plan Administrator believes it is subject to income tax examinations for three years.

Note 5 – Fair Value Measurements

The Plan follows a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are described as follows:

- Level one — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level two — Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level three — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. The mutual funds are registered with the Securities and Exchange Commission and are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts: Valued at the NAV of units for each trust. The NAV, as provided by the Trustee, are used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily.

Pooled separate accounts: Valued based upon the unit values of such pooled accounts held by the Plan at year end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although they are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

Note 6 – Investment in Fully Benefit-Responsive Investment Contracts

The Plan offers a capital preservation investment option known as the Principal Fixed Income Guaranteed Option, which is a group annuity contract issued by Principal Life Insurance Company. The contract is designed to provide a stable rate of return and preservation of principal.

Under the terms of the contract, Principal Life guarantees the payment of principal and interest for participant-initiated withdrawals and transfers in accordance with Plan provisions. The investment is considered a fully benefit-responsive investment contract and is reported at contract value, which represents the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

As of December 31, 2024, the contract and fair value were \$2,410,577, and \$2,410,577, respectively. As of December 31, 2023, the contract and fair value were \$2,454,047, and \$2,454,048, respectively. The crediting interest rate was 2.50% as of year-end and is subject to periodic adjustment by the issuer but is guaranteed not to be negative.

There are no reserves against contract value for credit risk or other potential losses. The investment is backed by the general account of Principal Life Insurance Company, and participants bear the credit risk of the issuer.

While the contract permits participant-directed withdrawals at contract value, plan-initiated redemptions may be subject to a 12-month advance notice or other termination provisions. No such restrictions were in effect as of the reporting date.

The contract meets the criteria for full benefit responsiveness as defined in ASC 962-325-25, and the Plan has no intent to terminate the contract or take any action that would limit its benefit-responsive status.

Note 7 – Parties in Interest Transactions

Certain Plan investments are managed by the Trustee or its affiliates. Fees incurred by the Plan for related investment management services are included in administrative expenses and net depreciation in fair value of investments. Certain fees incurred by the Plan for recordkeeping and audit fees are included in administrative expenses. Transactions such as these qualify as party-in-interest transactions. The Plan Sponsor pays directly certain other fees related to the Plan's operations.

Note 8 – Prohibited Transactions

During 2020, the Plan Sponsor failed to remit participant contributions in a timely manner. The Plan Sponsor identified one instance during the year ended December 31, 2020, where \$528 in participant loan repayments were remitted to the Plan in violation of DOL regulations. The missed earnings and interest were corrected in August 2024 outside of the DOL's Voluntary Fiduciary Correction Program ("VFCP").

A summary of nonexempt prohibited transactions related to the delinquent remittances is shown in the attached supplemental schedule of delinquent participant contributions for the year ended December 31, 2024.

Note 9 – Employer Contributions Receivable

In February 2025, the Plan Sponsor processed and submitted the annual Safe Harbor employer match true-up in the amount of \$340,765, including the related lost earnings and interest, to the Plan on behalf of the affected participants. The Plan recorded employer contributions receivable of \$340,765 as of December 31, 2024.

In May 2024, the Plan Sponsor processed and submitted the annual Safe Harbor employer match true-up in the amount of \$289,291, including the related lost earnings and interest, to the Plan on behalf of the affected participants. The Plan recorded employer contributions receivable of \$289,291 as of December 31, 2023.

Note 10 – Subsequent Events

The Plan has evaluated subsequent events through September 23, 2025, the date the financial statements were available to be issued.

On July 7, 2025, the Pearl Street Technologies 401(k) Plan was amended to merge into the Enverus, Inc. 401(k) Plan with the respective plan assets to be transferred to the Plan effective December 31, 2025.
