In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the AMI, LLC 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. DESCRIPTION OF THE PLAN

The following description of the AMI, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan was a defined contribution plan that covered substantially all employees of Active Minerals International, LLC (the Company) and was established on May 1, 1969. Effective November 16, 2018, the Company was acquired by Jurassic Topco LP (the Plan Sponsor). Leased and seasonal employees were eligible to participate in the Plan. Employees were eligible to participate in the Plan upon reaching 18 years of age and completing 90 days of service. Participants could enter the Plan on the day in which they satisfy the eligibility requirements. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), and the Plan was most recently amended effective December 31, 2024 to merge the Plan into the J.M Huber Corporation 401(k) Savings Plan.

Effective June 3, 2024, the Company was acquired by and became a wholly owned subsidiary of J.M Huber Corporation. As part of the acquisition, J.M Huber Corporation also acquired and maintained the Plan.

On December 31, 2024, the AMI, LLC 401(k) Plan merged with the J.M Huber Corporation 401(k) Savings Plan and all participants were transferred to the J.M Huber Corporation 401(k) Savings Plan. In conjunction with this Plan merger, the Plan's Net Assets totaling \$15,702,561, held by Fidelity Management Trust Company as the Trustee, were transferred to the J.M Huber Corporation 401(k) Savings Plan, held by VOYA Financial as Trustee of J.M Huber Corporation 401(k) Savings Plan. This amount includes vested balances of all participants as of the transfer date. The plan administrator ensured that all transfers were completed in a timely and accurate manner, and participants received confirmation of their transferred balances.

Participant Contributions

Prior to December 31, 2024, participants could elect to contribute, on a tax-deferred or Roth basis, a percentage of their compensation, as defined by the Plan document. Participant contributions could not exceed the maximum allowable contributions under the Internal Revenue Code (the Code), which totaled \$23,000 and \$22,500 for the years ended December 2024 and 2023, respectively. A participant's Roth elective contributions were allocated to a separate account maintained for such contributions. Participants who have attained age 50 before the end of the Plan year were eligible to make additional catch-up contributions, subject to limitations imposed by the Code, which totaled \$7,500 for the years ended December 2024 and 2023.

Prior to December 31, 2024, the Plan had an automatic enrollment provision whereby an eligible employee was automatically enrolled to contribute to the Plan unless they elect not to contribute or elect a different deferral percentage. Automatic enrollment contributions were contributed to an appropriate target date fund, unless the participant elects a different fund within the Plan. This percentage increases annually on January 1st for all participants in 1% increments starting at 3%, up to a maximum of 6%.

Participants were permitted to make rollover contributions into the Plan.

1. DESCRIPTION OF THE PLAN – cont'd.

Company Contributions

Prior to December 31, 2024, the Company could make matching contributions equal to a percentage of the participant's elective deferrals. Matching contributions were made for all participants currently deferring compensation into the Plan. Prior to January 1, 2023, matching contributions were calculated on an annual basis. Effective, January 1, 2023, matching contributions were calculated and remitted each payroll period. During the years ended December 31, 2024 and 2023, the Company made matching contributions equal to 100% of participant contributions up to 6% of compensation as part of a Qualified Automatic Contribution Arrangement (QACA) Safe Harbor Match. Matching contributions totaled \$905,630 and \$932,503 for the years ended December 31, 2024 and 2023, respectively.

Prior to December 31, 2024, the Company could also make discretionary profit sharing contributions to the Plan as determined by management on an annual basis. Participants must have completed a year of service, as defined by the Plan, and be employed on the last day of the Plan year to receive such a contribution. Discretionary profit sharing contributions were allocated based on the ratio of each eligible participant's compensation to the total compensation paid for all eligible participants. During the years ended December 31, 2024 and 2023, the Company did not make any discretionary profit sharing contributions.

Participant Accounts

Each participant's account was participant-directed and self-directed and credited with participant contributions, Company contributions, distributions and allocations of Plan earnings, losses and administrative expenses. Allocations were based on participant account balances, as defined by the Plan document. The benefit to which a participant was entitled is the benefit that can be provided from the vested portion of the participant's account.

Notes Receivable from Participants

Participants could borrow from their accounts up to the lesser of \$50,000 or 50% of their vested account balance, without regard to the intended use of the funds. Notes must have been at least \$1,000 and a participant could hold no more than one note at any given time. Notes were collateralized by the participant's vested account balance. Notes bore interest at rates commensurate with those offered by financial institutions at the time of the note's issuance. Interest and principal repayments were made ratably through bi-weekly payroll deductions. The maximum term for a note was 5 years unless for the purchase of a principal residence, in which case the loan repayment period may not extend beyond 10 years from the date of the loan. Notes became due immediately upon termination of a participant's employment. Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes were treated as distributions based upon the terms of the Plan document.

Payment of Benefits

Upon termination of service, retirement, early retirement, death, disability, or attainment of age 59 ½, a participant or their beneficiary, in the event of death, could elect to receive a lump-sum amount or annuity option, as defined by the Plan, equal to the value of the participant's vested interest in his or her account. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed could be withdrawn for a hardship purpose.

Payment of Benefits – cont’d.

Distributions were subject to the applicable provisions of the Plan agreement. Certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½. As of December 31, 2024 and 2023, there were no net assets of the Plan allocated to participants who had elected to withdraw from the Plan but had not been paid as of year-end.

Vesting

Participant contributions and earnings thereon vested immediately. Participants vested in QACA matching contributions and earnings thereon according to the following vesting schedule:

Upon retirement, death or disability, a participant becomes 100% vested in their Company contributions.

Forfeitures

Forfeitures of Company contributions could be applied to pay administrative expenses or reduce future Company contributions. Forfeitures become available to the Plan at the earlier of the last day of the Plan year in which a former employee incurs five consecutive one-year breaks in service or a distribution of the participant’s entire vested account balance occurs. Forfeitures available to the Plan totaled \$28,984 as of December 31, 2023. For the years ended December 31, 2024, and 2023, forfeitures applied to reduce Company contributions totaled \$94,602 and \$71,221, respectively. For the years ended December 31, 2024 and 2023, forfeitures applied to pay administrative expenses for the Plan totaled \$8,858 and \$7,475, respectively.

Plan Expenses

Expenses incurred in the administration of the Plan were required to be paid by the Trustee with net assets of the Plan unless paid by the Company at its discretion. During the years ended December 31, 2024 and 2023, the Company elected to pay a portion of the Plan’s direct expenses. Administrative expenses, net of forfeitures, totaling \$12,453 and \$13,053 were paid directly from the Plan for the years ended December 31, 2024 and 2023, respectively. Loan and distribution fees were paid by the Plan and its participants. Investment related expenses are included in net appreciation in fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of additions to net assets available for benefits and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provided for investments in financial instruments, in general, that were exposed to risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it was reasonably possible that changes in the values of investment securities could occur and materially affect the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurement

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Fair Value Measurement – cont'd.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Interests in registered investment companies: Valued at the closing price of shares held by the Plan at year-end. Funds were traded on an active market.

Interests in self-directed funds:

- *Interest bearing cash:* Valued at amortized cost plus accrued interest, which approximates fair value.
- *Interests in common stock:* Valued at the closing price of shares held by the Plan at year-end. Shares are traded in an active market.
- *Interests in registered investment companies:* Valued at the closing price of shares held by the Plan at year-end. Shares are traded on an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2023.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan evaluated for disclosure any subsequent events through August 15, 2025, the date the financial statements were available to be issued, and determined there were no material events that warrant disclosure.

3. INVESTMENTS

All investment information contained in the accompanying financial statements, including investments held as of December 2023, interest and dividend income, and net appreciation in fair value of investments for the year ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Trustee of the Plan, Fidelity Management Trust Company.

4. PARTY-IN-INTEREST TRANSACTIONS

The Plan invested in shares of mutual funds managed by Fidelity Investment Institutional Operations Company, Inc. (FIIOC). FIIOC is related to the Plan's Trustee. The Plan loaned funds to its participants according to the applicable provisions of the Plan agreement. The Company provided the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualified as party-in-interest transactions, which are exempt from the prohibited transaction rules.

5. SELF-DIRECTED FUNDS

The Plan offered a self-directed program to participants allowing them to invest their account balances in any investment, as permitted by the Plan, and in accordance with ERISA. Under this type of arrangement, participants could direct investments into the self-directed program in addition to, or in lieu of, the various investment alternatives offered by the Plan. The Plan's investment in self-directed accounts consisted of interest bearing cash, interests in common stock and interests in registered investment companies.

6. INCOME TAX STATUS

The Plan has adopted a standardized prototype plan through Fidelity, which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan administrator believes that the Plan was designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. INCOME TAX STATUS – cont’d.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. Given the Plan was tax exempt and had no unrelated business income, the provisions of ASC 740 did not have an impact on the Plan’s financial statements. The Plan recognized interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan did not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023. The Plan was subject to routine audits by the IRS and Department of Labor; however, there are currently no audits for any periods in progress.

8. PLAN TERMINATION

The company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon Plan termination, all participants become 100% vested in their accounts. While not a Plan termination, as described in note 1, the Plan did merge into J.M Huber Corporation 401(k) Savings Plan effective December 31, 2024.

The significant accounting policies used by the AMI, LLC 401(k) Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during the year ended December 31, 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.



Accounting estimates are an integral part of the financial statements and are based on your knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimates affecting the financial statements was the valuation methodology used to value investments at their fair value. We evaluated the key factors and assumptions used to develop the afore mentioned estimate in determining that it is reasonable in related to the financial statements taken as a whole.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in performing and completing our audit.

Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. We are pleased to report that no misstatements were identified in performing and completing the audit.

Disagreements with Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that included in the management representation letter dated August 15, 2025.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Other Matters

Our responsibility for the ERISA-required supplemental schedule accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedule, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).
