## Independent Auditors' Report

To the Participants and Plan Administrator of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

## 1. Description of the Plan

The following description of the Tubman 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

### General

Tubman (the Organization) is a non-profit agency supporting people of all ages, genders and cultural backgrounds who are facing relationship violence, trafficking, homelessness, addiction, mental health challenges or other trauma. The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) whereby contributions to the Plan consist of elective employee salary reduction deferrals, matching Organization safe harbor contributions and if made, any discretionary matching or profit-sharing contributions. The Organization is the administrator, sponsor and employer of participants in the Plan and has appointed The Standard Insurance Company to be the asset custodian and record keeper of the Plan. Long-term part-time employees who met eligibility requirements under SECURE Act are also eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Board of Directors are responsible for oversight of the Plan. The Plan's Board of Directors determines the appropriateness of the Plan's investment offerings and monitors investment performance.

### Eligibility

Eligible classes of employees include all employees except for union employees, certain non-resident aliens, part-time, temporary or seasonal employees. Eligible employees, who complete six months of employment, in which at least 500 hours are worked, are eligible to contribute to the Plan by making elective employee deferrals. Participants who are eligible to make salary deferrals to the Plan are also eligible to receive the Organization's safe harbor matching contribution. Upon completion of one year of service, employees are also eligible to participate in any discretionary matching or profit-sharing contributions. In the year a discretionary profit-sharing contribution occurs, the employee also has to complete at least 501 hours of service during the year and be employed at plan year end to receive the contribution.

### Contributions

Each year, participants may contribute an amount not to exceed the limits of Code Sections 401(k), 404 and 415, of pretax annual compensation, as defined in the Plan. Individuals age 50 or older by the end of any tax year may make additional catch-up contributions to the Plan. Effective January 1, 2025, participants aged 60-63 are eligible to make additional catch-up contributions. Participants may also contribute post-tax elective deferral amounts (Roth contributions) and amounts representing distributions from other qualified plans (rollover contributions). The Organization's matching contribution is a safe harbor contribution, which matches 100% of the first 3% of elective employee deferrals and 50% on elective employee deferrals greater than 3% but not to exceed 5%. In addition, each plan year, the directors of the Organization will determine whether to make a separate discretionary matching or profit-sharing contribution; no discretionary matching or profit-sharing contributions were approved for 2024.

### Participant Accounts

Upon enrollment in the Plan, participants can designate the investment of their contributions in various funds with pre-selected investment objectives, each of which is invested in securities selected and managed by the asset custodian to meet the objectives of each fund.

Each participant's account is credited with the participant's contributions, Roth contributions, rollover contributions, the Organization's matching contributions, an allocation of (a) the Organization's discretionary contribution and (b) plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately 100% vested in their voluntary contributions, Roth contributions, rollover contributions and Organization safe harbor matching contributions, plus the earnings thereon. Vesting in the Organization discretionary profit sharing or matching contributions is based on years of continuous service. Participants earn a year of service when they are credited with 1,000 hours of service during the plan year and are vested in the Organization's discretionary profit sharing or matching contributions and related earnings as follows: 50% after one year of service and 100% after two years of service. A participant is fully vested in the Organization's discretionary profit sharing or matching contributions upon reaching normal retirement age, death or permanent disability.

### **Forfeited Accounts**

Forfeited nonvested accounts are to be used first to reduce administrative expenses and second to reduce future Organization contributions. There were no forfeited nonvested accounts as of December 31, 2024 and 2023 and no forfeitures were used during the year ended December 31, 2024.

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 and up to 50% of their vested account balance, with a maximum of \$50,000. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as of the date of the note as determined quarterly by the plan administrator. Interest rates on notes receivable ranged from 3.57% to 11.50% at December 31, 2024 and 3.57% to 5.51% as of December 31, 2023. Note terms range from zero to five years. Principal and interest is paid directly by participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the plan document.

### **Payment of Benefits**

Distributions to terminated, disabled or retired participants are made in the form of installments over a period of not more than a participant's assumed life expectancy or a single lump sum payment to the participant (or in the case of death, the participant's beneficiary) equal to the value of the participant's vested account. If a participant terminates employment and the participant's account balance is less than \$5,000, the plan administrator can authorize the benefit payment without the participant's consent. Distributions may also be made in the form of hardship withdrawals if certain criteria are met.

### **Recent Regulatory Update**

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on a cash basis, which approximates generally accepted accounting principles accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

### **Contributions**

Contributions from Plan participants and the Employer contributions are recorded in the year in which the participant contributions are withheld from compensation.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

### **Payment of Benefits**

Benefits are recorded when paid.

## **3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted market prices for identical assets in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies and assumptions used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued based upon the unit values of such pooled separate accounts held by the Plan at year end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy.

### **4. Related Party and Party-in-Interest Transactions**

Plan investments are managed by The Standard Insurance Company. The Standard Insurance Company is the asset custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participants' account balances. These transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan.

### **5. Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

### **6. Tax Status**

The Plan uses a pre-approved prototype plan that obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, concentration and credit risks. Market risks include global events which could impact the value of investment securities such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

As of December 31, 2024 and 2023, the Plan had investments of \$8,030,699 and \$6,242,591, respectively, which were concentrated in five and four funds, respectively.

### **8. Information Certified by Custodian**

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, The Standard Insurance Company, the custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023 and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024 and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

### **9. Subsequent Events**

The Plan has evaluated subsequent events occurring through September 24, 2025, the date that the financial statements were available to be issued, for events requiring recording or disclosure in the Plan's financial statements.
