We were engaged to perform audits of the financial statements of Seamen's Society for Children and Families 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

Prior to January 1, 2009, records were maintained at a contract, not a plan level; therefore, management has not maintained, and Empower Annuity Insurance Company of America and its subsidiary (Empower), Voya Retirement Insurance and Annuity Company (VOYA), and Mutual of America Life Insurance Company (Mutual of America) did not provide, sufficient accounting records and supporting documentation relating to certain annuity contracts and custodial accounts issued to current and former employees, and supporting documentation is not adequate to assure the completeness and accuracy of the amounts included in the financial statements. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements have been affected by these conditions.



Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP), and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America (GAAS) and to issue an auditor's report. However, because of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental Schedule H (Form 5500), Line 4i - Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, it is inappropriate to, and we do not express an opinion on the supplemental schedule referred to above.

1. Description of Plan

The following description of the Seamen's Society for Children and Families 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

On January 1, 2012, Seamen's Society for Children and Families (the Company or Employer) restated the Tax Deferred Annuity Plan into the 403(b) Plan. The Plan is a defined contribution plan available to substantially all employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Employees subject to a collective bargaining agreement and non-resident aliens are not permitted to participate in the Plan.

Prior to January 1, 2009, Empower Annuity Insurance Company of America and its subsidiaries (Empower), Voya Retirement Insurance and Annuity Company (Voya), and Mutual of America Life Insurance Company (Mutual of America) maintained records at a contract, not a plan, level. Empower, Voya, and Mutual of America administratively decided not to provide accounting records and supporting documentation at the participant or plan level relating to certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009. As such, neither the Plan sponsor nor Empower, Voya, or Mutual of America have been able to produce sufficient records and supporting documents relating to certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009. As a result, the completeness and the accuracy of the annuity and custodial accounts, related investment income, and distributions related to these accounts, if any, could not be determined.

Contributions

Each year, participants are permitted to contribute to the Plan beginning on the date of hire an amount not to exceed the dollar limitation of \$23,000 and \$22,500 for the years 2024 and 2023, respectively, as prescribed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, to the limits allowed by the IRC. Participants may also contribute amounts from other tax-qualified plans (rollovers). Participants direct the investments of their contributions into various investment options offered by the Plan. Enrollment into funds of Voya and Mutual of America has been discontinued. Effective January 1, 2020, the Company provides a non-elective discretionary contribution to eligible participants. For the years ended December 31, 2024 and 2023, the Company provided non-elective discretionary contributions equal to 2.50% and 5%, respectively, of the total eligible compensation of all employees of the Company who are at least 21 years of age, have completed one year (1,000 hours) of service, and are employed by the Company on the last day of an allocation period. Employer contributions are invested in various investment options offered by the Plan, as directed by the participants.

Participant Accounts

Each participant's account is credited with the participant's and applicable portion of the Employer's contribution and investment earnings, which is reduced by applicable administrative expenses. The benefit to which a participant is entitled is equal to the value of the participant's vested account. Empower, Voya, and Mutual of America hold the Plan's investment assets and execute investment transactions.

Vesting

Participants are always 100% vested in their voluntary contributions plus actual earnings allocated thereon. Participants become vested in the Employer’s contribution, in accordance with the percentages determined in the following table:

Forfeitures

Forfeitures of terminated participants’ nonvested accounts may be used to pay the Plan’s administrative expenses or to reduce Employer contributions. During the years ended December 31, 2024 and 2023, the forfeiture balance of \$10,014 and \$9,840, respectively, were allocated to fund the non-elective Employer discretionary contributions in the subsequent Plan years.

Investment Options

Upon enrollment in the Plan, a participant may direct the investment of his or her account balances into any of the various investment options offered by Empower.

Payment of Benefits

The Plan provides for normal retirement at age 65. The Plan permits distribution to participants or beneficiaries upon termination of service, disability, or death. Distribution of benefits to participants will be made in the form of an annuity or installment payments, unless a participant specifically elects to receive their benefits in one lump-sum payment equal to the value of the participant’s vested interest in their account. If a participant’s vested account balance is \$7,000 or less, a single-sum payment is made at termination of employment.

Notes Receivable from Participants

Participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Loans are secured by the participant’s account and bear an interest rate at a commercially reasonable rate as established by the Plan Administrator. The notes are repaid ratably through payroll deductions over a period of five years or less, unless used to purchase a principal residence up to 15 years. The interest rates on notes outstanding at December 31, 2024 and 2023 range from 5.25% to 10.50%. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates and assumptions.

Investment Valuation and Income Recognition

The Plan's investments (except for fully benefit-responsive investment contracts, which are reported at contract value) are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements and Note 4 for a discussion on contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contribution Receivables

Contributions that are pending transfer to Empower for the years ended December 31, 2024 and 2023 are recorded as contribution receivables to the Plan in the statements of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

3. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Valuations are based on unadjusted quoted prices in active markets for identical assets or liabilities that the reporting entity can access at the measurement date.

Level 2 - Valuations are based on: (a) quoted prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar assets or liabilities in inactive markets, (c) inputs other than quoted prices that are observable for the asset or liability, and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Valuations are based on inputs that are unobservable for the asset or liability and reflect management's best estimate of what market participants would use as fair value.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

A description of the valuation technique applied to the Plan's major category of assets measured at fair value is as follows. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts - Pooled separate accounts are valued at their accumulation unit value (AUV) as a practical expedient. The AUV is determined daily based on the net asset value (NAV) of shares of the underlying fund, the fund's investment returns, and the separate account charges (i.e., the daily asset charge). The Plan's investments in the pooled separate accounts may be redeemed daily. There are no redemption fees or notice periods and no unfunded commitments.

The investments in pooled separate accounts, which are valued at AUV, have not been classified in the fair value hierarchy, in accordance with Accounting Standards Update (ASU) 2015-07, *Disclosures for Investments in Certain Entities That Calculate Net Asset Value per Share (or Its Equivalent)*. The underlying funds of the investments in pooled separate accounts are with various registered investment companies whose investment strategies are to seek capital appreciation through investment in common stocks, fixed-income securities, and mutual funds.

4. Fully Benefit-Responsive Contracts

The Plan entered into fully benefit-responsive guaranteed-interest and general account contracts with Mutual of America, Empower, and Voya. Mutual of America and Empower maintain the contributions in a general account. Voya maintains the contributions in a fixed account. The accounts are credited with earnings on the underlying interests and charged for participant withdrawals and administrative expenses. The guaranteed-interest contract issuers are

contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Because the guaranteed-interest contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed-interest contracts. Contract value, as reported to the Plan by Mutual of America, Empower, and Voya, represents contributions made under the contracts, plus interest, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), and (2) the establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

The guaranteed-interest contracts do not permit Empower, Voya, and Mutual of America to terminate the agreement prior to the scheduled maturity date.

5. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower, Voya, and Mutual of America, qualified institutions.

6. Party-in-Interest Transactions

Certain Plan investments are shares of pooled separate accounts, a general account, and a guaranteed-interest account managed by Empower, Voya, and Mutual of America and, therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, each participant will become 100% vested and the net assets of the Plan will be distributed, as prescribed by ERISA.

8. Tax Status

The Plan has adopted the Angel Pension Group, Inc. 403(b) Prototype Plan. Accordingly, the Plan is permitted to rely on the opinion letter, dated March 31, 2017, stating that the 403(b) Plan was designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and is

currently being operated in compliance with the applicable requirements of the IRC, and the Plan qualifies for tax-exempt status.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan provides for various investment options in any combination of funds offered by the Plan. These funds are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

10. Subsequent Events

Plan management has performed subsequent event procedures through September 24, 2025, which is the date the financial statements were available to be issued; there were no subsequent events requiring adjustment to the financial statements or disclosures as stated herein.



