Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

1. Description of the Plan

The following description of the Thiele Kaolin Company Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan established effective January 1, 1960, and most recently amended February 28, 2022. The Plan covers all employees of Thiele Kaolin Company (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Retirement Savings Committee, appointed by the Board of Directors (the "Board") of the Company, is responsible for oversight of the Plan. T. Rowe Price Trust Company ("TRP") serves as the "qualified institution" of the Plan. The qualified institution, with several investment managers, manages the Plan's investments.

Contributions – Each year, participants may contribute a percentage of pretax annual compensation, as defined in the Plan document, up to the maximum limits of the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants will have their deferral rate increase by 1% on the anniversary of their enrollment date until their deferral rate reaches 6%. The Company makes a safe harbor matching contribution in an amount equal to 100% on the first 3% of a participant's deferred compensation, and an additional 50% on the next 2% of a participant's deferred compensation, for a maximum of 4% of the participant's total eligible compensation. Additional profit sharing amounts may be contributed at the option of the Board. For the year ended December 31, 2024, the Company approved a \$3,601,787 profit sharing contribution to the Plan. The Company's Board determines on an annual basis the amount of the discretionary profit sharing contribution to the Plan. For the year ended December 31, 2024, the Company's Board approved 8% of 2024 compensation as the discretionary profit sharing contribution to be allocated on a service-weighted formula. Eligible employees with less than 10 years of service received a contribution equal to 4.04% of their 2024 eligible compensation; those with more than 10 years of service but less than 20 years of service received a contribution equal to 8.08% of their 2024 eligible compensation; those with more than 20 years of service received a contribution equal to 12.12% of their 2024 eligible compensation. The Plan requires a participant to be employed as of year end to be eligible to receive employer profit sharing contributions. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

1. Description of the Plan (continued)

Participant Accounts – Each participant's account is credited with the participant's contributions, allocations of the Company's safe harbor matching and discretionary contributions, and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are vested immediately in their contributions and Company contributions plus actual earnings thereon.

Benefits and Payments – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the Plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of lump sum.

2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable – Any contributions due and payable by the Company are reflected as employer contributions receivable in the Plan's financial statements. The Company's profit sharing contributions for 2024 and 2023 are recorded in employer contributions receivable in the statements of net assets available for benefits at December 31, 2024 and 2023, respectively. In addition, the amount of participant-related contributions that have been deducted from the participant's payroll as of the end of the year but have not been deposited with the Plan until after the end of the year is reflected as participant contributions receivable in the Plan's financial statements. Contributions are subject to certain IRC limitations.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

During the year ended December 31, 2024, there was \$79,655 of administrative fee credits from TRP allocated to participants' accounts.

Subsequent Events – Subsequent events were evaluated through September 15, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, the Plan was amended and restated to increase auto escalation ceiling to 10%.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

Level 1 – Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation technique include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

3. Fair Value Measurements (continued)

Common Collective Trusts – The common collective trusts have underlying investments that are invested in guaranteed investment contracts issued by insurance companies, investment contracts issued by banks, structured or synthetic investment contracts (“SIC”) issued by banks, insurance companies, and other issuers, as well as the securities supporting such SIC (underlying assets), separate account contracts, and other similar instruments that are intended to maintain a constant net asset value. These instruments are intended to maintain a constant NAV while permitting participant-initiated benefit-responsive withdrawals for certain events. These investments are measured using NAV as a practical expedient and have not been classified using the fair value hierarchy.

4. Information Certified by the Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, T. Rowe Price Trust Company, the qualified institution of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule, Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024 and the related investment activity reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

5. Party-in-interest Transactions

Certain Plan investments are shares of mutual funds and common trust funds managed by TRP. TRP is the qualified institution as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

7. Tax Status

The Plan adopted a pre-approved plan offered by the qualified institution. The pre-approved plan received an IRS Opinion Letter dated August 19, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
