Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of eCapital Enterprises Corp. 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

(1) **Description of the Plan**

The following description of the eCapital Enterprises Corp. 401(k) (the “Plan”) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the plan administrator.

(a) **General**

The Plan is a defined contribution plan sponsored by eCapital Enterprises Corp. (the “Company” or the “Employer”) for the benefit of its employees who have completed six months of service and have attained age twenty-one. The Plan was established effective July 1, 1994, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

The Plan operates under an agreement with Empower Trust Company, LLC (“Empower”), the trustee, and Empower Retirement, LLC (“Empower Retirement”), the recordkeeper of the Plan. Empower is responsible for maintaining the investments of the Plan and reporting on the earnings and investments of the Plan. The Plan also entered into a group annuity contract with Empower Annuity Insurance Company (“EAIC”) for a guaranteed interest account.

(b) **Contributions**

Each year, participants may contribute up to 100% of annual compensation as pre-tax or Roth contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan has adopted a safe harbor matching contribution equal to 100% of the first 5% of base compensation that a participant contributes to the Plan. Additional discretionary and qualified non-elective amounts may be contributed at the option of the Company. During the years ended December 31, 2024 and 2023, no discretionary or qualified non-elective contributions were made to the Plan. Contributions are subject to certain Internal Revenue Code (“IRC”) limitations.

(c) **Participant Accounts**

Each participant’s account is credited with the participant’s contributions, the Company’s contributions, rollover contributions from other qualified retirement plans, and allocations of the Plan’s investment income and administrative expenses. The allocation of plan investment income and administrative expenses is based upon the participant’s account balance.

(1) Description of the Plan - Continued

(d) Participant Investment Account Options

The Plan currently offers various mutual funds, a self-directed brokerage account, and a guaranteed investment contract as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

(e) Vesting

Participants are immediately 100% vested in their voluntary contributions, rollover contributions, and safe harbor matching contributions plus actual investment income thereon.

Participant matching contribution account and non-elective contribution accounts vest based on years of vesting services as follows:

<u>Total Number of Years of Service</u>	<u>Vested Interest</u>
Less than 1 year of service	0%
1 year, but less than 2	20%
2 years, but less than 3	40%
3 years, but less than 4	60%
4 years, but less than 5	80%
5 years	100%

Participants automatically become 100% vested in their account balance in the event of attaining normal retirement age, death, or disability.

(f) Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms may not exceed five years unless the loan is for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a fixed rate of prime plus 1% at the date of issuance. Principal and interest are paid ratably through payroll deductions. A participant may not have more than one outstanding loan balance at any time. Delinquent participant loans are reclassified as distributions based on the terms of the plan document.

(g) Payment of Benefits

The Plan provides for payment of benefits of the participant's vested account balance as soon as reasonably practical upon retirement, death, total and permanent disability, or termination of employment. The Plan also provides for distribution to a participant upon reaching normal retirement age. Benefits are recorded when paid.

Participants, while employed, may make withdrawals against their vested account balance in accordance with the Plan, which generally requires the demonstration of financial hardship.

(1) Description of the Plan - Continued

(h) Forfeitures

Forfeited balances of terminated participants' non-vested accounts may be used to reduce administrative expenses of the Plan or Company contributions. At December 31, 2024 and 2023, there was approximately \$86,000 and \$152,000, respectively, of forfeitures available to reduce future expenses and employer contributions. Approximately \$99,000 of forfeitures were used by the Company to reduce employer match contributions during the year ended December 31, 2024.

(i) Administrative Expenses

All significant costs related to plan administration are paid by the Company.

(2) Summary of Significant Accounting Policies

(a) Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

(c) Investment Valuation and Income Recognition

The Plan invests in registered investment companies which are stated at fair value based on the quoted market prices of shares held by the Plan at year end. Investments in guaranteed investment contracts which are fully benefit responsive are valued at contract value. Investments in self-directed brokerage accounts are valued based on the underlying investments held by the Plan at the end of the year. See Note 4 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

(d) Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

(e) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

(f) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

(g) Payment of Benefits

Benefits are recorded when paid.

(h) Administrative Expenses

Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

(3) Information Certified by Trustee and Custodian

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations and Disclosures under ERISA. Accordingly, Empower, the trustee, and EAIC, the custodian, have certified that the following information included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

(3) Information Certified by Trustee and Custodian - Continued

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to related information included in the financial statements and supplemental schedule.

(4) Fair Value Measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1: Observable inputs such as quoted prices in active markets; or

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means; if the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability;

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for the investments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Registered Investment Companies

Registered investment companies are valued at quoted market prices, which represent net asset values of shares held by the Plan at year end.

Self-Directed Brokerage Accounts

Self-directed brokerage accounts are valued based on quoted market prices in active markets based on the listing of underlying assets.

(5) Guaranteed Investment Contract

Investments in the guaranteed investment contract, the EAIC Key Guaranteed Portfolio Fund ("KGPF"), are held as a general account product offered through a group annuity contract with EAIC. Participant principal and interest are fully guaranteed by the entire general account assets of EAIC. The general account assets are primarily high-quality, fixed income bonds. The KGPF is credited with declared rates of interest based on the earnings of the underlying assets in the portfolio compared to the minimum interest crediting rate, as stated in the contract with EAIC.

The KGPF is reported at contract value which is the basis for participant-initiated transactions.

Certain events limit the ability of the Plan to transact at contract value with the issuer of the general investment contract. The Company does not believe the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

(7) Party-in-Interest Transactions

The Plan paid approximately \$78,000 for investment advisory and recordkeeping fees during the year. Participant loans are considered party-in-interest transactions, because they are transacted with plan participants. These transactions qualify as party-in-interest transactions, as defined in Section 3(14) of ERISA; they are, however, expressly exempted from the prohibited transaction rules.

(8) Tax Status

The Plan has adopted the non-standardized pre-approved profit-sharing plan document of the Angell Pension Group Inc., which received its latest opinion letter from the IRS dated June 30, 2020, stating that the plan adopted by the Company, as then designed, was qualified under Section 401(a) of the Internal Revenue Code. The adopted plan document has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(9) Subsequent Events

The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through September 10, 2025, the date the financial statements were available to be issued.

During 2024, an affiliate of the Company acquired TAFS, Inc., the plan sponsor of the Jacobson Holdings, Inc. 401(k) Profit Sharing Plan (the "Jacobson Plan"). The Plan was formally amended during 2025 to allow employees of TAFS, Inc. to participate and contribute to the Plan. On April, 8 2025, the Jacobson Plan merged substantially all of its assets into the Plan.

During 2024, an affiliate of the Company acquired LSQ Funding Group, L.C., ("LSQ"). The Plan was formally amended on February 1, 2025 to allow employees of LSQ to participate and contribute to the Plan.
