## **Independent Auditors' Report**

To the Plan Administrator  
Foundation Partners Group, LLC Retirement Savings Plan:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of Foundation Partners Group, LLC Retirement Savings Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Notes to Financial Statements

December 31, 2024 and 2023

### (1) Description of Plan

The following description of the Foundation Partners Group, LLC Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the plan administrator.

#### (a) General

The Plan is a defined contribution plan sponsored by Foundation Partners Group, LLC (the “Company”) for the benefit of its full-time employees who have three months of service and are age 21 or older. Part-time employees are not eligible to participate in the Plan unless they complete 500 hours of service and attain the age of 21. Leased employees, union employees, interns, nonresident aliens, non-common law employees and apprentices are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan operates under an agreement with Voya Institutional Trust Company (“VITC”), who serves as trustee of the Plan. Retirement Solutions Specialists (“RSS”) serves as third-party administrator of the Plan.

#### (b) Contributions

Each year, participants may contribute up to 90% of eligible compensation as pre-tax or Roth contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The automatic deferral percentage will increase by 1% per year on January 2, up to a maximum of 6% of eligible compensation. This provision applies only to employees hired after April 23, 2018. The Company may make discretionary employer matching contributions to eligible plan participants based on participants’ elective deferrals. Participants must be employed on the last day of the plan year to receive a discretionary employer matching contribution. For the year ended December 31, 2024, the Company’s discretionary matching contribution was 75% of the first 6% contributed by participants with less than six years of service and 100% of the first 6% contributed by participants with six or more years of service. The Company may also make non-elective contributions to eligible employees who have worked at least 1,000 hours and are employed on the last day of the contribution period. No such contributions were made for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Code (“IRC”) limitations.

### (1) Description of Plan - Continued

#### (c) Participant Investment Account Options

The Plan currently offers various registered investment companies as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

#### (d) Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### (e) Vesting

Participants' contributions plus actual earnings thereon are 100% vested immediately. Employer contributions are subject to the following vesting schedule:

Less than two years	0%
Two years but less than three	20%
Three years but less than four	40%
Four years but less than five	60%
Five years but less than six	80%
Six years or more	100%

The Plan recognizes prior service with any entity that the Company acquires, whether by asset or stock purchase, but only with respect to individuals who are employees of the acquired entity at the time of the acquisition. Regardless of the vesting schedule, participants become 100% vested in their employer contributions upon reaching normal retirement age (age 65) or upon death or disability.

#### (f) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions. Participants may not have more than one loan outstanding at any time. Loan repayment terms may not exceed five years unless the purpose of the loan is to acquire a principal residence.

#### (1) Description of Plan - Continued

##### (g) Payment of Benefits

On termination of service due to death, disability, retirement (after attaining normal retirement age) or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. The Plan also allows for distributions in substantially equal installments or partial withdrawals. If the vested account balance payable to a participant is less than or equal to the mandatory distribution limit utilized by the Plan, such account will be automatically distributed to the participant or rolled into an IRA on the participant's behalf without the participant's consent. The Plan also provides for in-service withdrawals for those age 59 ½ or older and for hardship withdrawals in the event of immediate and heavy financial need. Any hardship withdrawal is limited to the amount needed to meet the financial need but shall be for no less than \$500 and must qualify with respect to plan provisions.

##### (h) Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$196,000 and \$190,000, respectively. These accounts will be used to reduce future employer contributions or to pay administrative expenses of the Plan. Additionally, approximately \$248,000 and \$177,000 of forfeited nonvested accounts were used in 2025 and 2024, respectively, to reduce employer contributions receivable as of December 31, 2024 and 2023, respectively. Forfeited nonvested accounts used in 2025 to reduce employer contributions receivable at December 31, 2024 included additional forfeitures incurred between December 31, 2024 and the date on which the employer contributions receivable were funded in 2025. Finally, approximately \$35,000 of forfeited nonvested accounts were used to pay administrative expenses of the Plan during the year ended December 31, 2024.

#### (2) Summary of Significant Accounting Policies

##### (a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

##### (b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

##### (c) Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

##### (c) Investment Valuation and Income Recognition - Continued

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

##### (d) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

##### (e) Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

##### (f) Payment of Benefits

Benefits are recorded when paid.

##### (g) Administrative Expenses

Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### (3) Information Prepared and Certified by the Trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, VITC, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate:

- Investments at fair value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

### (3) Information Prepared and Certified by the Trustee - Continued

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in these financial statements and supplemental schedules.

### (4) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered Investment Companies:* Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

**(5) Party-in-Interest Transactions**

The Plan paid \$271,374 of expenses related to the Plan's operations to the Plan's recordkeeper, third-party administrator, investment advisor and auditor. These transactions, in addition to participant loan transactions, are party-in-interest transactions, but are exempt from the prohibited transaction rules.

**(6) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

#### (8) Tax Status

The Plan has adopted a non-standardized defined contribution pre-approved plan document (“PAPD”) provided by RSS. The IRS has determined that the PAPD is designed in accordance with applicable sections of the IRC and informed RSS of such in a letter dated June 30, 2020. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### (9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

### (10) Subsequent Events

Effective January 1, 2025, Nova 401(k) Associates began serving as third-party administrator and the Plan was amended and restated with the adoption of the Nova 401(k) Associates pre-approved plan document. As part of this amendment and restatement, the Plan's automatic enrollment provision was changed to increase the automatic enrollment deferral percentage to 3% and increase the maximum automatic increase of the deferral percentage to 10%.

The Plan has evaluated events through September 10, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
