Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Sociedad Para Asistencia Legal Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Note 1 - Description of the plan

The following description of the Sociedad Para Asistencia Legal Pension Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on December 29, 1998 as a defined contribution plan, covering substantially all full-time employees of Sociedad Para Asistencia Legal de Puerto Rico, Inc. (the Plan Sponsor) who have one year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute an amount of their compensation not exceeding the maximum deferral amount as specified by local law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans, subject to the conditions and limitations set forth in the Plan agreement. The Plan's Sponsor may make discretionary contributions.

Participant accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions and related employer matching contributions, as well as the participant's share of the Plan's earnings or losses. Allocation of earnings or losses are based on the participant's account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's contribution of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested on the Plan Sponsor's contribution after 3 years of credited service. Notwithstanding the above, all participants are 100% vested upon attaining age 65.

Investments options

The Plan Sponsor's and participants' contributions are invested in various investment funds provided by the custodian of the Plan, as permitted in the Trust Agreement. The Plan's investments are participant-directed.

Note 1 - Description of the plan – (continued)

Notes receivable from participants

Notes receivable from participants are not permitted.

Payment of benefits

Upon termination of service due to death, disability or retirement, a participant or the participant's beneficiaries may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or periodic installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

In addition, the Plan provides for in-service distributions in certain circumstances, including financial hardship withdrawals, subject to certain limitations. Also, in-service distributions may be available to participants as special disaster distributions, as determined by the Puerto Rico Treasury Department.

Forfeitures

Upon a participant's termination from employment or withdrawal from the Plan for any reason other than death, retirement or disability, the Plan Sponsor contributions on behalf of the participants not then vested are forfeited and used to reduce future Plan Sponsor contributions. As of December 31, 2024 and 2023, the forfeiture account balance amounted to \$32,643 and \$19,172, respectively.

Administrative expenses

Administrative expenses, unless paid directly by the Plan Sponsor, will be paid from the trust fund and will be charged against participant's accounts.

Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 2 - Summary of accounting policies

Following are the significant accounting policies followed by the Plan:

Basis of accounting and presentation

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP) and under the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investments valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. During the year ended December 31, 2024, the Plan's investments appreciated in value by \$1,720,873.

Payment of benefits

Benefits are recorded when paid.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the financial statements.

Note 2 - Summary of accounting policies – (continued)

Benefits payable

The Plan accounts for benefits payable in accordance with the guidance provided by the American Institute of Certified Public Accountants (AICPA) Audit and Accounting Guide, Audits of Employee Benefit Plans. This guidance requires that benefits payable to persons who have withdrawn from participation in a defined contribution plan be disclosed in the notes to the financial statements rather than recorded as a liability of the Plan. As of December 31, 2024 and 2023, no benefits payable is owed to the participants.

Note 3 - Information certified by the custodian (unaudited)

The plan administrator has elected the method of compliance permitted by Section 103(a)(3)(C) of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information in the accompanying financial statements and ERISA required supplemental schedules related to investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company LLC, a qualified institution.

Note 4 - Fair value measurements

The Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs to the extent possible. The Plan determines fair value based on assumptions that market participants would use in pricing an asset or liability in the principal or most advantageous market.

When considering market participant assumptions in fair value measurements, the following fair value hierarchy distinguishes between observable and unobservable inputs, which are categorized in one of the following levels:

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly.
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

Note 4 - Fair value measurements – (continued)

A financial instrument level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used by the Plan for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - are valued at the net asset value of shares held by the Plan at year end.

Fixed annuities - are valued and reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

Stable value funds - share prices / net asset value (NAV) are generally obtained directly from the fund house or other investment provider.

The preceding method described may have resulted in fair values that may had not been indicative of net realizable values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

During the year ended December 31, 2024 and 2023, investments without readily determinable fair values increased in value by \$63,210 and \$58,643, respectively, which is included as part of net appreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits. Cumulative upward adjustments in value at December 31, 2024 and 2023 amounted to \$121,853 and \$58,643, respectively.

Note 5 - Tax status

The Plan constitutes a qualified plan exempt from income taxes under the provision of Section 1081.01 of the Puerto Rico Income Tax Code (the Code). The Plan obtained a favorable determination letter on December 5, 2023, in which the Commonwealth of Puerto Rico tax authorities stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code.

Note 5 - Tax status – (continued)

Management has evaluated the Plan tax position and concluded that the Plan has maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements.

Note 6 - Non-discrimination test

The Plan complied with the non-discrimination test for the years ended December 31, 2024 and 2023. This test requires compliance with a determined percentage of contributions to the Plan as established in Section 1081.01.

Note 7 - Delinquent participant contributions

During the year ended December 31, 2023, the Plan Sponsors did not remit certain participants contributions to the Plan in a timely manner, as defined by ERISA, amounting to \$38,726. During the year ended December 31, 2024, participant accounts were credited by the estimated investment income that would have been earned had these participant contributions been remitted on a timely basis, amounting to \$235.

During the year ended December 31, 2024 participant contributions were remitted in a timely manner, as defined by ERISA.

Note 8 - Subsequent events

The Plan has evaluated the impact of subsequent events through August 27, 2025, which is the date these financial statements were available to be issued. No events have occurred subsequent to the statement of net assets available for benefits date, and to the date the financial statements were available to be issued, that would require additional adjustment to, or disclosure in the financial statements.
