Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed an audit of the financial statements of Kellex Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). (1) Plan Description

The following description of Kellex Corporation 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan covering employees of Kellex Corporation ("Company") who are age twenty-one or older and have completed six months of service. The Plan specifically excludes union employees, nonresident aliens and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Administrative Committee is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

(b) Contributions

Participants may contribute up to 100% of eligible pretax annual compensation not to exceed the limits imposed by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan offers both a pre-tax 401(k) deferral and a Roth 401(k) deferral, allowing participants to defer either pre-tax dollars or after-tax dollars. The Plan Sponsor matches 25% of the first 8% of compensation that a participant contributes to the Plan. The match is calculated and contributed after each payroll period.

(c) Participant Accounts

Each participant's account is credited with the employee's contribution, the employer's contributions, and Plan earnings. Each account is charged with applicable investment fees or participant fees directly attributable to their account, if any. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are immediately vested in their contributions and actual earnings thereon. Vesting in the employer contributions and earnings thereon is based on years of service. A participant is 100 percent vested after six years of service, in which 1,000 hours or more have been worked each year. Participants become fully vested under the Plan by attaining early or normal retirement age, permanent disability, death or termination of the Plan.

(1) Plan Description, Continued

(e) Payment of Benefits

Upon termination of service due to death, disability, retirement or other reasons, a participant whose vested account balance does not exceed \$5,000 receives benefits in a lump sum. When the vested account balance exceeds \$5,000, a participant must elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. In-service distributions are allowed after age 59 1/2. Hardship withdrawals, with certain restrictions, are also allowed. Benefits are recorded when paid.

(f) Forfeitures

Upon termination of service of a participant, the non-vested portion of the participant's account is used to reduce the employer's contribution or used to pay plan expenses. The Plan used \$8,764 of forfeitures to reduce employer's contributions and \$2,662 for plan fees during 2024. The Plan used \$1,077 of forfeitures to reduce employer's contributions and \$46 for plan fees during 2023. Unallocated forfeitures as of December 31, 2024 and 2023, were \$13,003 and \$8,149, respectively.

(g) Administrative Expenses

Administrative expenses associated with the Plan are paid by the Plan and the Company.

(h) Investment Options

Upon enrollment in the Plan, a participant may direct contributions into various investment options, as defined by the Plan. Participants may change their allocation on a daily basis.

(i) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become 100% vested in their accounts.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

(2) Summary of Significant Accounting Policies, Continued

(b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of the Plan assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance companies. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) Payment of Benefits

Benefits are recorded when paid. There were no benefits payable at December 31, 2024 and 2023 for participants who had elected to withdraw from the Plan but had not been paid.

(e) Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the years then ended, was obtained by management and agreed to or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Trust Company ("Principal").

(3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common/collective trust funds: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

(3) Fair Value Measurements, Continued

Pooled separate accounts: Valued at the net asset value (NAV) of shares held by the Plan at year end.

Mutual funds: Valued at the daily closing prices as reported by the fund. These are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. These investments are deemed to be actively traded.

(4) Investment Contract with Insurance Company

The Plan entered into a benefit-responsive investment contract with Principal. Principal maintains the contributions in a fixed account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

(4) Investment Contract with Insurance Company, Continued

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$325,750 and \$294,903, respectively.

Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract does have surrender charges so if the participant terminated the contract or the Plan terminates its interest, the contract value would be reduced by the surrender charges.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

(5) Related Party Transactions

At December 31, 2024 and 2023, plan assets included investments in funds managed by Principal. Principal is the current custodian of the plan and, as such, transactions with the custodian qualify as party-in-interest transactions under ERISA. Personnel and facilities of the Company have been used to perform administrative services for the Plan at no charge to the Plan.

(6) Tax Status

The Plan adopted a proto-type non-standardized plan sponsored by Principal Life Insurance Company. The non-standardized plan has received an opinion letter from the Internal Revenue Service as to the plan's qualified status. The non-standardized plan opinion letter has been relied upon by this Plan. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

(6) Tax Status, Continued

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near future and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

(8) Subsequent Events

The Company has evaluated subsequent events through September 18, 2025, the date which the financial statements were available to be issued. There were no significant events identified which require disclosure in the financial statements or footnotes.
