Notes to Financial Statements

Note 1. Plan Description

The following description of the Toyota & Honda of Santa Maria 401(k) Plan and Trust (the Plan) provides only general information with regard to the Plan. Toyota & Honda of Santa Maria (the Company) is the Plan sponsor. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all employees of the Company and affiliated employers, who are age 21, have met the service requirement of 1 year of service during which the employee is credited with at least 1,000 hours, and are not members of a collective bargaining unit or non-resident aliens. Employees enter the Plan on the first of the quarter that occurs after the employee has completed the eligibility requirements. In addition, long-term part time employees who do not satisfy the standard service requirement of the Plan are eligible to make employee contributions into the Plan after completing 500 hours of service during each of three consecutive years (two consecutive years starting January 1, 2025) under the long-term part time rules. The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan administration:

The Company is the Plan sponsor and Plan administrator. The Plan administrator is responsible for carrying out the duties imposed under the ERISA, including oversight of the Plan, appropriateness of investment offerings, and monitoring investment performance.

The Company contracts with Charles Schwab Bank to act as the custodian. Milliman Inc. acts as the recordkeeper and third-party administrator to process and maintain records of participant data.

Contributions:

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants may also designate a portion or all of the deferral contributions as Roth 401(k) contributions that are included in the participant's gross income at the time deferred. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic increase provision whereby deferral rates will increase on the first of the Plan year by 1% of compensation until a deferral rate of 50% of compensation (decreases to 15% of compensation effective January 1, 2025) is reached, unless they affirmatively elect not to participate in the auto-escalation.

The Company may, in its discretion, make contributions, including discretionary matching contributions and profit sharing contributions. To be eligible, participants must meet all eligibility requirements and also be employed on the last day of the Plan year. For the year ended December 31, 2024, the Company made a discretionary matching contribution of \$100,000. The matching contribution was funded through a cash contribution subsequent to year-end. The contribution was allocated to participants based on a discretionary percentage of their elective deferrals for the Plan year. There was no Company profit sharing contribution for the year ended December 31, 2024.

Contributions are subject to certain IRS limitations.

Participant accounts:

Each participant's account is credited with the participant's contribution, the Company's matching contribution, if any, an allocation of the Company's profit sharing contribution, if any, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. All amounts in participant accounts are participant directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company matching and profit sharing contribution portion of their account (if any), plus actual earnings thereon, is based on years of service as follows:

Notes receivable from participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, is set at the prime rate plus 1%, as defined, which has been determined by the Plan administrator as a reasonable rate of interest, commensurate with local prevailing rates, as of the loan date. Principal and interest are paid through payroll deductions or through direct payments from the participants.

Benefit payments and withdrawals:

On termination due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution or installments. Upon termination for any reason, if the terminated participant's vested and non-forfeitable balance is less than \$7,000, the participant's balance may be distributed in the form of a lump sum without authorization from the participant. The lump sum distribution would be a cash distribution if the balance is under \$200, and a direct rollover to a default IRA if not. A participant may withdraw the elective deferral balance of their account for reasons of hardship.

Forfeited accounts:

Forfeitures result from non-vested benefit payments remaining in the Plan for all terminated employees or adjustments, if any. At December 31, 2024 and 2023, the forfeiture balance was \$2,176 and \$2, respectively. Forfeitures may be used to reduce administrative expenses of the Plan, then any remaining forfeitures may be used to supplement employer contributions. During the year ended December 31, 2024, forfeitures applied to reduce administrative expenses of the Plan and reduce employer contributions totaled \$9,323.

Note 2. Significant Accounting Policies

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash:

The Plan considers cash to be highly liquid, non-interest bearing funds held in the Plan with an original maturity of three months or less.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan sponsor's management determines the Plan's valuation policies utilizing information provided by the custodian and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default and uncollectible, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Excess contributions payable:

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Payment of benefits:

Benefits are recorded when paid.

Administrative expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to recordkeeping services, trustee services, third-party administration services, investment advisory services, and the plan audit, are included in administrative expenses and allocated to participant accounts based on a pro rata formula. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Other investment related expenses are included in net appreciation or depreciation of fair value of investments.

Note 4. Investments and Fair Value Measurements

The *Fair Value Measurements* topic of the Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC)* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or by other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

Mutual funds (and money market): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds: Valued at the NAV of units of the collective trust funds. Units of each fund are valued each day on which the New York Stock Exchange (NYSE) is open for trading in accordance with the valuation procedures established by the trustee. The NAV per unit is calculated by dividing the total fair value of the assets of a fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the fund and included in the determination of unit values. NAV is considered a readily determinable fair value and is the basis for current transactions.

Cash surrender value (CSV) of life insurance: Valued at cash surrender value using the current mortality cost charges and a current interest rate (not certified).

The valuation technique for the Level 3 investment is based on the cash surrender value, which uses the current mortality cost charges and a current interest rate, which estimates fair value. There are no significant unobservable inputs and the balance is not significant to overall plan assets.

Note 5. Related Party and Party-in-Interest Transactions

Charles Schwab Trust Bank is the custodian as defined by the Plan. CAPTRUST Financial Advisors is the investment advisor as defined by the Plan. Milliman Inc. is the third-party administrator and recordkeeper as defined by the Plan. Caliber Audit & Attest, LLP is the auditor as defined by the Plan. Therefore, transactions with these entities qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Notes receivable from participants and related interest income are also considered party-in-interest transactions, which are exempt from the prohibited transaction rules.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of the ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Including any applicable amendments, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan as of December 31, 2024, and is not aware of any uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.
