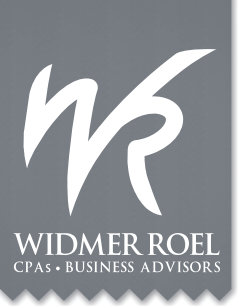

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of **Midland Garage Door Manufacturing Company 401(k) Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

### NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Midland Garage Door Manufacturing Company 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Defined Contribution Volume Submitter Plan and Trust (“Plan Document”) and the Adoption Agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution Plan covering eligible employees of Midland Holding Co LLC (“the Company”). Eligible employees are those which have reached 18 years of age and have completed two consecutive months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2024, the Nordick Group, Inc. ceased participation in the Plan. On February 5, 2024, the assets belonging to participants employed by the Nordick Group, Inc. were transferred to The Nordick Group, Inc. 401(k) Plan. The value of the assets transferred for the year ended December 31, 2024, has been reflected in the Statement of Changes in Net Assets Available for Benefits.

#### *Plan Amendments*

Effective January 1, 2024, the Plan was amended to reflect a change in Plan sponsorship from Midland Garage Door Manufacturing Company to Midland Holding Co LLC. Additionally, the Plan was amended to remove participation of the following employers: Midland Garage Door Manufacturing Company, Nordrpal Corp, and The Nordick Group, Inc. The Plan was also amended to recognize prior service with Midland Garage Door Manufacturing Company.

#### *Contributions*

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan, limited to the maximum allowed under the Internal Revenue Code (IRC). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions, limited to the maximum amount allowed under the IRC. Participants may also contribute amounts representing contributions from other qualified defined contribution plans. The Company can make discretionary employer contributions. Contributions are subject to certain limitations.

The Plan allows rollover contributions from other qualified plans.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contribution and allocations of (a) Company contributions, (b) Plan earnings, and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### *Vesting*

Participants are immediately vested in all employee contributions plus actual earnings thereon. The plan allows for discretionary profit-sharing contributions. Employer matching and discretionary profit-sharing contributions are subject to a six-year cliff vesting schedule as follows:

### *Investment Options*

Upon enrollment in the Plan, a participant may direct employee contributions in any of the offered investment options. Participants may change their investments options daily.

### *Payment of Benefits*

In the event a participant terminates employment due to separation of service, retirement, disability, or death, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a fixed number of years. For termination of service due to other reasons, a participant may receive a distribution of all or any part of the value of the vested interest in his or her account. For participants whose age exceeds 73 years, the Internal Revenue Service required minimum distribution rules may apply.

If, upon termination of employment due to separation of service, retirement, or disability, if the account balance is less than \$5,000, the participant may elect to receive either a lump-sum distribution of the entire account balance or rollover the account into an IRA or to another qualified account. If no election is made and the balance is less than \$5,000 but greater than \$1, the funds will be rolled over into an IRA in the participant's name with a provider selected by the Plan administrator.

On attainment of age 59½ years, a participant without termination of service may withdraw all or any portion of his or her vested account balance.

### *Administrative Fees*

The Plan trustee and record-keeper assesses a per-transaction fee for certain types of distributions. These fees were deducted from the individual participant's account balance and recorded as plan administration expense. The Plan trustee also assesses a fee for the administration of the Plan.

### *Forfeited Accounts*

A forfeiture occurs when a participant terminates employment and all or part of the participant's employer matching contributions are not vested. The nonvested portion is forfeited immediately if the participant either has no vested interest upon termination of employment or receives a distribution of the entire vested interest when the participant terminates employment. If none of these circumstances exist, nonvested balances are forfeited upon the completion of five consecutive years in which the Participant works fewer than twelve months.

At December 31, 2024 and 2023, forfeited non-vested accounts of terminated participants that have withdrawn from the Plan totaling \$174 and \$1,592, respectively, were available to reduce future employer contributions as provided by the Plan. Forfeitures of \$16,870 were used in 2024 to reduce employer discretionary contributions.

### **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### *Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

#### *Use of Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Subsequent Events*

The Plan's management has evaluated subsequent events through the date of the auditor's report, which is the date the financials were available to be issued. With the exception of those matters discussed in Note 9, there were no material subsequent events that required recognition or additional disclosure in these financial statements.

### NOTE 3 – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The Plan Administrator has elected the method of compliance permitted by the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, as permitted under such election, no independent auditing procedures were performed with respect to the information certified as complete and accurate by Bell Bank.

The Plan trustee has certified its statements of accounts as of December 31, 2024 and 2023, and for the year ended December 31, 2024. The statements of accounts include beginning and ending balances of investments held, notes receivable from participants, and detail of all transactions during the period, including investment earnings.

### NOTE 4 – FAIR VALUE MEASUREMENTS

The three levels of the fair value hierarchy in accordance with ASC 820 Fair Value Measurements are described below.

*Level 1* – Inputs to the valuation method are unadjusted quoted prices for identical instruments in active markets;

*Level 2* – Inputs to the valuation method include quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active and model-derived valuations whose significant inputs are observable; and

*Level 3* – Inputs to the valuation method are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Common/Collective Trust Funds* - Valued at the net asset value (“NAV”) of units of a bank common trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily.

*Mutual Funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

The Federated Capital Preservation Fund seeks stability of principal and high current income. The fund invests in a variety of Guaranteed Investment Contracts (GIC), including traditional GICs, separate account GICs, and synthetic GICs. Participants may redeem units of the fund daily for purpose of funding a bona fide benefit payment, making a participant loan, honoring an employee-directed transfer of the employee's interest in the Plan to another investment election that is a non-competing investment, or paying Trustee fees. Participants may make withdrawals from the fund for other purposes generally only upon 12 months advance written notice to the Trustee.

### NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### NOTE 6 – TAX STATUS

The Plan is a Volume Submitter Profit Sharing Plan. The IRS has issued an opinion by letter dated March 31, 2014, that the Volume Submitter Profit Sharing Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended and restated since adopting the prototype. The Plan Administrator believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that, therefore, the Plan qualifies under Section 401(k) and the related trust is tax-exempt as of December 31, 2024. For this reason, no provision for income taxes has been including in the Plan's financial statements.

Plan management is required to evaluate tax positions taken by the Plan and determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain positions taken.

### NOTE 7 – TRANSACTIONS WITH PARTIES-IN-INTEREST

The Company provides certain accounting and administrative services to the Plan, for which no fees are charged.

Certain Plan investments are in shares of investment funds managed by Bell Bank, the trustee, as defined by the Plan and therefore, these transactions qualify as party-in-interest.

Fees are incurred by the Plan to the trustee for third-party administrator and recordkeeping services pursuant to an administrative services agreement. These transactions are exempt party-in-interest transactions.

### NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

As of December 31, 2024 and 2023, the Plan had investments of \$4,577,197 and \$2,173,205, respectively, concentrated in two funds and one fund.

### NOTE 9 – SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan was amended to replace employer discretionary contributions with safe harbor contributions, which allows for an employer match of 100% on the first 4.0% of participant elective deferrals. This change provides an enhanced match when compared to the discretionary match for the Plan year ended December 31, 2024, of a 50% match on the first 6.0% of participant elective deferrals. Additionally, the Plan was amended to update the service requirement from one year to two months for match and non-elective employer contributions.

Effective January 1, 2025, the Plan was amended to add a participating employer agreement for MDM Utah, LLC. Through a stock acquisition and as a result of the transaction employees of MDM Utah, LLC became employees of the Plan Sponsor. Provisions of the amendment allow for recognition of prior service with MDM Utah, LLC and a one-time special entry date of January 9, 2025, for all employees of MDM Utah, LLC employed on January 1, 2025. As August 21, 2025, the Plan experienced rollover contributions in the amount of \$409,939, related to this acquisition by the Plan Sponsor.
