#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

I have performed audits of the financial statements of Insero & Co. CPAs, LLP 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## **NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023**

### ***Note 1*** **Description of Plan**

The following brief description of the Insero & Co. CPAs, LLP 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

#### **General**

The Plan is a defined contribution benefit plan sponsored by Insero & Co. CPAs, LLP (the Company or Employer) established to provide retirement benefits for all full-time employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Effective September 1, 2024, Fidelity Management Trust Company is the custodian and trustee for the Plan and Fidelity Workplace Services LLC is the recordkeeper (collectively, Fidelity). Prior to that date, Newport Trust Company was the custodian and trustee, and Burke Group was the recordkeeper.

#### **Contributions**

Participants may elect to make pre-tax or Roth (post-tax) deferrals in an amount not to exceed the statutory limitation under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. At the participant's date of eligibility, they are automatically enrolled in the Plan at a 5% salary deferral into a default investment option unless they indicate that they do not wish to participate in the Plan. On an annual basis, elective deferrals are automatically increased by 1% until the participant reaches a 10% deferral or opts out of auto escalation for elective deferrals.

The Company may make a matching contribution equal to a discretionary percentage of the participant's elective deferrals or a discretionary dollar amount, the percentage or dollar amount to be determined by the Employer on a uniform basis for all participants. For 2024, the Company approved a matching contribution equal to 30% of each eligible participant's contributions up to 10% of their compensation for the Plan year. Company matching contributions amounted to \$391,626 for the year ended December 31, 2024 of which \$337,829 was funded in cash and \$53,797 was funded from forfeited accounts. The employer contribution receivable at December 31, 2024 was received by the Plan in 2025.

The Plan also provides for discretionary employer profit sharing contributions. There were no discretionary profit-sharing contributions for 2024.

#### **Participant Accounts**

Each participant's account is credited with participant and employer contributions and allocations of Plan earnings (losses) and charged with distributions and an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company contributions plus earnings thereon is based on years of continuous services as follows:

Forfeited balances of terminated participant's non-vested accounts are used to reduce Company contributions. The forfeiture account balance was zero at December 31, 2024 and 2023.

#### **Investments**

Participants direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan. If a participant does not make an investment election, the participant's account will be invested in the various target date retirement funds (default investments), in accordance with plan provisions. Participants may change their investment options at any time.

#### **Payment of Benefits**

The Plan provides for normal retirement benefits in the form of a lump-sum upon reaching age 65 and has provisions for early retirement, disability, death, obtaining age 59½, hardship and termination benefits for those participants who are eligible to receive such benefits. If the value of a terminated employee's account does not exceed \$7,000, the participant's balance will be distributed automatically upon termination.

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the highest loan balance outstanding during the 12 month period prior to the new loan, or 50% of their vested account balance. A participant may not have more than two loans outstanding at any one time. Loan terms range from one to five years, or up to 15 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account. Effective January 1, 2020, new loans bear interest at the current prime rate plus 1%. Loans taken prior to that date bear interest at the prime rate plus 2%. Principal and interest is paid ratably through payroll deductions.

### ***Note 1* Description of Plan - Continued**

#### **Plan Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

### ***Note 2* Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Subsequent Events**

In preparing the financial statements, management has evaluated events and transactions for potential recognition or disclosure through September 19, 2025, the date that the financial statements were available to be issued.

#### **Use of Estimates**

The preparation of the Plan's financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are classified as distributions based upon the terms of the Plan document.

#### **Payment of Benefits**

Distributions of benefits to participants are recorded when paid.

#### **Risk and Uncertainties**

The Plan invests in investment securities which are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic, inflation or international conflict. Due to the level or risk associated with these investment securities, it is at least reasonably possible that changes in their values will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### ***Note 3* Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan follows the fair value measurement guidance required by accounting principles generally accepted in the United States of America for financial and nonfinancial assets and liabilities. This guidance defines fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements.)

The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value.

Money Market Fund and Mutual Funds: Valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market and is therefore classified as a Level 1 asset.

### ***Note 3* Investment Valuation and Income Recognition - Continued**

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Note 4* Certified Information**

The Company, acting in its capacity as the Plan administrator, has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information summarized below related to the accompanying financial statements and ERISA-required supplemental schedule was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company and Newport Trust Company.

### ***Note 5* Federal Tax Status**

Effective September 1, 2024, the Plan adopted a pre-approved plan document sponsored by FMR LLC, a related party to Fidelity. FMR LLC received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the pre-approved document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. The pre-approved plan's opinion letter has been relied upon by the Plan. The plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Prior to September 1, 2024, the Plan utilized a pre-approved document sponsored by Newport Group, Inc.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

***Note 6***     **Party-in-Interest Transactions**

Certain Plan investments are managed by an entity related to Fidelity. Transactions involving these investments qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

Certain employees and/or officers of the Company, who may also be participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

***Note 7***     **Plan Termination**

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, the accounts of all participants become fully vested and nonforfeitable.

***Note 8***     **Subsequent Event**

Subsequent to Plan year end, the plan sponsor changed to Insero Advisors, LLC and the Plan name was changed to Insero Advisors, LLC 401(k) Plan.
