To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Radical Media 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE 1: PLAN DESCRIPTION

The following description of the Radical Media 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) profit sharing plan covering all employees of Radical Media, LLC (the "Company" / "Sponsor") and related companies, who are eligible employees, as defined in the Plan document. All qualifying employees are active participants in the Plan for purposes of elective deferral contributions on the first day of the month following eligibility, and for contributions other than elective deferral contributions on the January 1 or July 1 on or after eligibility and completion of one year of service, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Elective Deferrals

Each year, participants may elect to defer from 1%, up to 100%, of their compensation, as defined, as pre-tax contributions to the Plan. In addition, the Plan provides a Roth contribution option whereby participants may designate a portion or all of their elective deferral contribution to be made on an after-tax basis. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. The initial automatic deferral rate of 3% will be increased in increments of 1% at the beginning of each Plan year until the automatic deferral rate reaches 10%, at which point there will be no further increase in the automatic deferral rate. Combined elective contributions cannot exceed the annual maximum amount as permitted by the Internal Revenue Service ("IRS"). Participants who are making maximum contributions and have attained age 50 or older before the end of the Plan year are eligible to make catch-up contributions of pre-tax contributions, Roth contributions or a combination of both, up to the maximum annual amount as permitted by the IRS.

Matching Contributions

The Company, on behalf of the participant, may contribute as of each pay period, a matching contribution equal to a percentage of the participant's elective deferral contribution. Matching contributions may be adjusted or suspended at the Company's discretion. For the year ended December 31, 2024, the Company matched 50% of the employee's elective deferral contributions up to 6% of the employee's eligible compensation, as defined.

Discretionary and Qualified Nonelective Contributions

Each Plan year, the Company may, but is not required to, make a discretionary and/or a qualified nonelective contribution to the Plan on behalf of all participants eligible at year end. Such contributions are to be allocated pro-rata based on annual compensation. The Company did not make a 2024 discretionary contribution.

Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. Contributions are subject to certain limitations under the IRS.

Rollovers and Transfers

Participants may make transfers to the Plan of amounts that are directly rolled over from another qualified plan as described by the IRS, including amounts attributable to after-tax employee contributions. A participant may, with the consent of the Plan administrator, make transfers between the Plan and other qualified plans or individual retirement accounts upon the occurrence of the events described in the Payment of Benefits section below.

NOTE 1: PLAN DESCRIPTION (Continued)

Participant Accounts

An account is established on behalf of each participant. Each participant's account is credited with the participant's contributions, the Company's matching contributions and allocations of (a) any Company discretionary contributions, and (b) Plan earnings, and charged with an allocation of administrative expenses. In addition, certain fees may be charged directly to a participant's account for participant requested transactions. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from that participant's vested account.

Vesting

Participants are fully vested, at all times, in their elective deferral contributions and qualified nonelective contributions plus actual earnings thereon. Participants become fully vested in the Company's discretionary contributions upon normal retirement age, death or disability. In all other circumstances, participants become vested based on years of service as follows:

3	40%

6 or more	100%

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, subject to the provisions set forth in the Plan document. Loans to participants are secured by the vested portions of those participants' accounts and bear interest at an annual rate of 3.25% - 8.50%, which is commensurate with rates available for similar loans from commercial lending institutions as determined periodically by the loan administrator. Principal and interest amounts are paid ratably through payroll deductions over a period of time not to exceed five years. With the exception of participants actively serving in the military or on an approved, unpaid leave of absence, as defined in the Plan document, if any loan repayment amount remains unpaid for 90 days past its due date, the loan is considered to be in default. Upon default, the entire outstanding principal balance and unpaid interest thereon become immediately due and payable. A loan default is deemed to be a distribution, which is an event taxable to the participant.

Payment of Benefits

Upon termination of service due to death, disability or retirement, the participant, participant's spouse or participant's beneficiary will receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Upon termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution, as set forth by the Plan.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are recorded at their unpaid principal balances plus any accrued and unpaid interest thereon. Interest income is recorded on the accrual basis. Related fees are expensed when incurred and recorded as administrative expenses. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be in default, the outstanding participant loan balance is extinguished, and a benefit payment is recorded for the same amount.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Expenses

Plan administrative expenses may be paid out of the Plan assets unless paid by the Company. Fees associated with participant requested transactions, including those related to administration of notes receivable from participants, are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,360 and \$627, respectively. These accounts are used to pay Plan expenses or to reduce future employer contributions. For the year ended December 31, 2024, employer contributions were reduced by \$32,667 and Plan expenses of \$3,826 were paid from forfeited non-vested accounts.

NOTE 3: INVESTMENTS – INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIANS AS COMPLETE AND ACCURATE

The following information in the accompanying financial statements and supplemental schedule as of December 31, 2024 and 2023 and for the year ended December 31, 2024, was obtained from data that has been prepared and certified to be complete and accurate by Reliance Trust Company ("Reliance") and Empower Retirement, LLC/Empower Trust Company, LLC ("Empower"). Reliance was the trustee of the Plan for the period January 1, 2023 to March 31, 2023. Effective April 1, 2023, Empower is the trustee of the Plan.

NOTE 4: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Collective Investment Trust

The Plan has various collective investment trust (“CIT”) investment options (see Note 5) that are composed primarily of fully benefit-responsive investment contracts and are valued at the net asset value (“NAV”) of units of the collective trusts. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the CIT’s will sell the investment for an amount different from the reported NAV.

Participant transactions (purchases and sales) may occur daily. Withdrawals from the CIT’s for benefit payments and participant transfers to noncompeting options to be paid to Plan participants shall be made within 30 days after written notification has been received and are considered as made immediately after the next valuation date subsequent to the custodian’s approval. Withdrawals, other than for benefit payments and participant transfers to noncompeting options, require a 12-month advance written notice. Included in this advance written notice requirement are full or partial withdrawals of assets invested in the CIT’s resulting from Plan Sponsor directed actions including, but not limited to: trustee or Plan Sponsor directed reallocation of investments, Company sponsored layoffs/termination of groups of employees, disposing of or selling a component of the business which involves the transfer or termination of employees, terminating the CIT’s as an investment option of the Plan, and terminating the Plan.

The custodian may choose to disburse withdrawals in less than the required one-year period if, in the custodian’s discretion, it determines that such a disbursement is in the best interest of the CIT’s as a whole.

Net investment income of the CIT’s is not distributed to participants, but reinvested into the CIT’s, and unit values are adjusted accordingly.

Mutual Funds

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4: FAIR VALUE MEASUREMENTS (Continued)

Pooled Separate Accounts

Pooled separate accounts are valued at the NAV of shares held at year end as determined by the issuer of the fund and are direct filing entities. These investments are measured using NAV as a practical expedient and have not been classified in the fair value hierarchy. The NAV amounts presented in the table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

NOTE 5: COLLECTIVE INVESTMENT TRUSTS

Participants in the Plan have the option to invest in one CIT, the Morley Stable Value Fund, a direct filing entity, which is a CIT offered by Principal Global Investors Trust Company, formerly Union Bond & Trust Company, as trustee, and Morley Capital Management, Inc., as investment advisor, both of which are wholly-owned subsidiaries of The Principal Financial Group.

NOTE 6: RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments represent shares in pooled separate accounts or other investments administered by JP Morgan which qualify as party-in-interest transactions. Administrative fees paid by the Plan amounted to \$36,712 for the year ended December 31, 2024.

NOTE 7: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 8: TAX STATUS

On May 18, 2022, the Plan adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase plan sponsored by Reliance. That Plan had previously obtained an opinion letter from the IRS dated June 30, 2020 stating that the form of the Plan is acceptable for use by employers for the benefit of their employees under Internal Revenue Code (the "IRC") Section 401. The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified and the related trust is tax-exempt. Reliance was the trustee prior to April 1, 2023.

Effective April 1, 2023, the Plan adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase plan sponsored by Empower. That plan had previously obtained an opinion letter from the IRS dated November 14, 2022 stating that the form of the plan is acceptable for use by employers for the benefit of their employees under IRC Section 401. The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management and the Plan administrator have analyzed the tax positions taken by the Plan, and have concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. There has been significant volatility in the market which has negatively impacted fair values. Management is unable to determine the impact on the Plan as of the date of this report.
