Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Puklich Chevrolet, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTE 1 PLAN DESCRIPTION

The following description of the Puklich Chevrolet, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

Puklich Chevrolet, Inc. established the Plan effective October 1, 1987. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is a defined contribution plan.

The plan is administered by the sponsor, Puklich Chevrolet, Inc. (the Company). FuturePlan by Ascensus serves as the third-party administrator of the Plan, while Voya Retirement Insurance and Annuity Company maintains the records of the participant data and holds the Plan assets.

Eligibility

All employees of the Company are eligible to participate in the Plan after 500 hours of service in a consecutive 6-month period; or 1,000 hours of service in the first year of eligibility (one year following first date of employment), and attainment of age 21 except for: union employees, leased employees, nonresident aliens, and dealer/trade drivers. To receive discretionary matching contributions, an employee must complete six months of service, be 21 years of age and be contributing to the Plan. To receive discretionary profit-sharing contributions, an employee must meet the eligibility requirements above and be employed on the last day of the plan year. Employees may enroll in the Plan at the beginning of each calendar year quarter.

Contributions

Participants may contribute up to the maximum dollar amount allowed under federal regulations for the plan year. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows for a discretionary match. For the years ended December 31, 2024 and 2023, the Plan matched 100% of the participant's elective deferrals up to 2% of the participant's eligible compensation. The Plan allows participants to allocate contributions between pretax and after tax (Roth 401(k)) deferrals.

Discretionary profit-sharing contributions to the Plan are also allowed and are allocated to each employee in the ratio that the compensation of the individual participant is to the compensation of all participants for the plan year. There were no discretionary profit-sharing contributions for the plan years ended December 31, 2024 and 2023.

Participants may make rollover contributions for amounts representing distributions from other qualified defined benefit plans, defined contribution plans, or individual retirement accounts.

Payment of Benefits

Upon termination of employment, death, disability, or retirement, the participant will receive a lump sum amount, installment distributions or ad-hoc distributions equal to the value of the participant's vested interest. Terminated participants with account balances of \$1,000 or less are required to take a lump sum distribution upon termination. Terminated participants with balances between \$1,000 and \$7,000 can elect to receive a lump sum payment or rollover those funds to another qualified plan. Hardship distributions and in-service retirement distributions are also permitted for participants who have not separated from service. Participants must have attained normal retirement age (age 59 ½) or early retirement age (age 55) and 6 years of service to qualify for in-service retirement distributions. Generally, certain minimum distributions are required for participants who have separated from service and have reached minimum distribution age.

Participant Accounts

Each participant's account is credited with the participant's contribution and the Company's contribution. Plan earnings are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. The Plan allows for participant-directed investment programs for which separate funds are maintained. The value of each participant's account is determined daily. Upon termination of service, a participant may elect to receive the value of his or her account in a lump sum payment, substantially equal annual or more frequent installments over a period not to exceed the joint life expectancy of the participant and their beneficiary. If the participant's interest is distributed in the form of an annuity purchased from an insurance company, distributions thereunder will be made in accordance with the requirements of Code 401(a)(9) and the regulations.

Participants' Investment Options

Participants must direct their salary deferral contributions and Company contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options throughout the year by contacting Voya Retirement Insurance and Annuity Company, the custodian.

Vesting

Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of service with certain exceptions for death and disability. A participant is 100% vested after six years of credited service or upon attaining retirement age.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to the maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account and bear interest of one percent above the Prime interest rate as published in the Wall Street Journal when the loan was obtained. The term of the loan cannot exceed five years, unless it is for the purchase of a principal residence, which must be repaid within twenty years. Principal and interest are paid ratably through payroll deductions.

Forfeitures

Forfeitures can be used in any permissible method, including to restore forfeitures, reduce employer contributions, or to pay Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,445 and \$6,928, respectively. During the years ended December 31, 2024 and 2023, \$13,781 and \$14,794 were used to reduce employer matching contributions, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Basis of Presentation

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for investments in insurance contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year and is reflected in the statements of changes in net assets available for benefits.

Contributions

Contributions from Plan participants and matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit distributions are recorded when paid.

Administrative Expenses

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Participant loan accounts are assessed a separate fee for the administration of loans. Certain administrative expenses that are paid by the Company are excluded from these financial statements.

Income Taxes

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

NOTE 4 FAIR VALUE MEASUREMENT

Financial Accounting Standards Board Statement ASC Topic 820, *Fair Value* Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
 Quoted prices for similar assets or liabilities in active markets;
 Quoted prices for identical or similar assets or liabilities in inactive markets;
 Inputs other than quoted prices that are observable for the asset or liability;
 Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
 If the asset or liability has a specified (contractual) term the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the net asset value (NAV) of shares held by the Plan at year end. The NAV, as provided by the insurance company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the account less its liabilities. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the accounts, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodology is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan does not have any assets to be classified within the fair value hierarchy table. See investments measured using the net asset value per share practical expedient in the following table to reconcile investments at fair value on the Statement of Net Assets Available for Benefits.

Balanced pooled separate accounts invest in a diversified portfolio of quality stocks and bonds to promote versatility and lead to more consistent results.

Bond pooled separate accounts invest in bonds and are designed to provide regular income from interest paid by the bonds they hold.

Growth pooled separate accounts include investments that invest in companies the account manager believes have above-average growth potential. Most underlying holdings are in common stocks. The accounts may make limited use of futures and/or options for the purpose of maintaining equity exposure. These managers are generally willing to pay higher market multiples for the superior growth rates and profitability they anticipate. As a result, stocks in growth portfolios will tend to have higher price/earnings ratios and will generally pay little or no dividends.

Value pooled separate accounts primarily hold stocks that are deemed to be undervalued in price and that are likely to pay dividends.

Blended pooled separate accounts invest primarily in a combination of stocks, bonds, and cash-equivalent investments. Over the long term, they seek growth of both capital and income.

Asset allocation pooled separate accounts provide investors with a portfolio of a mix of stocks and bonds, as well as cash equivalents, with a variety of objectives.

Diversified income pooled separate accounts seek income by investing in a broadly diversified array of securities including bonds, common stocks, real estate securities, foreign market bonds and stocks, and money market instruments. Bonds, stocks, and cash components will vary, reflecting the portfolio manager's judgments of the relative availability of attractively yielding and priced stock and bonds.

Diversified emerging markets pooled separate accounts seek long-term capital appreciation by investing primarily in equity securities, principally common stocks, of non-U.S. companies whose principal activities are located in emerging market countries and are undervalued based on their earnings. Under normal circumstances, it invests at least 80% of its assets in equity securities of companies whose principal business activities are located in emerging market countries.

Target retirement pooled separate accounts seek a high total return with asset allocations tailored to individuals' expected retirement dates. These funds invest in a mix of fixed income, stocks, and alternative assets depending upon the expected retirement date.

NOTE 5 CONTRACT WITH INSURANCE ENTITY

During the year ended December 31, 2016, the Plan entered into an insurance contract with Voya Retirement Insurance and Annuity Company (VRIAC). Under the terms of that contract, Plan participants can direct funds to pooled separate accounts or the Voya Fixed Account which has a primary objective of stability of principal. The Voya Fixed Account is an obligation of VRIAC's general account which supports all of the company's insurance and annuity commitments. The interest rate guarantees under the contract are subject to VRIAC's claims-paying ability.

The Voya Fixed Account guarantees minimum rates of interest and may credit interest that exceeds the minimum guaranteed rate. The current rate is subject to change at any time but will never fall below the guaranteed minimum. The guaranteed minimum interest rate was 1% as of December 31, 2024 and 2023. Daily credited interest becomes part of the principal and the investment increases through compound interest. The same credited rate applies to all funds a participant invests in the Voya Fixed Account under the portfolio method of interest rate crediting. The credit rating of the issuer at December 31, 2024 and 2023 was A2 as reported by Moody's Investors Service.

The Voya Fixed Account guarantees principal and a guaranteed minimum interest rate (GMIR) for the life of the contract, as well as featuring two declared interest rates: a current rate, determined at least monthly, and a guaranteed minimum floor rate declared for a defined period - currently one calendar year. The GMIR may vary by participant based on the date the participant established an account under the VRIAC contract. The guaranteed minimum floor rate may change after a defined period, but it will never be lower than the GMIR that applies for the life of the contract. The current rate, the guaranteed minimum floor rate and the GMIR are expressed as annual effective yields.

The Voya Fixed Account is intended to be a long-term investment for participants seeking stability of principal. The assets supporting it are invested by VRIAC with this goal in mind. Therefore, VRIAC may impose limitations on the ability to move funds into or out of this investment option. Transfers from the Voya Fixed Account to other investment options within the contract are limited to the 'window' which varies but will never be less than 10 percent of the balance in the Voya Fixed Account as of the date of transfer, reduced by any prior transfers made during the same calendar year. Withdrawals from the Voya Fixed Account are not subject to this window limitation, and may be made for any reason, subject to plan or Internal Revenue Code limitations; however, the withdrawal may be subject to a withdrawal fee.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
- Premature termination of the contracts
- Plan termination or merger
- Changes to the Plan's prohibition on completing investment options
- Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer.

The contract permits the insurance company to terminate the agreement with 90 days advanced written notice.

NOTE 6 INCOME TAX STATUS

The Plan adopted a non-standardized pre-approved profit sharing plan sponsored by Ascensus. The non-standardized pre-approved profit sharing plan has received an opinion letter dated June 30, 2020, from the Internal Revenue Service as to the plan's qualification status. The opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

NOTE 7 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan is currently funded through a group funding agreement issued by Voya Retirement Insurance and Annuity Company (Voya). The contract makes certain mutual funds available to the Plan through a pooled separate account and also provides a credit rate investment option (Voya Fixed Account) for the Plan. Certain investment options offered by the Plan are Voya proprietary funds and Voya is a party-in-interest to such funds.

Voya provided recordkeeping services to the Plan during the years ended December 31, 2024 and 2023, and received indirect compensation from the Plan's investments as compensation for these recordkeeping services. These transactions are covered by a permanent exemption under Section 408 of the Employee Retirement Income Security Act of 1974, and therefore, are not a violation of the prohibited transactions regulations promulgated by Act Section 406.

FuturePlan by Ascensus provides third party administrator services for the Plan.

NOTE 8 AMENDMENT AND TERMINATION

Although it has not expressed any intent to do so, the Company reserves the right at any time to amend or terminate the Plan subject to the provisions of the Plan and ERISA. If the Company terminates contributions or the Plan is terminated, all participants become fully vested.

NOTE 9 RISKS AND UNCERTAINTIES

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10 SUBSEQUENT EVENTS

No significant events occurred subsequent to the Plan's year end. Subsequent events have been evaluated through September 19, 2025, which is the date these financial statements were available to be issued.
