## **1. Description of Plan**

The following description of the UltiSat Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

### **General**

The Plan is a defined contribution plan covering eligible employees of UltiSat Inc., and its participating related companies (the “Company”). Eligible employees, as defined by the Plan, who have attained age 18, are fully eligible to enter the Plan on the first day of each month. Non-resident aliens who do not receive any earned income from the Company that constitutes United States source income, leased employees, and employees covered by a collective bargaining agreement are excluded from participation in the Plan. Temporary employees and interns are also excluded from participation in the Plan unless such employees have reached the age of 21 and have completed 1,000 hours of service. Salary deferral eligibility requirements for these employees have been modified to reflect provisions required by the Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022 (“SECURE Act 2.0”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. Fidelity Management Trust Company (“Fidelity” or “Trustee”) is the trustee of the Plan.

### **Contributions**

Each year, participants may contribute up to 90 percent of their pre-tax annual compensation, as defined in the Plan document, up to the maximum amount allowed by the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also allows for Roth 401(k) contributions. Participants may also contribute amounts representing qualified rollovers from other qualified defined benefit or contribution plans.

The Plan includes an auto-enrollment provision whereby an initial pre-tax deferral contribution of 6 percent will be made for newly eligible employees 35 days after employee’s date of hire, unless they affirmatively elect not to participate in the Plan or elect a different deferral contribution percentage. Contributions from automatic enrollment are invested in a designated fund until changed by the participant. The Plan also allows for an auto escalation clause whereby participants who have been auto enrolled in the Plan will have that deferral increased annually by 1 percent as a pre-tax deferral contribution until a deferral rate of 10 percent is reached.

Effective January 1, 2024, the Plan was amended and restated to provide for a safe harbor matching employer contribution equal to 100% of the first 5% of eligible compensation a participant contributes to the Plan, and to provide for additional discretionary matching employer contributions (see Note 9). For the year ended December 31, 2024, there were no additional discretionary matching employer contributions declared by the Company.

The Plan may provide for non-elective employer contributions at the employer’s discretion. Participants must be employed by the Company on the last day of the year in order to receive the non-elective employer contribution, unless the participant dies, becomes disabled, or retires during the year. For the year ended December 31, 2024, there were no discretionary non-elective employer contributions declared by the Company.

Participants direct the investment of their deferral contributions and employer contributions into various investment options offered by the Plan. Participants may change their investment options at any time.

### **Participant Accounts**

Individual accounts are maintained for each participant. Each participant’s account is credited with the participant’s contributions, safe harbor matching employer contributions, and the Company’s matching contributions, if any, as well as allocations of non-elective employer contributions, when declared, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are vested immediately in their contributions, including their elective pre-tax deferral contributions, Roth 401(k) deferrals, safe harbor matching employer contributions, additional discretionary matching contributions, discretionary non-elective employer contributions and rollover contributions, plus actual earnings thereon. Different vesting schedules apply to certain employer contributions which were merged into the Plan from other plans.

A participant is 100 percent vested upon death, disability, normal retirement age (65) or early retirement.

**Forfeited Amounts**

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$9,486, respectively. Forfeitures may be used to reduce employer matching contributions, and/or to pay administrative expenses to the Plan. During the year ended December 31, 2024, forfeitures of \$13 were used to pay administrative expenses of the Plan, and \$9,563 of forfeitures were used to offset employer contributions.

**Payment of Benefits**

Upon termination of service, death, disability, retirement or separation from service, participants or their beneficiaries will receive, in a lump-sum payment, an amount equal to the value of the participant's vested interest in his or her account. If a participant's vested account balance is less than the cash out limit defined in IRC Section 411(a)(11)(A) upon termination, a distribution of the participant's account may be rolled over to an individual retirement plan designated by the Plan administrator.

In-service withdrawals of all or a portion of a participant's vested account balance may be made by participants who have attained the age of 59-1/2. Participants are also permitted to make hardship withdrawals from their vested portion of their accounts in certain cases of immediate and heavy financial need. In-service withdrawals of all or a portion of a participant's rollover account balance may be withdrawn at any time.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Participants may have only 1 loan outstanding at any time. The loans are secured by the balance in the participant's account and bear interest at one percent above the prime rate at the time of borrowing, as determined by the trustee. Principal and interest are repaid ratably through payroll deductions over a period of five years or less, with the exception of loans made for the purchase of a primary residence, where the repayment period may be up to and including ten years. Interest rates on notes receivable from participants ranged from 4.25% to 9.50% as of December 31, 2024.

**2. Summary of Significant Accounting Policies**

The following are the significant accounting policies followed by the Plan:

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit distribution is recorded, based upon the terms of the Plan document.

**Contributions**

Contributions from Plan participants, safe harbor matching employer contributions, and additional discretionary matching employer contributions from the Company, if any, are recorded in the year in which the employee contributions are withheld from compensation. Discretionary non-elective employer contributions from the Company, if any, are recorded in the year earned.

**Payments of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable and other participant-specific fees are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are included in the net appreciation in fair value of investments.

**3. Information Certified by a Qualified Institution**

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company, a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, notes receivable from participants, other receivables, and other payables as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment activity, including net appreciation in fair value of investments, dividend and interest income, and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The information for all mutual funds (registered investment companies), common collective trust, self-directed brokerage accounts, and participant loans listed in the schedule of assets (held at end of year) as of December 31, 2024, as shown in the ERISA-required supplemental schedule.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable

inputs (level 3 measurements). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") Accounting Standards Codification are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

*Mutual funds and self-directed brokerage accounts:*

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Self-directed brokerage accounts generally are limited to certain mutual funds, including money market funds, and publicly traded common stock, preferred stock, and exchange-traded funds. Common stock, preferred stock, and exchange-traded funds are valued at the closing prices reported on the active market on which the individual securities are traded.

*Common collective trust:*

The common collective trust is valued at the net asset value or equivalent based on units of the common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the common collective trust less its liabilities. This practical expedient is not used when it is determined to be probable that the common collective trust will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's common collective trust is invested in a stable value fund that seeks the preservation of capital and to provide a competitive level of income over time that is consistent with the preservation of capital. This common collective trust is redeemable at NAV under agreements with the underlying common collective trust. However, it is possible that these redemption rights may be restricted by the common collective trust in the future in accordance with underlying trust agreements. Due to the nature of the investments held by the common collective trust, changes in market conditions and the economic environment may significantly impact the NAV of the common collective trust, and consequently, the fair value of the Plan's interest in the common collective trust. Furthermore, changes in the liquidity provisions of the common collective trust may significantly impact the fair value of the Plan's interest in the common collective trust.

## 5. Related-Party and Party-In-Interest Transactions

Plan investments include funds managed by affiliates of Fidelity Management Trust Company ("FMTC"). FMTC and/or affiliates provide recordkeeping, trustee and custodial services to the Plan. Therefore, administrative fees charged by FMTC that are paid from Plan assets qualify as party-in-interest transactions. In addition, the Plan is provided services by an investment advisor and plan auditor, which also qualify as parties-in-interest to the Plan. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations. Fees paid by the Plan amount to \$53,962 for the year ended December 31, 2024. Additionally, for

participants who have elected to take a participant loan, the loans are secured by the respective participant's account balance.

Fidelity Management Trust Company or its affiliates generate income to the Plan through revenue sharing agreements. More specifically, Fidelity Management Trust Company or its affiliates may receive revenue from mutual fund and common collective trust service providers for services Fidelity Management Trust Company or its affiliates provide to the funds and common collective trust. This revenue may be used to offset certain amounts owed to Fidelity Management Trust Company or its affiliates for administrative services to the Plan. If the revenue received by Fidelity Management Trust Company or its affiliates from such mutual fund or common collective trust service providers exceeds the amount owed as agreed to by Fidelity Management Trust Company and the Plan for administrative services, Fidelity Management Trust Company or its affiliates is to remit the excess to the Plan. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During the year ended December 31, 2024, the related amounts deposited into the Plan were \$0. During the year ended December 31, 2023, \$21,464 was used to pay administrative expenses and no amounts were allocated to participants. As of December 31, 2024 and 2023, the balance in this account totaled \$0 and \$21,197, respectively. The Plan or Company may make a payment to Fidelity Management Trust Company or its affiliates for administrative expenses not covered by revenue sharing.

## **6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, including any employer contributions for which they were not already vested, and all remaining assets in the Plan are to be distributed to the participants in accordance with the accrued benefits of such participants as of the date of termination.

## **7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

## **8. Tax Status**

Effective January 1, 2024, through the adoption of a Fidelity Pre-Approved Defined Contribution Plan, the Plan was amended and restated. The IRS issued an opinion letter dated June 30, 2020, stating that the pre-approved defined contribution plan document was designed in accordance with applicable IRC requirements as of that date. Although the Plan has been amended since receiving the opinion letter, management of the Plan believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. An audit by the IRS for the Plan's 2019 through 2022 Form 5500 filings commenced in 2023 and ended in 2024 with the IRS accepting the returns as filed with no changes necessary in the information reported. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2023.

**9. Plan Amendments**

Effective January 1, 2024, the Plan was amended and restated to change the discretionary employer matching contribution to a safe harbor matching employer contribution equal to 100% of the first 5% of eligible compensation a participant contributes to the Plan, and provide for an additional discretionary matching employer contribution.

**10. Subsequent Events**

Effective January 1, 2025, the Plan was amended to change the contribution period for the additional discretionary matching employer contributions from an annual basis to a pay-by-pay basis.

Management evaluated subsequent events for the Plan through September 25, 2025, the date the financial statements were available to be issued.
