We have performed audits of the financial statements of Inwood National Bank 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. #### Note 1. Description of the Plan

The following description of the Inwood National Bank 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan whereby eligible employees of Inwood National Bank, N.A. (the Company or Plan Sponsor) are permitted to make contributions that are tax-deferred under Section 401(k) of the Internal Revenue Code (IRC). The Plan is intended to stratify the requirements for a qualified retirement plan under the appropriate provision of the IRC. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility:** Employees become eligible for participation at the age of 18 and upon completing three months of continuous service, as defined by the Plan. Effective January 1, 2023, employees may begin participating the first day of the month following satisfaction of the minimum age and service requirements. Prior to January 1, 2023, employees were eligible to begin participating the first day of the quarter following satisfaction of the eligibility requirements.

**Contributions:** Each year, participants may elect to contribute a portion of pretax compensation from 1% to 90%, subject to certain maximum limitations imposed by the IRC. Participants are automatically enrolled to contribute 3% of their pretax compensation upon becoming eligible unless elected otherwise. Employee contributions are automatically increased by 1% annually, to a maximum deferral of 6% unless elected otherwise. Employees who are eligible to make elective deferrals under the Plan and who have attained the age of 50 before the close of the plan year are also eligible to make catch-up contributions subject to the maximum limitation imposed by the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company may make discretionary matching contributions up to 50% of the participant's deferral contributions, not to exceed 15% of employees' pretax compensation. The Company may also make additional discretionary contributions. There were no additional discretionary contributions in 2024.

**Participant accounts:** Each participant's account is credited with the participant's contribution and allocations of: (a) the Company's matching contributions, (b) the Company's discretionary contributions and (c) Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings and account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's vested account.

**Investment options:** Participants must direct their contributions to selected investments as made available and determined by the Company. Participants may change their investment options any time throughout the year via internet or direct phone access to Charles Schwab Trust Bank, the current Plan trustee. The Plan currently offers a collective investment trust and various mutual funds for participants to invest in. Additionally, the Plan offers a brokerage account option to participants. The participants are responsible for selecting the investments within their brokerage account.

#### Note 1. Description of the Plan (Continued)

**Vesting:** Participant contributions plus actual earnings are immediately vested and nonforfeitable. Employer contributions vest to participants based upon years of continuous service. Participants are vested in employer discretionary matching and additional discretionary contributions based upon the following schedule:

Years of Service	Vesting Percentage
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years	100%

**Forfeitures:** Forfeitures of nonvested Company matching and discretionary contributions by participants who withdraw from the Plan are retained by the Plan and may be used by the Plan. At December 31, unused forfeited nonvested employer contributions amounted to approximately \$700 for 2024 and \$8,000 for 2023. Amounts forfeited during 2024 were approximately \$31,000. The Plan used forfeitures of approximately \$38,000 to reduce employer matching contributions.

Effective September 23, 2024, the Plan was amended to change the allocation of forfeitures to be used to reduce employer or matching contributions rather than being reallocated as additional employer or matching contributions. Prior to the amendment, the Plan used forfeitures of approximately \$23,000, \$38,000, and \$41,000 during 2024, 2023, and 2022, respectively, to reduce employer matching contributions. See Note 9 for additional details.

**Payment of benefits:** On termination of service due to death, disability or retirement, payments of benefits are made in an amount equal to the value of the participant's vested interest in their account in a lump-sum distribution, unless a participant elects to delay the distribution as specified in the provisions of the Plan. If a participant's account balance is \$5,000 or less, the participant will automatically receive a single lump-sum distribution of their entire account balance. Amounts rolled over from another qualified plan will be excluded in determining whether the \$5,000 threshold has been exceeded. The Plan also allows participants to make hardship withdrawals, subject to certain limitations as defined.

**Notes receivable from participants:** Notes receivable are available to all participants at an interest rate comparable to rates offered by commercial lending institutions with periodic repayment through payroll deductions over a period not generally extending beyond five years unless the note receivable is used to purchase a principal residence. Notes receivable balances outstanding at December 31, 2024, are due at varying dates through December 2034 and bear interest between 4.25% to 9.50%. Participants may borrow from their participant accounts a minimum of \$1,000 to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Only one loan may be outstanding at a time.

**Basis of accounting:** The financial statements of the Plan are presented on the accrual basis of accounting.

#### Note 2. Summary of Significant Accounting Policies

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Capital gains distributions from mutual funds that are reinvested are included with dividends on the statement of changes in net assets available for benefits.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Delinquent notes receivable are treated as an asset on the statements of net assets available for benefits, and continue to accrue interest until they are considered to be in default. Notes in default are classified as distributions on the statement of changes in net assets available for benefits. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Payment of benefits:** Benefits are recorded when paid.

**Administrative expenses:** Certain administration functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain other administrative expenses are paid directly by the Plan.

**Subsequent events:** The Plan Administrator has evaluated events and transactions for potential recognition or disclosure through September 2, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan was amended to change when forfeitures will be applied. Forfeitures will be applied for the plan year following the plan year in which the forfeitures occur rather than for the plan year in which the forfeiture occurs.

A new loan policy became effective January 1, 2025. Two loans may be outstanding at any time. Loans for the purchase of a participant's primary residence may be payable over any reasonable period commensurate with the period permitted by commercial lenders for similar loans, subject to any internal administrative limitations as defined in the loan policy. A participant may not renegotiate the terms of a loan.

#### Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurement and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Mutual funds are valued based on the quoted market prices in the active market in which they are traded.

**Collective investment trust:** The collective investment trust is made up of a stable value fund that is composed primarily of fully benefit-responsive investment contracts and is valued at the net asset value (NAV) of units of the collective investment trust. The NAV is used as a practical expedient to estimate fair value.

**Brokerage accounts:** Brokerage accounts include investments in common stocks, mutual funds and money market funds. The fair value of common stocks included in brokerage accounts is valued at the closing price reported on the active market on which the individual securities are traded. The fair value of mutual funds held in brokerage accounts is determined as described above.

**Changes in fair value:** To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

#### Note 5. Party-in-Interest Transactions

Parties-in-interest are defined under the DOL's Rules and Regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. As such, transactions conducted by the Company, Charles Schwab Trust Bank, the Plan's trustee, and the Plan's record keeper, July Business Services, qualify as party-in-interest transactions.

#### Note 6. Income Tax Status

The Plan has adopted a nonstandardized form of a preapproved plan sponsored by July Business Services. The preapproved plan has received an opinion letter, dated June 30, 2020, from the Internal Revenue Service (IRS) as to the preapproved plan's qualified status. The preapproved plan opinion letter has been relied upon by the Plan. The Plan has been amended since receiving the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Management has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

#### Note 7. Plan Termination

While it has expressed no intention to do so, the Company has the right to terminate the Plan. In the event of termination of the Plan, the participants become fully vested in their entire account balances and the net assets of the Plan will be distributed to the participants of the Plan in accordance with the provisions of ERISA.

#### Note 8. Risks and Uncertainties

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate and market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### **Note 9. Prohibited Transactions**

The Plan Sponsor inadvertently failed to deposit approximately \$65,000 during 2023 of participant contributions and loan repayments within the required timeframe as stated by the United States Department of Labor regulations. The Plan Sponsor deposited lost earnings to correct this failure for the 2023 late deposits in 2024. The Plan Sponsor also filed Form 5330 and paid the applicable excise tax to the IRS in 2024. The correction and any excise taxes were made from the Plan Sponsor's assets and not from the assets of the Plan.

During 2024, 2023 and 2022, the Plan Sponsor failed to apply forfeitures in accordance with the Plan document. The Plan document, prior to being amended in September 2024, states that forfeitures may be used to pay plan administrative expenses or allocated as additional employer discretionary contributions. Prior to the amendment, forfeitures in the amount of approximately \$23,000, \$38,000 and \$41,000 during 2024, 2023 and 2022, respectively, were used to reduce employer matching contributions. The Plan Sponsor deposited these amounts, along with lost earnings, to correct this failure in 2024. As described in Note 1, the Plan was amended effective September 23, 2024, to amend the Plan document to allow forfeitures to be used to reduce employer matching contributions going forward.
