We have performed audits of the financial statements of Mobro Marine, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). ### 1. Description of Plan:

The following description of the Mobro Marine, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan was established on August 1, 1994 for the administration of any contributions made by Mobro Marine, Inc. (the “Company”) and to encourage eligible employees to defer a part of their current income to provide for their retirement, death or disability under the provisions of Section 401(k) of the Internal Revenue Code (“IRC”). The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan was restated effective April 15, 2023, to comply with Internal Revenue Service (“IRS”) restatement requirements. The restatement of the Plan incorporated all prior Plan amendments.

#### *Eligibility*

The Plan covers all full-time employees of the Company who have completed one year of service with 1,000 hours a year of crediting service and are age twenty-one or older. Eligible employees may enroll the first day of January or the first day of July coincident with or next following the date the employee satisfies the Plan’s eligibility requirements.

#### *Contributions*

Each year participants may elect to contribute up to 75% of their annual compensation, as defined by the Plan up to the maximum allowable under the Internal Revenue Code (“IRC”). In addition, employees who have attained age 50 by the end of the Plan year may make catch-up contributions up to limits defined by the IRS. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company has elected to make safe harbor contributions equal to 3% of the basic annual compensation for all participants eligible for allocation. Additional discretionary matching contributions of up to 4% of eligible compensation and discretionary nonelective contributions may be made at the option of the Company’s Board of Directors. Contributions are subject to certain limitations. No employer discretionary contributions were made in 2024.

#### *Investment Options*

Participants may direct the investment of their account balances into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds and a common collective trust fund as investment options for participants.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contributions, allocations of Company contributions, and participant earnings. Participant earnings are based on an allocation of Plan earnings respective to each participant’s account balances and investment selections. Transaction fees are deducted directly from the applicable participant’s account. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### 1. Description of Plan (Continued):

#### *Vesting*

Participants are immediately 100% vested in their elective deferrals, including catch-up contributions and rollover contributions from other plans, plus actual earnings thereon, as well as Company safe harbor contributions plus earnings thereon.

Vesting in the Company's discretionary matching and nonelective contributions plus actual earnings thereon is based on years of continuous service.

Participant vesting in employer discretionary matching contributions and nonelective contributions are as follows:

Less than 2	0%
2 but less than 3	20%

#### *Forfeited Accounts*

Forfeitures by non-vested participants may be used to reduce future employer contributions, pay administrative expenses or restore previously forfeited accounts for qualified participants with a break in service. For the year ended December 31, 2024, forfeitures totaling \$10,065 were used to reduce employer contributions and pay administrative expenses. At December 31, 2024 and 2023, forfeited non-vested accounts of approximately \$1,650 and \$11,374, respectively, were held at year-end available to be used by the Plan.

#### *Notes Receivable from Participants*

Participants may borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and must be repaid in level payments through payroll deductions over a five-year period, except for loans for the purchase of a principal residence which may be repaid over a reasonable period of time that may be longer than five years. The loans bear interest at the prime rate plus 2%.

#### *Payment of Benefits*

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in their account in accordance with Plan provisions. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan.

Account balances that are under \$5,000 may be automatically distributed upon termination of service as a lump sum without consent of the participant.

**2. Summary of Accounting Policies:**

*Basis of Accounting*

The accompanying financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

*Use of Estimates*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets and changes therein. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition*

The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of the investments within the Plan are reflected on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Realized gains and losses on the sales of securities are reported on the average cost method.

*Notes Receivable from Participants*

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as distributed based upon the terms of the Plan document.

*Plan Expenses*

The majority of administrative expenses are paid by the Company and not recorded by the Plan. Administrative expenses recorded in the Plan pertain to transaction fees which are deducted directly from the applicable participant's account.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

*Payment of Benefits*

Benefits are recorded when paid.

**2. Summary of Accounting Policies (Continued):**

*Risks and Uncertainties*

The Plan invests in a combination of investment securities which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**3. Fair Value Measurements:**

The Financial Accounting Standards Board, Accounting Standards Codification Topic 820 ("ASC 820"), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly.

Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

In many cases, a valuation technique used to measure fair value includes inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

*Mutual funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*Money market:* Valued at the amounts of cash balances on deposit, which approximates fair value.

The Plan invests in a common collective/trust that invests in separate account investment contracts issued by life insurance companies, banks and other financial institutions. The investment in the common/collective trust is valued at net asset value based on the fair value of the underlying securities within the investment in accordance with ASC 820. It is possible that the redemption rights may be restricted in the future in accordance with the underlying fund agreements which could impact the fair value of the Plan's interests in the fund.

#### 4. Information Certified by the Plan Trustee:

The following investments included in the statements of net assets available for benefits as of December 31, 2024 and 2023, and the net appreciation in fair value of investments and dividend and interest income included in the statement of changes in net assets available for benefits for the year ended December 31, 2024 have been derived from information certified as complete and accurate by Matrix Trust Company, trustee of the Plan, in accordance with 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

#### **5. Party-In-Interest Transactions:**

Fees paid to Northwest Plan Services Recordkeeping, recordkeeper for Plan, for transaction fees charged to participants amounted to \$2,150 for the year ended December 31, 2024, and is included in transaction fees in the accompanying statement of changes in net assets available for benefits.

#### **6. Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100 percent vested in their accounts.

#### **7. Tax Status:**

The Plan obtained a determination letter on June 30, 2020, in which the IRS stated that the Plan was in accordance with applicable sections of the IRC. The Plan has not been amended since receiving the letter and Plan management believes the Plan continues to be in compliance with applicable requirements of the IRC and the related trust continues to be tax exempt.

Management evaluated the Plan's tax positions and concluded that as of December 31, 2024, the Plan had taken no uncertain tax positions that require recognition of a liability (or asset) in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

#### **8. Subsequent Events:**

Management has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be filed, and has determined that there were no material events requiring recognition or disclosure.
