Notes to Financial Statements

1. Description of the Plan

The following brief description of Wheeler Trigg O'Donnell LLP 401(k) Profit-Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan was established by Wheeler Trigg O'Donnell LLP (the Company or Employer) effective February 1, 1998 and most recently amended and restated for regulatory purposes on January 1, 2021. The Plan is a contributory, defined contribution 401(k) profit-sharing plan available to qualifying employees of the Employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Trustee and Administration of the Plan

The Company administers the Plan. Vanguard Fiduciary Trust Company (Vanguard) serves as trustee and manages Plan assets and maintains the Plan's records. Charles Schwab is the sub-custodian for the self-directed brokerage account held in the Plan. Individual accounts are invested in the various investment options at the direction of the participants. The Retirement Plan Committee determines the Plan's investment offerings and monitors investment performance.

Eligibility

Employees are eligible immediately upon hire. Leased employees and independent contractors are not eligible to participate in the Plan.

Contributions

Participants may make pre-tax or after-tax Roth contributions subject to certain Internal Revenue Code (IRC) limitations. Employee contributions to the Plan are generally made through regular payroll deductions. The Plan also allows catch-up contributions for participants aged 50 or over, based on IRC limitations. Newly eligible participants are automatically enrolled at 5%, unless they elect not to participate or elect otherwise. Effective January 1, 2024, the plan implemented auto increase in which participants that were automatically enrolled in the plan would increase their deferral by 1% each plan year to a maximum deferral of 10%. The increase is effective in July of each year.

Rollover contributions from other qualified plans are also allowed if certain criteria are met.

The Employer makes a safe harbor non-elective employer contribution to all eligible employees equal to 3% of compensation.

The Employer may also make a discretionary profit-sharing contribution to each eligible employee equal to their compensation multiplied by the contribution percentage, as determined by the Employer. The Employer could decide to give a different contribution percentage to each eligible participant in the Plan. The Plan made a discretionary profit-sharing contribution of approximately \$2 million for the year ended December 31, 2024.

Notes to Financial Statements

The Employer may also make a discretionary matching contribution of up to 6% of compensation each year. The Employer did not make a discretionary matching contribution for the year ended December 31, 2024.

Participants' Accounts and Investment Options

Each participant's account is credited with the participant's pre-tax and Roth contributions, rollover contributions, catch-up contributions, the Employer's contributions and an allocation of net Plan investment earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The investment earnings or losses are allocated to each participant's account in the proportion that the balance of each participant's account bears to the total balance of all participants in each investment option. Participants may direct the investment of their account balances into various investment options offered by the Plan, including a self-directed brokerage account option.

Notes Receivable from Participants

Participants may borrow from their account a maximum equal to the lesser of \$50,000 or 50% of their account balance. The maximum term of the loans is five years, unless used for the purchase of a residence, which may have a longer loan period. The loans are secured by the balances in the participants' accounts and bear interest at rates which are commensurate with local prevailing rates, as determined on the date of issuance, and are fixed for the term of the loan. Principal and interest are paid ratably through payroll deductions.

Vesting and Forfeitures

Participants are immediately vested in their accounts. Any forfeited non-vested amounts, which can result from excess-contributions which are forfeited, may be used to reduce future Employer contributions or pay Plan expenses. For the year ended December 31, 2024, no forfeitures were used to reduce Employer contributions or to pay Plan expenses. The balance of forfeitures at December 31, 2024 and 2023 was \$24,008 and \$17,039, respectively.

Payment of Benefits

Upon death, retirement (age 62), or termination of service, a participant may receive a lump-sum payment in the amount equal to the participant's vested account balance. Balances less than \$1,000 upon a distributable event are disbursed as a lump-sum payment.

The Plan allows participants to receive hardship withdrawals to satisfy certain immediate and heavy financial needs. Certain other in-service withdrawals are also allowed by the Plan if certain criteria are met.

2. Summary of Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Notes to Financial Statements

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. The net appreciation in the fair value of investments consists of the realized gains (losses) and the unrealized appreciation (depreciation) on those investments. Net earnings or losses from the investments in the self-directed brokerage accounts are shown as other income.

Contributions

Employee contributions and related Employer contributions are recognized in the period during which the Company makes payroll deductions from the participant's compensation, and when the amounts are due to the Plan.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Any accrued, but unpaid interest are de minimis. Related fees are recorded as administrative expenses and are expensed as incurred. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefit payments to participants are recorded when paid to participants.

Administrative Expenses

The Employer has full discretionary authority to allocate to participants' accounts any reasonable Plan expenses that are not paid by the Employer. For the year ended December 31, 2024, expenses of \$142,409 were paid by the Plan. Certain other investment management fees in the form of an expense ratio are net with earnings. All other expenses related to administering the Plan were paid by the Company, and are excluded from these financial statements.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the

provisions of ERISA. In the event of plan termination, participants' accounts will be distributed according to the Plan agreement and ERISA.

Concentrations, Risks, and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risk in the near term would materially affect the amounts reported in the statements of net assets available for plan benefits and participant accounts.

At December 31, 2024 and 2023, there was one investment, which individually represented more than 10% of investments held. Refer to the supplemental Schedule of Assets (Held at End of Year) for a complete listing of investments held at December 31, 2024.

3. Information Certified by the Trustee

The Company has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard, a qualified institution, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments (excluding \$6,853,923 and \$5,565,977, respectively, of amounts held in the self-directed brokerage account) and notes receivable from participants as shown in the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023.
- Interest earned on notes receivable from participants, interest and dividend income, and net appreciation in fair value of investments, as shown in the accompanying statement of changes in net assets available for plan benefits for the year ended December 31, 2024.
- Investment amounts, excluding amounts held in the self-directed brokerage account, included in the notes to financial statements.
- Investment amounts in Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, excluding the self-directed brokerage account.

At the request of the Company, the Plan's independent auditors did not perform any auditing procedures with respect to this certified information, except for comparing the certified information to the related information presented and disclosed in the financial statements and supplemental schedule, reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP and whether the supplemental schedule is in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

4. Fair Value Measurements and Disclosures

Accounting Standards Codification (ASC) 820 provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority

to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - These assets are valued at the daily closing price, as reported by the fund or security. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trust - The Vanguard Retirement Savings Trust III (the RS Trust) is a collective investment trust fund sponsored by Vanguard. The RS Trust's objective is to protect principal while providing a higher rate of return than shorter maturity investments, however, there is no assurance this objective can be met. The RS Trust is composed primarily of fully benefit-responsive investment contracts. The RS Trust is valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. This investment is a direct filing entity.

Self-Directed Brokerage Accounts - These accounts are comprised of common stock, exchange traded funds, money market mutual funds, government securities, and registered investment companies. Common stock and exchange traded funds (ETFs) are valued at the published market price on an active market. Registered investment companies (mutual funds) and money market

mutual funds are valued at the NAV that is quoted on an active market and is determined based on the fair value of the underlying assets at the end of each day. Government securities are generally valued at the bid and ask price. Prices are based on pricing models, quoted prices of securities with similar characteristics, or broker quotes.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Income Taxes

The Plan has adopted a Vanguard pre-approved profit-sharing plan document. The pre-approved profit-sharing plan document received an Internal Revenue Service (IRS) opinion letter, dated June 30, 2020, that the form of the pre-approved plan, as then designed, was acceptable under Section 401 of the IRC and, therefore, exempt from federal income taxes under the provisions of Section 501(a) of the IRC. The Plan administrator believes that the Plan, as amended and restated, is designed and currently being operated in compliance with the applicable provisions of the IRC, and the Plan and related trust continue to be tax-exempt; therefore, no provision for income taxes has been included in the accompanying financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Related Party and Party-in-Interest Transactions

Vanguard is the recordkeeper and trustee, as defined by the Plan. The Plan holds various investments in Vanguard mutual funds and a collective investment trust as offered as investment options of the Plan and also held within the self-directed brokerage account. Transactions with Vanguard funds qualify as party-in-interest. Fees of \$142,409 were paid to the recordkeeper, trustee, auditor and investment advisor out of Plan assets during 2024. Certain other investment management fees may be paid by the Plan in the form of an expense ratio and are shown net of earnings. The Plan also issues loans to participants, which are secured by the vested balance of the participants' accounts. These transactions are party-in-interest transactions, which are exempt from the prohibited transaction rules.
