Report on the Financial Statements

Opinion

We have audited the accompanying financial statements of PNM Resources, Inc. Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for purpose of expressing an opinion on the effectiveness of PNM Resources, Inc. Comprehensive Health Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about PNM Resources, Inc. Comprehensive Health Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

(1) Plan Description

General

The PNM Resources, Inc. Comprehensive Health Plan (the “Plan”) is a welfare benefit plan that provides benefits to eligible employees of TXNM Energy, Inc. (“TXNM”), formerly PNM Resources, Inc. (“PNMR”) and participating subsidiaries (collectively, the “Company”). The Plan was adopted as of January 1, 2004 to provide benefits through the following programs:

- Medical program
- Dental program
- Vision program

Benefits provided under the Plan are paid by the Company directly and funded through participant premiums and Company contributions. The Plan is subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. Eligible employees consist of full-time employees regularly scheduled to work at least 32 hours per week; or part-time or job-share employees regularly scheduled to work at least 20 hours per week; and, employees covered by a collective bargaining agreement if the collective bargaining agreement provides for participation in the Company's medical, dental, and vision plans. Information about the benefit provisions is contained in the employee's Summary Plan Description available from the Company's Benefits Department. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan covers medical, dental, and vision coverage for deceased employees' dependents for six months after the eligible employees' death.

Plan Benefits

The Plan provides medical, dental, and vision benefits to participants and to their beneficiaries and covered dependents. Medical claims of active participants, dependents, and beneficiaries are self-insured programs funded by participant paid premiums and employer contributions. Medical claims of participants, dependents and beneficiaries are processed by either Presbyterian Health Plan or Blue Cross Blue Shield of New Mexico and ExpressScripts, for prescriptions. Dental claims are processed primarily by the Delta Dental Plan of New Mexico (“Delta”) and are also self-insured and funded by participant premiums. Vision claims are processed by Vision Service Plan and are fully-insured by participant premiums.

Claims are processed in accordance with the Patient Protection and Affordable Care Act (“PPACA”) and the Health Care and Education Reconciliation Act of 2010. The Plan is not financially impacted by the PPACA as it does not qualify for the Medicare Part D subsidy.

Contributions and Funding Policy

Medical, dental, and vision benefits are funded by employer and participant contributions. A participant contributes amounts based on the type of coverage chosen. The Company pays monthly insurance premiums for the dental benefits. The Company contributes amounts to the Benefit Trust necessary to pay current medical and dental benefits to participants in accordance with the Plan provisions.

The Plan established a Voluntary Employee Beneficiary Association in accordance with Section 501(c)(9) of the Internal Revenue Code (the “IRC”) to hold the investments of the Benefit Trust.

Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of the Plan and ERISA.

(2) Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Cash and Cash Equivalents

The Plan considers all highly liquid financial instruments purchased with an original issue maturity of three months or less to be cash equivalents.

Income Recognition

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Benefit Obligations

The total plan benefit obligation amount for year end is actuarially determined based on actual claims incurred and payment patterns. The total plan benefit obligation includes reported medical and dental claims and claims incurred but not reported.

Administrative and Other Expenses

Expenses incurred in processing medical and dental claims are paid to providers by the Plan.

Subsequent Events

GAAP defines subsequent events as events or transactions that occur after the balance sheet date but before financial statements are issued or are available to be issued. Based on their nature, magnitude, and timing, certain subsequent events may be required to be reflected at the balance sheet date and/or required to be disclosed in the financial statements. The Plan has evaluated subsequent events through September 19, 2025.

On May 18, 2025, the Company, TroyParentCo LLC, a Delaware limited liability company ("Parent"), and Troy Merger Sub Inc., a New Mexico corporation and a direct subsidiary of Parent ("Merger Sub"), entered into an Agreement and Plan of Merger (the "Merger Agreement"), pursuant to which Merger Sub will merge with and into TXNM (the "Merger"), with TXNM surviving the Merger as a direct wholly-owned subsidiary of Parent. Parent and Merger Sub are affiliates of Blackstone Infrastructure Partners L.P. ("BIP"). The Merger is subject to certain regulatory approvals, including from the New Mexico Public Regulatory Commission. Additional details related to the Merger can be found in the Company's Current Report on Form 8-K filed on May 19, 2025. The Company is currently unable to determine the full extent of the impacts that the Merger will have on the Plan.

(3) Tax Status

The Internal Revenue Service ("IRS") issued a favorable determination letter which states that the Plan and the related trust are designed in accordance with the applicable sections of the IRC. Therefore, the Plan's net investment income is exempt from

income taxes. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

GAAP requires the Plan to evaluate tax positions and recognize tax assets (liabilities) for uncertain tax positions that more likely than not would not be sustained upon examination by the IRS. The Plan has no uncertain tax positions taken or expected to be taken as of December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions.
