Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of GBA Companies Corporate Services, LLC Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of September 30, 2024 and 2023, and for the year ended September 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

Note 1. Plan Description

The following description of GBA Companies Corporate Services, LLC Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan was previously named George Butler Associates, Inc. Profit Sharing Plan and effective January 1, 2025 was changed to GBA Companies Corporate Services, LLC Profit Sharing Plan.

General: The Plan is a defined contribution profit sharing and 401(k) plan, which covers all employees of George Butler Associates, Inc. (the Plan Sponsor), GBA Builders, LLC, GBA Systems Integrators, LLC, GBA Companies Corporate Services, LLC, Infrastructure Solutions, LLC, Alynix, LLC, Compli, LLC and ViroCon, Inc. (collectively, the Company). The Profit Sharing Committee of the Board of Directors of the Company, in consultation with the Plan's investment advisor, control and manage the operation, administration of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Employees may contribute up to 50% of their pretax compensation, as defined in the Plan, subject to certain Internal Revenue Code (IRC) limitations. Part-time as-needed employees (defined as working less than 20 hours per week) and temporary employees are not eligible to contribute to the Plan. Employees that are members of a collective bargaining agreement are excluded from participating in the Plan. Employees entering the Plan are automatically enrolled at a 7% deferral rate if no contrary election is made during the 30-day opt-out period. Employees are enrolled in the Plan the pay period following their election to participate or the pay period following their automatic enrollment.

All employees who are eligible to make elective deferrals under the Plan and have attained age 50 shall be eligible to make catch-up contributions in accordance with the Plan document. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans and Roth elective deferrals, as defined in the Plan.

Each pay period, the Company will make a fixed matching contribution equal to 50% of the participant's elected deferral, up to 7% of eligible compensation. For the year ended September 30, 2024, the Company made a matching contribution of \$1,704,726.

In addition, the Plan provides that the Company can contribute, annually, a discretionary profit sharing contribution amount, which is an equal dollar amount to all eligible employees. Employees must be employed by the Company on the last day of the plan year in order to receive the Company discretionary profit sharing contribution. If an employee incurs a separation in service during the plan year on account of death, disability or normal retirement age, they will still receive the Company discretionary profit sharing contribution. An employee does not have to be a participant to receive the Company discretionary profit sharing contribution. For the year ended September 30, 2024, the Company made a discretionary profit sharing contribution of \$254,030.

Participant accounts: Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's fixed matching contribution, allocations of Company discretionary profit sharing contributions, forfeitures of terminated participants' nonvested accounts and Plan earnings, and is charged with withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1. Plan Description (Continued)

Investment options: Participants direct the investment of their contributions and the Company contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, pooled separate accounts and common collective trusts as investment options for participants. Participants may change their investment options anytime throughout the year via direct dial or web access.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's fixed matching and discretionary profit sharing contributions portion of their account plus earnings thereon is based on a graduated vesting schedule. Participants with one year of service are 30% vested. Participants with two years of service are 60% vested. A participant is 100% vested after three years of service. An employee must complete at least 1,000 hours of service during a plan year to receive credit for one year of service.

Notes receivable from participants: Subject to the approval of the Third-Party Administrator based on the Plan provisions, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant is limited to two outstanding loans at one time. Loan terms range up to five years or up to 10 years for the purchase of the participant's principal residence. These transactions are treated as transfers between the investment fund and the participant notes receivable fund. The notes receivable are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing interest rates as determined by the Plan Administrator. The interest rate ranged from 3.25% to 8.50% for all outstanding notes at September 30, 2024. Principal and interest are paid ratably through biweekly payroll deductions.

Payment of benefits: On termination of service due to death, disability, retirement or termination, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or monthly, semiannual or annual installments. If a participant's vested balance is less than \$7,000, the account balance must be distributed as a lump sum as soon as administratively possible after separation from service. Participants with a balance greater than or equal to \$1,000 but less than \$7,000 are forced to roll over their accounts outside the Plan. Participants with a balance less than \$1,000 receive a cash distribution from the Plan. If the account balance is \$7,000 or greater, distributions can be paid under one or more of the optional forms available under the Plan, or the account balance may remain in the Plan.

In-service withdrawals: A participant may withdraw all or a portion of his or her vested account balance once he or she attains age 59½. The Plan also allows for participants to withdraw a portion of his or her account balance if they incur a financial hardship. A distribution may be made from the participant contributions account and the vested portion of the Company contributions account.

Forfeitures: At September 30, 2024 and 2023, forfeited nonvested accounts totaled \$27 and \$10,123, respectively. Forfeitures may be used to pay Plan expenses, reduce future Company contributions or be reallocated to participants as additional employer contributions. For the year ended September 30, 2024, \$112,703 of forfeited nonvested accounts were used to reduce Company contributions.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements are prepared on the accrual basis of accounting.

Contributions: Contributions from Plan participants and the related matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation. The discretionary profit sharing contribution is recorded in the year in which participant compensation is earned.

Note 2. Summary of Significant Accounting Policies (Continued)

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Profit Sharing Committee determines the Plan's valuation policies utilizing information provided by investment advisors and the trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Allowance for credit losses: The Plan adopted Accounting Standards Codification (ASC) 326, Financial Instruments—Credit Losses, as of October 1, 2023, with the cumulative-effect transition method with the required prospective approach. The measurement of expected credit losses under the current expected credit loss (CECL) methodology is applicable to financial assets measured at amortized cost, which include employer and participant contributions receivables. An allowance for credit losses under the CECL methodology is determined using the loss-rate approach and measured on a collective (pool) basis when similar risk characteristics exist. Where financial instruments do not share risk characteristics, they are evaluated on an individual basis. The CECL allowance is based on relevant available information, from internal and external sources, related to past events, current conditions and reasonable supportable forecasts. Management provided for no allowance for credit losses as of September 30, 2024, as all amounts were determined to be fully collectable.

Prior to the adoption of ASC 326, the Plan maintained an allowance for doubtful accounts to reserve for potentially uncollectable receivables. Management provided no allowance for doubtful accounts as of September 30, 2023, as all amounts were determined to be fully collectable.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses, and are expenses when they are incurred. If a participant ceases to make the scheduled repayments and the Plan Administrator deems the participant to be in default, the participant's note receivable is reduced and a benefit payment is recorded based on the terms of the Plan. No allowance for credit losses have been recorded as of September 30, 2024 and 2023.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, part IV, line 4i—schedule of assets (held at end of year).

Expenses: Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment-related expenses are included in net appreciation of fair value of investments.

Payment of benefits: Benefit are recorded when paid. There were no withdrawals approved but not yet paid as of September 30, 2024.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quotes prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are observable and significant to the fair value measurement.

Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts: (a) The common collective trusts are valued at the NAV of the underlying investments based on the audited financial statements of the common collective trusts. (b) The common collective trusts are valued based on the NAV of units of the common collective trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Pooled separate accounts: Pooled separate accounts are valued at NAV per share based on quoted market prices of underlying investments as of the Plan year-end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Note 5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Note 6. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their Company fixed matching and discretionary profit sharing contributions.

Note 7. Income Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10. Prohibited Transactions

During the year ended September 30, 2022, the Plan Sponsor inadvertently failed to deposit \$548 of loan payments within the required time frame as stated by the DOL regulations. Lost earnings related to this late deposit were calculated and remitted into the Plan in 2024. The Plan Sponsor filed Form 5330 and paid the applicable excise tax to the IRS. The correction and excise tax payment was made from the Plan Sponsor's assets and not from the assets of the Plan.

Note 11. Subsequent Events

Management has evaluated and disclosed subsequent events up to and including September 23, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, Alynix, LLC was removed as an adopting employer in the Plan. The plan assets related to Alynix, LLC were transferred to a separate plan effective January 1, 2025.
