### **Note 1 – Plan Description and Basis of Presentation**

The following description of the SCS Engineers 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**Eligibility and Coverage** – The Plan was established on July 1, 1997 and was amended and restated as of February 2023. The Plan is a defined 401(k) profit sharing plan covering all eligible employees of Stearns, Conrad and Schmidt Consulting Engineers, Inc. (the “Company” and “Plan Sponsor”) who are age eighteen or older. Participants, once eligible, may begin deferring a portion of their compensation into the Plan on the first day of the month following the satisfaction of eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and Section 401(a) of the Internal Revenue Code (IRC). The Administration Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

**Contributions – Participants** – Participants can contribute up to 90% of their eligible salaries, in 2024, not to exceed \$23,000. Participants ages 50 or older may elect to defer additional amounts (called “catch-up” contributions) to the Plan. The maximum “catch-up” contribution that could be made in 2024 was \$7,500. The additional amount can be deferred regardless of any other limitations on the amounts that can be contributed to the Plan. Participants also have the option to make elective after-tax contributions to a Roth 401(k). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (“rollover”).

**Employer** – For the year ended December 31, 2024, the Company matches 50% of employee contributions, up to a maximum of \$1,000 per participant per Plan year. Contributions are subject to certain Internal Revenue Service limitations. During the year ended December 31, 2024, the Company’s contributions totaled approximately \$1,125,000

The Plan includes an auto-enrollment provision whereby all newly eligible participants are automatically enrolled in the Plan unless affirmatively elect not to participate in the Plan.

The Company permits participants to contribute to a Roth 401(k). Roth 401(k) contributions are not tax deductible for the participants. The Roth 401(k) has the same provisions for maximum deferral amount and employer match as mentioned above.

All contributions made on a participant’s behalf are deposited in the trust and allocated among the investment funds in accordance with the participant’s investment elections. A participant may elect to transfer investments from any investment fund to any other investment fund on a daily basis.

### **Note 1 – Plan Description and Basis of Presentation (Continued)**

**Participant Accounts** – Each participant’s account is credited with the participant’s contributions and allocations of the Plan Sponsor’s contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting** – Participants are immediately vested in their contributions and related investment activity thereon. Participants vest in plan sponsor contributions at 10% after the first year, 25% after the second year and in annual ratable installments of 25% until fully vested after five years of service. Participants are fully vested in the event of death, disability, or attaining normal retirement age (age 65).

**Forfeitures** – If a participant terminates prior to vesting 100% in the employer contributions, the forfeited balance will be used to reduce administrative expenses and future employer contributions. In 2024, there were no administrative expenses reduced from forfeited non-vested accounts and employer contributions were reduced from forfeited non-vested accounts by \$171,462. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,209 and \$27,227, respectively.

**Payment of Benefits** – The Plan provides for the payment of benefits to the participant (or, if applicable, the beneficiary) at retirement, disability, death, financial hardship, or termination of employment. In-service distributions are also available to those participants who are disabled or are age 59½ or older. Participants who qualify for retirement benefits and withdrawals will receive their benefits as a lump sum in cash, installment payments, or partial withdrawals. The benefit to which a participant is entitled is the benefit that can be provided solely from the participant’s vested account balance. Participants who separate from service and have vested account balances of \$7,000 or less are subject to an administrative lump sum distribution.

**Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan repayment terms shall be no greater than five years except when loan proceeds are used for the purchase of a primary residence. The loans are secured by the vested balance in the participant’s account and bear interest at variable rates. At December 31, 2024, outstanding loans had interest rates ranging from 4.25% to 9.50%. Principal and interest is paid semi-monthly over the term of the loan through payroll deductions.

**Administrative Expenses** – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Note 2 – Summary of Significant Accounting Policies**

**Basis of Accounting** – The accompanying financial statements are prepared on the accrual basis of accounting under accounting principles generally accepted in the United States of America.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition** – Investments are stated at fair value as determined by Fidelity Management Trust Company. Mutual funds are valued based on the quoted market prices on the last business day of the plan year. The carrying value of interest bearing money market accounts equal their fair value. Increases or decreases in fair value are recognized currently. Plan management determines the Plan’s valuation policies utilizing information provided by the investment advisors and custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. In the event payment is more than three months delinquent, the note is considered to be in default.

**Payment of Benefits** – Benefits are recorded when paid.

**Risk and Uncertainties** – The Plan provides for various investment securities. These investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with these securities and the level of uncertainty related to changes in value, it is at least reasonably possible that changes in the various risk factors in the near term would materially affect participants’ account balances and the amounts reported in the accompanying financial statements.

### **Note 3 – Trustee Certification**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

### **Note 4 – Fair Value Measurements**

The accounting standards regarding fair value measurements define fair value, establish a framework for measuring fair value, and provide for enhanced disclosures about fair value measurements. Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The standard describes three levels of inputs that may be used to measure fair value:

- Level 1 Valuation is based upon quoted prices in active markets for identical securities.
- Level 2 Valuation is based upon other observable inputs (including quoted prices for similar securities, interest rates, prepayment speeds, credit risk, etc.).
- Level 3 Valuation is based upon unobservable inputs significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in methodologies used at December 31, 2024 and 2023.

#### *Mutual Funds*

These are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money Market Fund*

These are valued at the net asset value of shares held by the Plan at year end (generally \$1 per share).

*Self-Directed Brokerage Account*

The Self-Directed Brokerage Account is reported at fair value. For the majority of Self-Directed Brokerage Accounts the Plan receives prices from a nationally recognized pricing service that are based on observable market transactions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Below are the Plan's financial instruments carried at fair value on a recurring basis by the fair value hierarchy levels established in current accounting standards.

## **Note 5 – Related Party Transactions**

Certain Plan investments are shares of mutual funds managed by affiliates of Fidelity Management Trust Company. During the year ended December 31, 2024, administrative fees in the amount of approximately \$52,000 were paid by the Plan. Fidelity Management Trust Company is a custodian and Strategic Advisors, Inc. is an investment advisor as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Transactions involving participant loans also qualify as party-in-interest transactions.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan Sponsor pays directly any other fees related to the Plan's operations.

## **Note 6 – Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants' rights to their accrued benefits are non-forfeitable.

## **Note 7 – Income Tax Status**

The Plan has adopted the provisions of a volume submitter 401(k) plan. The Plan obtained its latest opinion letter from the Internal Revenue Service dated June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **Note 8 – Subsequent Events**

The Plan Sponsor has evaluated subsequent events through September 23, 2025, the date which the financial statements were available to be issued. Management's evaluation of subsequent events has determined that there were no events that require additional disclosures.
