Independent Auditor's Report

To the Plan Administrator and Participants
Glaukos Corporation 401(k) Profit Sharing Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Glaukos Corporation 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Glaukos Corporation 401(k) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

1. Description of Plan

The following description of the Glaukos Corporation 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

a. General

The Plan was established January 1, 2002 by Glaukos Corporation (the "Company") as a defined contribution plan under the provisions of section 401(a) of the Internal Revenue Code ("IRC"), which includes a qualified cash or deferred arrangement as described in section 401(k) of the IRC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Fidelity Management Trust Company ("Fidelity") serves as trustee of the Plan. The Plan is administered by the Company as the Plan sponsor.

b. Eligibility

Employees of the Company are eligible to participate in the Plan and make elective deferrals and become eligible for matching contributions upon reaching 21 years of age and completing one month of service, except nonresident aliens, and employees covered by a collective bargaining agreement. Participants enter the Plan on the first day of the month coinciding or following the date the employee meets the eligibility requirements.

c. Contributions

All employees of the Company meeting the eligibility requirements are automatically enrolled with a 4% deferral rate, unless the participant affirmatively elects otherwise. Participants may contribute up to 80% of their eligible compensation to the Plan, subject to the Internal Revenue Service ("IRS") limits. The Plan also allows rollover contributions from other qualified plans. Upon reaching the age of 50, eligible employees may make additional catch-up contributions as allowed by the IRC.

The Company may make discretionary matching and discretionary non-elective contributions to the Plan. Employees must complete 501 hours of service and be employed on the last day of the Plan year to receive a discretionary non-elective contribution. For the years ended December 31, 2024 and 2023, the Company made discretionary matching contributions of 50% of the first 6% deferred by participants into the Plan. There were no discretionary non-elective contributions made during 2024 and 2023.

d. Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions, the Company's contributions, and an allocation of the Plan's earnings and

expenses, and are valued on a daily basis. The current benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

e. Vesting

Participants are immediately vested in their elective deferrals and rollover contributions and the net earnings thereon. Participants become 100% vested in employer matching contributions and earnings thereon after three years of eligible service. Participants vest in discretionary non-elective contributions and earnings thereon, 20% after two years of eligible service and 20% for each additional year of eligible service until they are fully vested after six years of eligible service.

f. Investments

Participants direct the investment of their account balances in one or a combination of several investment options offered by the Plan. Participants may change their investment elections or transfer their assets between investments on a daily basis.

g. Forfeitures

Participants who terminate employment forfeit the non-vested portion of Company discretionary contributions and earnings thereon. At December 31, 2024 and 2023, there were approximately \$51,000 and \$15,000 of forfeitures, respectively, available to reduce future Company contributions or pay Plan administrative expenses. During 2024 and 2023, forfeitures totaling approximately \$109,000 and \$261,000 respectively, were utilized to reduce Company contributions.

h. Payment of Benefits

Upon reaching retirement age, termination of service or death, a participant may elect to receive their vested account balance in a lump-sum, substantially equal installments or a partial withdrawal. For balances less than \$1,000, the vested balance of the participant's account can be distributed to the participant at the discretion of the Plan Administrator in a single lump-sum cash payment. For balances over \$1,000 but less than \$5,000, the Plan Administrator can elect to distribute the balance to an Individual Retirement Account on behalf of the participant.

i. Hardship Withdrawals

Upon certain conditions, participants, while still employed by the Company, are permitted to withdraw, in a single sum, a portion of their vested account balance as a result of an immediate and heavy financial need, subject to a \$500 minimum. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of postsecondary education tuition, the payment of burial or funeral costs of immediate family members, the payment of natural disaster clean-up on the participant's principal residence or to prevent eviction or foreclosure from the participant's principal residence.

j. Notes Receivable From Participants

Participants may borrow the lesser of \$50,000 or 50% of their vested account balance, subject to certain other restrictions. Loans are secured by the vested account balance of the participant and bear interest at a rate equal to the prevailing interest rate that would be charged under similar circumstances as determined by the Company. Loans are repaid through payroll deductions over periods ranging up to five years unless the loan is used to acquire a principal

residence, in which case the loan term may be extended for a longer period. The interest rate on outstanding loans at December 31, 2024 ranged from 4.25% to 9.5%, and mature through 2032.

k. Revenue Credits and Administrative Expenses

The Plan entered into an agreement with the trustee whereby the trustee shares certain revenue generated by the Plan in excess of their fee. These deposits are included in other income on the statements of changes in net assets available for benefits and are available to pay Plan expenses or to be reallocated to participants. During 2024 and 2023, revenue credits of approximately \$41,000 and \$30,000, respectively, were allocated to participants who were invested in the funds that received revenue credits based on the balance in these specific funds. At December 31, 2024 and 2023, no revenue credits were available to be reallocated to participant accounts or to pay future Plan expenses.

The Company pays certain administrative expenses of the Plan, including legal, trustee and audit fees. Direct expenses paid by the Plan were approximately \$9,000 and \$8,000 for 2024 and 2023, respectively. Certain expenses are included in the transaction prices of investments bought and sold and are not separately quantifiable. The Plan charges certain loan and distribution fees to the impacted participants.

2. **Summary of Significant Accounting Policies**

a. Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

b. Use of Estimates

The preparation of the financial statements in conformity with GAAP requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Net appreciation in fair value of investments consists of the net change in unrealized gains or losses during the year and the realized gain or loss on investments sold during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

d. Notes Receivable from Participants

Notes receivable from participants are carried at amortized cost plus accrued interest.

e. Payment of Benefits

Benefits are recorded when paid.

3. Investments

The Plan investments are held by Fidelity. Participants can direct their accounts among the various mutual funds and a money market account.

4. Fair Value Measurements

FASB Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, establishes a framework for fair value measurements and disclosures. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds and money market fund: Valued at fair value based on quoted market prices at year end.

5. Risks and Uncertainties

The Plan assets are invested in a variety of investments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, foreign currency and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits, and therefore participant account balances.

6. Information Certified by the Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the financial statements was provided and certified by Fidelity, the trustee, as of December 31, 2024 and 2023 and for the years then ended as complete and accurate:

- Investments, at fair value
- Notes receivable from participants
- Investment income (loss)
- Interest on notes receivable from participants
- Schedule of assets (held at end of year)

7. Party-In-Interest Transactions

Certain Plan investments are managed by Fidelity Investments, an affiliate of Fidelity. Fidelity is the trustee as defined by the Plan. Certain investment fees are paid by the trustee and are reflected in the investment income or loss for the year. The Plan also issues loans to participants that are secured by the vested balance in the participants' accounts. As such, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Additionally, the Plan sponsor, Glaukos Corporation, is a party-in-interest to the Plan; however, there were no transactions with the Plan sponsor other than the funding of contributions to the Plan and payment of certain administrative expenses of the Plan.

8. Tax Status

The Plan was restated effective May 1, 2018 utilizing a Fidelity Volume Submitter Defined Contribution Plan Document which received an opinion letter from the IRS on June 30, 2020, in which the IRS stated that the plan document, as then designed, was in compliance with the applicable requirements of the IRC. Management of the Plan believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust is tax exempt.

Assuming it meets certain initial and ongoing requirements, the Plan is generally exempt from federal and state income taxes. However, GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Plan Termination

Although it has not expressed any intention to do so, the Company may terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
