**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the NZXT 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering all employees of NZXT, Inc. (the “Company”) except employees covered by a collective bargaining agreement, leased employees, nonresident aliens, and interns. Employees are eligible to participate in the Plan on the first day of each month after attaining the age of 21 and completing one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Administration**

Fidelity Management Trust Company (FMTC) is the custodian and trustee of the Plan and Fidelity Workplace Services is the recordkeeper.

**Contributions**

Participants may elect to contribute up to 90% of eligible compensation into the Plan, subject to certain limitations, deferred on a pre-tax and/or after-tax Roth basis. Eligible employees are automatically enrolled in the Plan at a pre-tax salary deferral rate of 3% unless they opt out or elect a different percentage. Automatically enrolled participants’ deferrals will automatically increase 1% annually on April 1<sup>st</sup> until they reach a maximum of 10% unless they opt out or elect a different rate. Participants who have attained the age of 50 before the end of the plan year may make catch-up contributions. The Plan allows rollover contributions from other qualified retirement plans.

The Company may contribute a discretionary matching contribution. During 2024, the Company made a discretionary matching contribution equal to 50% of participant contributions that are up to 6% of eligible compensation on a pay period basis. The Company may also make a discretionary non-elective contribution each plan year for all participants who are employed on the last day of the plan year. The Company did not make a discretionary non-elective contribution for 2024.

The Plan is participant directed and participants may change their contribution rates each pay period and investment options at any time.

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions and Company contributions as well as allocations of Plan earnings. In addition, participants are charged with any applicable administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)**

**Vesting/Payment of Benefits**

Participants are at all times fully vested in their contributions and the appreciation or depreciation thereon. Vesting in the employer discretionary matching and non-elective contributions portions of their accounts plus earnings thereon is based on years of continuous service. Participants vest 25% each year after one year of service and are 100% vested after four years of service. Participants hired prior to November 9, 2022 will continue to be 100% vested in the employer discretionary matching and non-elective contributions. A participant shall be immediately vested upon retirement, death, or termination of employment due to total and permanent disability.

Normal retirement age under the Plan is 59½. Upon a participant's termination or retirement, the vested funds in the participant's account may be distributed in a lump-sum payment. The Plan also allows for age 59½ withdrawals from a participant's vested account balance. Hardship withdrawals are permitted from a participant's vested account.

**Forfeitures**

Forfeitures of nonvested employer contributions may be used to pay plan expenses or reduce employer contributions. The forfeiture balance at December 31, 2024 and 2023 was \$4,221 and \$104, respectively. No forfeitures were used during the year ended December 31, 2024.

**Notes Receivable from Participants**

Plan participants may borrow a minimum of \$1,000 up to a maximum of the lesser of \$50,000, minus the highest outstanding balance of loans in the past 12 months, or 50% of their vested account balance in the Plan. Loans are repaid in level installments through payroll deductions for periods ranging up to five years or 10 years for the purchase of a principal residence. The loans bear interest at reasonable rates and are secured by the participant's vested account to the extent of the principal amount of the loan plus accrued interest. Participants may only have one loan outstanding at any time.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

Plan management has made the determination that the Plan experienced a partial plan termination as a result of employment severances that occurred in 2024 and continued into 2025. In accordance with the Plan document and applicable regulations surrounding the event of a partial termination, participants affected by the event became 100% vested in all amounts credited to their accounts regardless of the affected participant's vested percentage under the Plan.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investments**

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are reflected on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants and the Company discretionary matching contributions are recorded in the plan year in which the participant contributions are withheld from compensation.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to financial advisory, recordkeeping, withdrawals, and certain investment transaction fees are charged to participants' accounts and are included in administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

Various inputs are used in determining the fair value of the Plan's investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Level 2* - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

*Level 3* - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Investments measured using the NAV practical expedient are described below:

*Collective Trust Fund:* The collective trust fund is valued at the underlying NAV as provided by the fund manager as a practical expedient to determine fair value. The fund seeks stability of principal by investing mainly in investment contracts or similar investments issued by insurance companies, banks, and other financial institutions. The collective trust fund held by the Plan provides for daily redemptions by the Plan with no advance notice requirement. The Plan has no unfunded commitments and no contractual obligations to further invest in the fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in the methodologies used at December 31, 2024 or 2023.

**NOTE 4 - INFORMATION CERTIFIED**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, FMTC, the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, and the related investment income and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**NOTE 5 - TAX STATUS**

The Plan has adopted a non-standardized pre-approved plan which obtained its latest opinion letter dated June 30, 2020 in which the Internal Revenue Service (IRS) stated that the document satisfies the applicable provisions of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are in mutual funds, managed by entities affiliated with FMTC. FMTC is the trustee as defined by the Plan and, therefore, qualifies as a party in interest. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan provides for various investments. In general, such investments are exposed to various risks such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 - DELINQUENT CONTRIBUTIONS**

During 2024, 2023, and 2022 there were unintentional delays by the Company in submitting participant contributions to the Plan totaling \$71,841, \$105,183, and \$1,190, respectively. The Company corrected \$1,114 of the delinquent contributions in 2024 and intends to compensate the affected participants for any lost earnings resulting from the remaining delinquent contributions in 2025.

**NOTE 9 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through September 10, 2025, the date the financial statements were available to be issued.
