We are the Accountants for the Chapter 7 Bankruptcy Trustee of Art Supply Enterprises, Inc. (“ASE” or the “Debtor”), the Sponsor of the Art Supply Enterprises, Inc. 401(k) Profit Sharing Plan (the “Plan”). The Debtor filed for protection under Chapter 7 of the United States Bankruptcy Code on August 8, 2025, at which time Ricardo Palacio Esq. was appointed as the Chapter 7 Trustee. All operations and contributions to the Plan ceased during 2025, and the Trustee is in the process of winding down the Debtor’s affairs.

As a result of the Chapter 7 bankruptcy proceeding, and pursuant to 11 U.S.C. Sect. 704(a)(11), the Trustee is responsible for the liquidation of the Plan Assets of the Plan.

The 2024 annual informational return was prepared from the best information available; that is, data provided by the Plan’s Record Keeper and Plan Asset Custodian, Principal Financial Group (“Principal”), and payroll information provided by the Debtor to Principal. Due to the cessation of business and the filing of bankruptcy, certain key financial records, subsidiary ledgers and documentation supporting various policies, transactions, and other matters that would normally be expected to be present in an operating enterprise, were missing or unavailable.

This Plan requires audited financial statements, but as a result of the bankruptcy, the bankruptcy estate does not have funds to pay for the audits (nor may the bankruptcy estate pay such costs), and thus Plan expenses must be paid from Plan Assets. In an effort to minimize costs and preserve participants’ funds, the annual audits will not be prepared. Given that the Plan is terminating and all funds are being distributed to participants, the Trustee and Bederson believe that not preparing audits is in the best interests of the Plan’s participants. In addition, as a result of the bankruptcy the records required to complete the audits are limited. Accordingly, due to lack of information caused by the bankruptcy and the need to preserve Plan Assets for participants’ benefit, the annual audits will not be prepared or attached to this Form 5500, and no audits will be prepared going forward.

The period of this return pre-dates the appointment of the Trustee and his professionals. Neither the Trustee, nor the Trustee’s Accountants have any direct knowledge of the transactions recorded by the Debtor and Principal as reported on this return. In addition, the Trustee and his professionals have no knowledge of the processes used or policies put in place by the Debtor or Principal.

The Trustee, by his signature on the face of this informational return, has relied on Principal’s expertise in preparing the return from the available records, which were limited due to the entity's cessation of business. However, it is our qualified opinion that this is a complete return based on the financial information available.
