**INDEPENDENT AUDITOR'S REPORT**

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Legacy Partners Realty Inc Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits – modified cash basis for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with modified cash basis of accounting, as described in Note 2 to the financial statements.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. ## **Emphasis of Matter – Basis of Accounting**

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of Legacy Partners Realty Inc (Legacy) Retirement Plan (the Plan), formerly Legacy Partners Retirement Plan, provides only general information. Participants should refer to the Plan document or Summary Plan Description for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees, except union and nonresident aliens (as defined by IRS), of Legacy Partners Realty Inc., formerly Legacy Partners, Inc., who have three months of service and are age 21 or older for all contribution types. The Plan, adopted in 2014 and restated in 2021 and 2024, is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may currently contribute annually up to 90% of eligible compensation, as defined in the Plan document. The maximum participant contribution to the Plan allowed for participants under the age of 50 was \$23,000 and 22,500 for 2024 and 2023, respectively, and for participants aged 50 and over was \$30,500 and \$30,000 for 2024 and 2023, respectively. These limits are set forth by the Internal Revenue Service and may vary to reflect changes in the Consumer Price Index. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan also allows participants to make designated Roth contributions on an after-tax basis. Effective March 2024, the Plan allows participants to make voluntary, non-deductible, after-tax employee contributions up to \$44,440 with a 30% limit of salary.

Legacy may contribute annually a discretionary matching contribution equal to a uniform percentage of a participant's contribution. Legacy elected to contribute 100% of a participant's contribution up to a maximum of \$1,560 annually for 2024 and 2023. Effective October 1, 2016, Legacy added a discretionary profit sharing contribution provision to the Plan, covering eligible participants who are actively employed on the last day of the Plan year. There was no profit sharing contribution made for the years ended December 31, 2024 and 2023.

Participant Accounts

Participant accounts are credited with participant contributions, employer contributions, and earnings thereon, and are charged with an allocation of administrative expenses, unless paid by Legacy. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and earnings thereon. Employer contributions and earnings thereon are based on years of service. Participants are 100% vested after four years of service.

Investment Options

The Plan's investments are held by Fidelity Management Trust Company (Fidelity). Upon enrollment in the Plan, a participant may direct his or her account to be invested in various investment options offered by the Plan.

These investment options have been approved by the plan administrator. A participant may change his or her investment election for future contributions, or transfer existing balances, from one fund to another by following procedures established by Fidelity. Fidelity also maintains certain records for the Plan and participant accounts and provides certain other administrative services.

Notes Receivable from Participants

Participants may borrow an amount from \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the participant's vested account and bear interest at rates ranging from 4.25% to 9.50% as of December 31, 2024 and 2023, as determined by Fidelity. Loan payments are made by bi-weekly payroll deductions over a term generally not exceeding five years.

However, loans made for the purchase of a principal residence may exceed five years. The maximum permissible number of loans outstanding at any time is one per participant.

Notes receivable from participants, secured by participant account balances, are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan. The outstanding participant notes receivable as of December 31, 2024 and 2023 were \$471,724 and \$378,756, respectively.

Benefit Payments

On termination of service for any reason, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or substantially equal installments over a period of time. The Plan also provides for hardship withdrawals to current employees under certain circumstances.

Forfeitures

Any forfeitures of employer contributions and earnings thereon due to a participant's withdrawal from the Plan prior to being 100% vested are applied first to pay any Plan administrative expenses and then to employer matching contributions that would otherwise be made to the Plan. Forfeited non-vested employer contributions were \$23,672 and \$16,082 for the years ended December 31, 2024 and 2023, respectively. Forfeitures applied to administrative expenses and employer contributions were \$29,594 and \$15,940 for the years ended December 31, 2024 and 2023, respectively.

Plan Termination

Although it has not expressed any intent to do so, Legacy has the right to discontinue contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of termination, participants would become 100% vested in their employer contributions and earnings thereon.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The Plan prepares its financial statements under the modified cash basis of accounting. Contributions and investment income are generally recorded when received rather than when earned, and benefits and administrative expenses are recognized when paid rather than when the obligation is incurred.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Under generally accepted accounting principles, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Generally accepted accounting principles establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to observable inputs (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy based on inputs are as follows:

Level 1 – Valuations are based on unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access and therefore do not entail a significant degree of judgment.

Level 2 – Valuations are based on significant inputs that are observable, either directly or indirectly, or quoted prices in markets that are not active, that is, markets in which there are few transactions, the prices are not current or price quotations vary substantially over time or among market makers.

Level 3 – Valuations are based on inputs that are unobservable and significant to the overall fair value measurement and therefore require more judgment.

There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for investments measured at fair value:

Registered Investment Companies (Mutual Funds):

The fair value of mutual funds is based on the net asset value per share of each fund held by the Plan at year-end. Such investments are categorized as Level 1 of the fair value hierarchy.

Collective Investment Trust:

Reliance Trust Company Stable Value Employee Benefit Investment Trust, Reliance Trust New York Life Anchor Account – Series I (the Trust) invests in New York Life Group Annuity Contract (the Contract), issued by New York Life Insurance Company (New York Life) to Reliance Trust Company (the Trustee). The Contract is the primary underlying investment for the Trust. The Contract is administered by New York Life and is managed by New York Life and the Trustee. The Plan’s investment in the Trust consists of units that are valued at the net asset value of the respective units of the Trust. The net asset value is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value could result in a different fair value measurement at the reporting date.

Net appreciation (depreciation) in fair value of investments reflect dividends and realized and unrealized gains and losses during the year.

Net asset value and fair value were equal for all investments held by the Plan at December 31, 2024 and 2023. Additionally, there were no unfunded commitments to purchase investments at December 31, 2024 and 2023. There were no imposed redemption restrictions on participants.

Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events

Management has evaluated subsequent events through September 8, 2025, the date on which the financial statements were available to be issued.

As of December 31, 2024 and 2023, investments consist of shares of mutual funds and units of a collective investment trust. All investments are participant-directed.

**NOTE 6 – TAX STATUS**
