Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Premier Select Sires 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Note 1 – Plan Description

The following description of the Premier Select Sires 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Premier Select Sires, Inc. (the “Cooperative”) who are age 18 or older, except interns. Participants are eligible for all types of contributions after completing six months of service, during which 1,000 hours of service are attained. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Contributions

Each year participants may contribute up to 90% of their compensation, as defined by the Plan, not to exceed the maximum allowable under the *Internal Revenue Code (IRC)*. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans. The Cooperative will make fixed safe harbor contributions of 3% of participant’s compensation. The Cooperative may also contribute a discretionary matching contribution for employees hired on or after January 1, 2006. For 2024, the Cooperative made a matching contribution of 50% of the first 4% of compensation that a participant contributed to the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

Additional amounts may be contributed at the discretion of the Cooperative’s Board of Directors. The Cooperative contributed an additional \$350,450 for the year ended December 31, 2024. In order to be eligible for the allocation of a profit-sharing contribution, the employee must be employed on the last day of the Plan year and have completed at least 1,000 hours of service. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Cooperative’s contributions, an allocation of the Plan earnings, and charged with an allocation of Plan expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately 100% vested in their contributions, and the Cooperative’s Safe Harbor contributions, plus actual earnings thereon. Vesting in the Cooperative’s profit-sharing contributions and matching contributions plus actual earnings thereon is based on years of continuous service. Profit-sharing contributions are subject to a cliff vesting with a participant being 100% vested after 3 years of credited service. A participant is 100% vested in matching contributions after six years of credited service.

Payment of Benefits

Upon termination of service for any reason, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or annual installments not exceeding the life expectancy of

the participant. Effective January 1, 2024, the automatic distribution threshold increased from \$5,000 to \$7,000 in accordance with Secure Act 2.0. In-service withdrawals are generally limited to participants age 59½ or older. Hardship withdrawals are also permitted, subject to the provisions described in the Plan document.

Administrative Costs

Administrative expenses incurred by the Plan may be paid by either the Cooperative or the Plan on a discretionary basis. Fees and expenses were paid by the Plan for the year ended December 31, 2024.

Notes from Participants

Participants may borrow from their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested balance. Loan terms range from one to five years. The loans are secured by the balance in the participant's account and bear interest at market rates as determined by the Plan Administrator. At December 31, 2024, the interest rate on loans ranged from 4.25% to 9.5%. Principal and interest are paid ratably through payroll deductions.

Forfeited Accounts

The forfeited, non-vested employer contribution accounts totaled \$10 and \$857 for December 31, 2024 and 2023. Forfeitures of employer contributions may be used to pay administrative expenses incurred by the Plan or used to offset employer contributions. In 2024, forfeitures of \$5,000 were used to offset employer contributions.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a full discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably

possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes from Participants

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Benefit Payments

Benefits are recorded when paid.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 consists of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

Note 4 – Investment Contracts

The Plan has investments in the New York Life Anchor Account Series I – Class 0 Fund. Included in this fund are traditional and separate accounts guaranteed investment contracts and certain wrapper contracts. The average yield for the fund was approximately 3.73% and 3.86% for 2024 and 2023, respectively. The yield earned by the fund with an adjustment to reflect the actual interest rate credited to participants during 2024 and 2023 was 3.38% and 3.51%, respectively. The objective of the fund is to provide safety of principal and consistency of returns while attempting to maintain minimal volatility. The percentage of contributions allocated to this fund is determined by the participants.

Note 5 – Related Party Transactions

Certain administrative functions are performed by officers or employees of the Cooperative. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Plan participants may direct their investments in funds issued and managed by the Plan Trustee. Investments in funds issued by the Plan Trustee are considered related party transactions. Fees paid by the Plan to related parties amounted to \$49,338 for the year ended December 31, 2024.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Cooperative has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7 – Tax Status

The Plan adopted a non-standardized prototype plan sponsored by ADP, LLC and has not requested a determination letter but rather has relied upon the Internal Revenue Service opinion letter dated October 6, 2020, issued on the prototype plan stating the Plan and related trust are designed in accordance with applicable sections of the *IRC*.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
