## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Stratum Reservoir LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Stratum Reservoir LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting, which is a basis of other than accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than

accounting principles generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Stratum Reservoir LLC 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

#### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statement in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Stratum Reservoir LLC 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

#### Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether

they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting, which is a basis of other than accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

#### NOTE (1) DESCRIPTION OF PLAN

The following description of the Stratum Reservoir LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions:

- A. General - The Plan was formed January 1, 2020 and adopted by Stratum Reservoir LLC (the Company). The Plan is a defined contribution plan covering all employees of the Company and all employees of the Company, with no service requirement. The Plan is a salary reduction plan or 401(k) plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- B. Contributions – Employees are eligible to participate in the Plan as long as they are not union employees, nonresident aliens, or leased employees. Each year, participants may contribute up to 90% (in whole percentages) of eligible earnings, as defined in the Plan. The Plan has an automatic deferral provision of 3% unless the employee opts out in writing. While a participant, the automatic deferral amount will increase by 1% of compensation up to a maximum of 10%. The Company has elected to make matching contributions of 100% of employee elective deferrals that do not exceed 2% of compensation per pay period starting January 1, 2023. Effective July 20, 2024 the matching contribution was increased to 100% of employee elective deferrals that do not exceed 3% of compensation. Participants are automatically 100% vested in employer contributions. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers an investment contract with ADP. Through ADP, assets of the Plan are held and maintained by Reliance Trust Company (Reliance Trust or Trustee), and include a money market fund, common/collective trusts, and registered investment companies as investment options for participants.

Eligible earnings are defined as W-2 wages.

- C. Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of (a) Plan earnings, and (b) administrative expense. Allocations are based on participant earnings applicable to the investment options chosen by each participant or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.
- D. Vesting - Participants are immediately 100% vested in their contributions and rollover contributions made by individual participants plus actual earnings thereon.
- E. Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the respective participant's account and bear interest at a rate of prime plus 1%, as published in the Wall Street Journal on the 14<sup>th</sup> day of the month that is in effect the month in which the loan becomes effective. Principal and interest is paid ratably through payroll deductions, over a period generally not extending beyond five years from the date of the loan. However, if the use of the loan is to acquire a principal residence, it may be repaid within a longer period.

#### NOTE (1) DESCRIPTION OF PLAN (Continued)

- F. Payments of Benefits - On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested account balance or have the balance paid as a direct rollover to another Individual Retirement Account or to another Employer's tax qualified plan. For termination of service for other reasons and for amounts less than \$5,000, a participant must receive the value of the vested interest in his or her account as a lump-sum distribution. Hardship withdrawals are permitted from participant deferrals (excluding earnings), rollovers, and non-elective contributions.

#### NOTE (2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- A. Basis of Accounting - The financial statements of the Plan are prepared using the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (U.S. GAAP). This basis of accounting differs from U.S. GAAP primarily because certain revenue and related assets have been recorded when received rather than when earned and certain expenses and related liabilities have been recognized when paid rather than when the obligations were incurred. The modified cash basis is an accounting method that combines elements of the two major accounting methods, the cash method and the accrual method. The cash method recognizes income when it is received and expenses when they are paid for, whereas the accrual method recognizes income when it is earned (for example, when the terms of a contract are fulfilled) and expenses when they are incurred.

The Plan modified its cash basis financial statements to accrue and record for the following accounts: Notes receivable from participants and Liabilities. All other transactions are recognized as revenue or expense when received or paid in cash, respectively.

- B. Use of Estimates - The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- C. Investment Valuation and Income Recognition - Investments are reported at fair value as determined by the Trustee, using market quotations and other available information. Securities are valued at the last reported sales price on the last business day of the Plan's fiscal year. Net appreciation or depreciation of investments is reported in the Statements of Changes in Net Assets Available for Benefits and consists of the realized gains or losses and the unrealized appreciation or depreciation of these investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

- D. Notes Receivable from Participants - Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by participants' account balances. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Therefore, no allowance for doubtful accounts is recorded.
- E. Contributions - Employee contributions are recorded in the period during which the Company makes payroll deductions from participant earnings.
- F. Payment of Benefits - Benefits are recorded when paid.
- G. Plan Expenses - A participant with a loan is directly charged a processing fee upon origination of the loan. Other administrative costs of the Plan charged by Reliance Trust and ADP are generally paid by the Company. Transactional charges are paid by the Plan.
- H. Concentrations of Credit Risk - The Plan's investments potentially subject the Plan to concentrations of credit risk. The Plan has not experienced any credit losses associated with these instruments.

#### NOTE (4) FAIR VALUE MEASUREMENTS

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Valued at the net asset value of shares held by the Plan at year end.

Money Market Funds - Valued at the net asset value of shares held by the Plan at year end.

Common/collective trusts - Valued based on the values of the underlying investments.

#### NOTE (5) PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provision of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### NOTE (6) PLAN AMENDMENTS

Effective May 1, 2020, the Company ceased making safe harbor contributions to the Plan. Effective December 1, 2022, the Company began making contributions on a plan-year basis. Effective January 1, 2023, the Company began making contributions each payroll period. In addition, eligible earnings were redefined to exclude reimbursements, fringe benefits, and amounts paid during the "determination period".

#### NOTE (7) RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan Sponsor provides the Plan with certain accounting and administrative services for which no fees are charged. Reliance Trust is considered a party-in-interest, as defined by ERISA, since it provides services to the Plan as investment custodian. All compensation to Reliance Trust is exempt from the prohibited transaction rules of ERISA pursuant to ERISA Section 408 because the compensation is reasonable and customary for the services rendered. The indirect compensation paid to Reliance Trust is based on percentages of average daily assets managed.

ADP and ADP-Broker Dealer is considered a party-in-interest because it is the administrator of the Plan. For the year ended December 31, 2024 and 2023 ADP received direct compensation of \$4,884 and \$4,975, respectively, for services rendered from the Plan which is exempt from the prohibited transaction rules of ERISA pursuant to ERISA Section 408 because the compensation is reasonable and customary for the services rendered. The indirect compensation paid to ADP-Broker Dealer is based on percentages of average daily assets managed.

#### NOTE (8) TAX STATUS

The IRS has determined and informed the Company by a letter dated March 31, 2008 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Plan management evaluates tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, no uncertain positions are taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is not subject to income tax examinations prior to 2022.

#### NOTE (9) RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
