**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of Tierra, Inc. (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering all full-time employees of the Company who have one year of service and are age twenty-one (21) or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan’s Board of Trustees. There are three different contribution types available in the plan. The Company, at its discretion, may make a non-elective contribution to the Plan. This contribution is known as the profit sharing contribution. The employee may make an elective contribution known as a 401(k) contribution or salary deferral contribution. The Company will make a required matching contribution to the Plan.

**Contributions**

For 2024, participants may contribute up to \$23,000 of pretax and/or after tax annual compensation, as defined in the Plan. Participants who have attained age fifty (50) before the end of the Plan year are eligible to make catch-up contributions not to exceed \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions as well as Company contributions into various investment options offered by the Plan. The Company contributes one hundred (100%) of the first four (4%) of eligible compensation that a participant contributes to the Plan. The matching Company contribution is invested directly in the investment option chosen by the participant. Additional profit sharing amounts may be contributed at the option of the Company’s board of directors into investment options offered by the Plan at the direction of the participants. During the year ended December 31, 2024, the Company elected not to make a profit sharing contribution to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations. See Note 6 for additional information.

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions and Company matching contributions, as well as allocations of the Company’s profit sharing contribution, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants in the Safe Harbor 401(k) Plan are vested immediately one hundred percent (100%) in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, is based on years of service. See Note 6 for additional information.

Vesting in the Company's profit sharing contribution is based on years of continuous service. A participant is one hundred (100%) vested after six years of credited service as follows:

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or fifty (50%) percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined on the 14<sup>th</sup> of each month, is set at two (2%) percent above the prime rate, as defined. This interest rate is effective for any loan processed as of the 16<sup>th</sup> day of the month. Principal and interest is paid ratably through weekly payroll deductions. See Note 6 for additional information.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. See Note 6 for additional information.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$0, respectively. Future employer contributions will not be reduced as a result of no forfeitures being recorded for year ending December 31, 2024.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting. Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attributable for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The Statement of Net Assets Available for Benefits presents the fair value of the investment contracts as well as the adjustment of the fully benefit-responsive investment contracts from fair value to contract value. The Statement of Changes in Net Assets Available for Benefits is prepared using the contract value basis for fully benefit-responsive investment contracts.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants and matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowances for credit losses have been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. See Note 6 for additional information.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions payable as of December 31, 2024.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through August 15, 2025, the date the financial statements were available to be issued. See Note 11 for additional information.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds, held by the Plan, are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Collective Trust:** The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**Participant Loans:** The fair value of participant loans approximates the amortized cost of the loans because the loans are secured by each respective participant's account balance.

Certain Plan investments are managed by Reliance Trust. Reliance Trust is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions.

Tierra, Inc., the Plan Sponsor, paid certain expenses related to Plan operations and, therefore, these transactions qualify as party in interest transactions.

**NOTE 6 – PLAN TERMINATION**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. On December 16, 2024, the company confirmed its intention to terminate the Plan due to the sale of the Company. The Plan will terminate on February 28, 2025, subsequent to the balance sheet date, and prior to the date the financial statements were available to be issued. The final participant deferral and employer match was processed on payroll ending December 6, 2024, paid on check date December 13, 2024. The participants will become one-hundred percent (100%) vested in their employer contributions. Participants will receive their account balances within two (2) months of the Plan termination date. Participants have the option of receiving their account balances by direct rollover to an Individual Retirement Account (IRA), a direct rollover to another employer plan, or a distribution paid by check, subject to ERISA Rules and Regulations and IRS Code. The participants transferring their employment to the acquiring company will rollover their accounts to RMA Companies 401(k) Plan. The recordkeeper for the new Plan is John Hancock Life Insurance Company (USA). See Notes 1 and 2 for additional information regarding participants with loan balances.

Repayment of outstanding participant loans by payroll deduction will end at the same time as processing of participant 401(k) contributions, which was payroll ending December 6, 2024, paid on check date December 13, 2024. If a participant has an outstanding Plan loan:

1. The loan will become due and payable in full upon termination of employment. The loan can be prepaid in full.
2. If the loan is not repaid, the outstanding loan amount will be deemed defaulted and offset from the participant's account balance upon distribution. The amount of the loan offset is included in the participant's taxable income for the year of the default.

3. The participant can repay their loan balance up until the due date of their tax return in the year following their distribution into an IRA or another qualified plan to avoid taxation. Participants can review the IRS Special Tax Notice to understand the rules on rolling over a loan offset.

ERISA Rules and Regulations, and IRS Code apply.

**NOTE 7 – TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated June 24, 1998, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
