(1) Description of plan

The following description of the Xpert Design & Construction LL 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan covering eligible employees of Xpert Design & Construction, LLC and participating affiliates (the "Company"). The participating affiliates consist of Rickhaus Design, LLC, LDG Asset Mgmt, LLC, Solidago Residential Services, LLC, and LDG Multifamily LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

(b) Eligibility

An employee may become a participant in the Plan on the first day of the third month coinciding with and immediately following attainment of age twenty-one and the completion of three months of service.

(c) Contributions

Participants may contribute the maximum allowable amount under Section 401(k) of the Internal Revenue Code ("IRC"). Each year participants may contribute up to 85% of their annual compensation as defined in the Plan. Participants may also contribute to a Roth and there is no limit on the amount of Roth contributions other than statutory limits. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company makes safe harbor matching contributions to the Plan. The safe harbor match is 100% of the participant's deferrals up to the first 5% of compensation. The Company may make a discretionary profit sharing contribution to the Plan. For the years ended December 31, 2024 and 2023, no profit sharing contributions were made.

Company and participant contributions may not exceed the maximum amount allowable for federal income tax purposes.

(d) Participant accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions, and (b) plan earnings (losses), and is charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

December 31, 2024 and 2023

(e) Vesting

Participants are immediately vested in their contributions and safe harbor matching contributions, plus actual earnings (losses) thereon.

Vesting in the Company's profit sharing contributions portion of their accounts plus actual earnings (losses) thereon is based on years of continuous service as follows:

(f) Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at prime plus 2%. The maximum number of notes receivable from participants outstanding at any one time is one. Principal and interest is collected ratably through payroll deductions.

(g) Payment of benefits

On termination of service for reasons other than death, disability, or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Withdrawals for accounts of \$7,000 or less will be paid as soon as administratively feasible following severance of employment. Participant consent is required for withdrawals from accounts over \$7,000.

(h) Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Notes to the Financial Statements

December 31, 2024 and 2023

(i) Forfeitures

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Company's profit sharing contribution portion of their accounts. At December 31, 2024 and 2023, there were \$1,203 and \$475, respectively, of forfeited nonvested accounts. Nonvested forfeited accounts can be utilized to pay plan expenses or reduce future Company contributions.

(j) Hardship withdrawals

The Plan permits distributions in the event of a hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½, unless certain exceptions apply. Hardship withdrawals are limited to the participant's vested account balance.

(k) Administrative expenses

Certain administrative expenses of the Plan are paid directly by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in in fair value of investments. Fees for the administration of notes receivable from participants are included in administration expenses and charged directly to the participants' accounts.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

(c) Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent notes receivable from participant is recorded as a benefit payment based on the terms of the plan document.

(d) Payment of benefits

Benefits are recorded when paid.

(e) Events occurring after the reporting date

The Company has evaluated events and transactions that occurred between December 31, 2024, and September 22, 2025, which is the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Certain information related to investments presented and disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year), including the fair value of investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest income, and interest income on notes receivable from participants for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company ("Reliance").

(4) Fair value measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

- (i) *Mutual funds*: Valued based on the funds' reported closing net asset values (NAV) of shares by the Plan as of the last business day of the plan year. The mutual funds are deemed to be actively traded.
- (ii) *Self-directed brokerage accounts*: Comprised of common stocks. Valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Excess contributions

Contributions received from participants for 2024 and 2023 are presented net of payments totaling \$18,822 and \$20,813, respectively. These payments, made in February 2025 and February 2024, were issued to certain active participants to return to them excess deferral contributions, as required to satisfy the relevant nondiscrimination provisions of the Plan.

(6) Tax status

The Company adopted a non-standardized profit sharing plan, which received a favorable opinion letter from the Internal Revenue Service ("IRS") on October 6, 2020, which stated that the non-standardized plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain positions that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

(7) Party-in-interest transactions

As described in Note 1, the Plan paid expenses to various service providers which qualify as party-in-interest transactions under ERISA. The Plan holds notes receivable from participants which also qualify as party-in-interest transactions.

(8) Plan termination

Although it has not expressed an intent to do so, the plan administrator has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(9) Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
