Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

DECEMBER 31, 2024 AND 2023

NOTE 1 - DESCRIPTION OF THE PLAN

The Black Angus Steakhouses, LLC Savings and Investment Plan (the “Plan”) was established on January 1, 1989 to provide voluntary retirement benefits and tax-deferred savings opportunities to eligible employees, as defined in the Plan, of Black Angus Steakhouses, LLC (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The assets of the Plan are held in a trust by Reliance Trust Company (the “trustee”).

THE PLAN DOCUMENT INCLUDES DETAILED RULES FOR EACH SITUATION. PARTICIPANTS AND OTHER INTERESTED PARTIES SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

A. Eligibility

Employees are eligible to participate in the Plan after a six-month service requirement and reaching age 21. The Plan will automatically enroll participants with a default deferral rate of 3%.

B. Contributions

The Plan permits each participant to contribute up to the Internal Revenue Code (the “IRC”) annual maximum.

The Company may, at its discretion, make matching and profit sharing contributions. There were no Company contributions during the year ended December 31, 2024.

C. Vesting

A participant is fully vested immediately as to their contributions, rollover contributions and related earnings thereon. Company contributions plus related earnings are vested as follows:

Employees must complete at least 1,000 hours of service to receive a year of vesting service.

D. Benefits

Benefits under the Plan begin when a participant retires, becomes disabled, dies or ceases to be an employee, whichever applies. Normal retirement age is 65. Hardship withdrawals are permitted.

NOTE 1 - DESCRIPTION OF THE PLAN (Continued)

E. Notes Receivable from Participants

At the discretion of the plan administrator, a participant is allowed to borrow a maximum of 50% of his or her vested account balance, up to \$50,000. The minimum loan is \$1,000. Loan terms range from one to five years or up to 15 years for the purchase of a primary residence. All loans must be adequately secured and accrue interest at the prime rate plus 1%.

F. Forfeitures

Forfeitures of terminated participants' non-vested accounts are applied to reduce employer contributions and Plan expenses. There were no forfeitures for the year ended December 31, 2024. Investments as of December 31, 2024 and 2023 include \$12,080 and \$410, respectively, of forfeited funds available for future use.

G. Administrative Expenses

The Plan recordkeeper and directed trustee receives revenue sharing payments from the Plan investments. These payments were used to offset Plan costs for record keeping and investment advisory fees. Certain other fees for participant elective transactions, primarily withdrawal and participant loan administration fees, are charged directly to participants.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

B. Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Actual results may differ from those estimates.

C. Payments of Benefits

Benefits are recorded when paid.

D. Risks and Uncertainties

The Plan provides for investment options in any combination of investment funds offered by the Plan. Plan investments are exposed to various risks such as interest rate, market fluctuations and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in equity markets, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 3 - INCOME TAX STATUS

The Plan has adopted a prototype plan, which has received an opinion letter from the Internal Revenue Service stating that the Plan is designed in compliance with the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the

applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to ERISA and the provisions set forth in the Plan. In the event of plan termination, participants will become 100% vested in their accounts and the net assets of the Plan will be allocated among the participants and their beneficiaries, after payment of any expenses properly chargeable to the Plan, in accordance with the provisions of ERISA.

NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

NOTE 7 - FAIR VALUE MEASUREMENTS

The participants select how their share of Plan assets will be invested among those investment vehicles made available.

GAAP establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Mutual funds and the exchange traded fund are valued at closing market prices. The following tables set forth Plan investments measured at fair value based on the inputs used to value them at December 31:
