NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Century Linen & Uniform, Inc. 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering eligible employees of Century Linen & Uniform, LLC, Century Linen Services, LLC, and Century Linen East, LLC (collectively, the “Company”). Employees are eligible to participate in the Plan after completing six consecutive months of service from the date of employment and attaining the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 90% of eligible compensation subject to Internal Revenue Code limitations. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants have the option of making after-tax Roth contributions to the Plan. Participants may also contribute rollover amounts representing distributions from other qualified plans.

The Company may make discretionary matching contributions. During the years ended December 31, 2024 and 2023, the Company made matching contributions equal to 75% of employee contributions up to 5% of each eligible participant’s compensation as determined by Plan management. For the years ended December 31, 2024 and 2023, the Company made discretionary matching contributions of \$201,226 and \$190,425, respectively.

In addition, the Company has the option of making additional discretionary contributions. Contributions are subject to certain dollar limitations. The Company did not elect to make additional discretionary contributions for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, along with an allocation of (a) the Company’s contributions, and (b) Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances in accordance with terms of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their voluntary contributions, plus actual earnings/(losses) thereon. A participant’s vested interest in each of the Company’s discretionary contributions, if applicable, is based on a graded ratable vesting schedule beginning after an employee has attained two years of service, with 100% vested after six years of continued credited service.

Investment Options

The Plan currently offers twenty-eight (28) mutual fund accounts. Upon enrollment in the Plan, a participant may direct contributions to any of the investment options. Participants may change their investment options and transfer funds amongst investments daily.

1. DESCRIPTION OF PLAN (Continued)

Notes Receivable from Participants

Participants may borrow from their account up to a maximum amount that is equal to the lesser of \$50,000 or 50 percent of their account balance. Loan transactions are treated as a transfer from the investment fund to the participant notes fund. Generally, loan terms range from several months to 5 years. If the loan is used to purchase a primary residence, the loan may be repaid over a reasonable period of time that may be longer than 5 years. The loans are secured by the balance in the participant's account and bear interest at the prime rate of interest plus 1%. Principal and interest are paid ratably through payroll deductions, which cannot be less frequently than quarterly.

Payment of Benefits

On termination of service or separation of service, due to death, disability, or retirement, a participant or their beneficiary will be entitled to receive a distribution of their total vested account balance. The Plan allows for in-service and hardship withdrawals. Benefits will be paid in accordance with terms of the Plan.

Forfeitures

Forfeitures are used to reduce employer contributions or pay plan expenses. As of December 31, 2024 and 2023, the balance of forfeited nonvested accounts available to be used to reduce future employer contributions was \$7 and \$22, respectively. For the years ended December 31, 2024 and 2023, employer contributions were reduced by \$10,991 and \$11,962 from forfeited nonvested accounts, respectively.

Administrative Expenses

The majority of the Plan's administrative expenses are paid by the Plan. The primary administrative expenses incurred for 2024 and 2023 were investment advisory/management fees and professional fees.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are stated at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as accounts payable, with a corresponding reduction to contributions received from participants.

Payment of Benefits

Benefits to terminated participants are recorded when paid.

Financial Instruments Measured at Fair Value

The Plan has financial instruments which are recorded at fair value in the accompanying statements of net assets available for benefits. The Plan makes estimates regarding the valuation of assets and liabilities measured at fair value in the financial statements. These assets and liabilities include the investments in mutual funds.

Fair Value Measurement - Definition and Hierarchy

The Plan uses various valuation techniques in determining fair value and classifies assets into a three level hierarchy based on the nature of the inputs. Level 1 valuations are based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Level 2 valuations are based on inputs, other than quoted prices included within Level 1 that are observable either directly or indirectly. Level 3 valuations are based on inputs that are unobservable and significant to the overall fair value measurement. The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the net asset value of shares held by the Plan at year end based on quoted prices in active markets.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

3. FAIR VALUE MEASUREMENTS

5. PARTY-IN-INTEREST TRANSACTIONS

Reliance is the trustee of the Plan and the custodian of the Plan's assets. As such, transactions involving Reliance and the Plan qualify as party-in-interest transactions.

The Plan allows current employees who are participants to receive loans under specific circumstances. As such, transactions between the participants that have notes receivable to the Plan qualify as party-in-interest transactions.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

7. INCOME TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

8. SUBSEQUENT EVENTS

Subsequent events have been evaluated through September 5, 2025, which is the date the financial statements were available to be issued.
