## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of  
the Intellipro Group Inc. 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Intellipro Group Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Intellipro Group Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Note 1 – Description of Plan

The following description of the Intellipro Group Inc. (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

a. General

The Plan is a defined contribution plan sponsored and administered by Intellipro Group Inc. and was established on September 1, 2014 for the benefit of all eligible employees of the Company. Employees can enroll into the Plan upon employment starts. Generally, the Plan covers all employees of the Company except for employees who are:

- At under the age of twenty-one

The Plan is subjected to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Plan trustees oversees governance of the Plan.

b. Participant Contributions

Every year participants may elect to have 1% to 90% of their compensation (as defined in the Plan) withheld and contributed to their basic account in the Plan, subject to the Internal Revenue Service (“IRS”) pretax contribution limits. Participants may contribute up to \$23,000 for the year ended December 31, 2024. Participants who are age 50 and over may make an additional catch-up contribution of \$7,500. Participants between the ages of 60-63 may contribute a higher catch-up contribution amounting to \$11,250.

The Plan also permits Roth 401 (k) contributions into the Plan. Participants may also make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. All contributions are deposited in the appropriate investment funds in accordance with the participant’s direction and the Plan’s provisions.

c. Company’s Contributions

The Company may at its sole discretion, make matching contributions to all eligible participants at a certain percentage of the participant's elective deferrals at the end of the Plan year. The Company had no contribution to the Plan in 2024.

d. Participant Accounts

Each participant’s account is credited with the participant’s contributions, and allocations of the Company’s profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of any administrative expenses that are paid by the Plan to the extent that not paid by the Company.

d. Participant Accounts (continued)

Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

e. Vesting

Participants are immediately 100% vested in their accounts with respect to participant contributions (including catch-up, Roth and rollover contributions) and earnings thereon.

Vesting in the employer's discretionary contribution, portion of their accounts is based on the following schedule:

f. Rollovers

With the approval of the plan administrator, the Plan may receive any amounts received by an employee as a distribution from another qualified plan provided that the receipt of such amounts does not adversely affect the qualified tax status of the Plan. Participants are fully vested in these amounts.

An aggregate of \$160,856 was rolled into the Plan during the year ended December 31, 2024, and is included in rollovers on the statement of changes in net assets available for benefits.

g. Forfeited Accounts

Forfeitures, if any, will be allocated to Participants in accordance with the applicable formula elected by the employer. Forfeitures can be applied to reduce the employer's matching contribution or administrative expenses payable under the Plan. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$16,606 and \$9,311, respectively. These accounts will be used to reduce future employer contributions. For the year ended December 31, 2024, there were no forfeitures used to reduce employer contribution or administrative expenses.

h. Investment Options

Participants can direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers thirty-seven pre-selected mutual funds. Participants may change their investment options and allocations on a quarterly basis.

i. Notes Receivable from Participants

Participants may borrow from their fund accounts. Each participant may have up to two loans outstanding at any one time, only one of which may be a primary residence loan. Loan fees and interest due are paid by the participants. Minimum loan amount is \$500, a new loan, when added to the outstanding balance of all loans from the Plan, will be limited to 50% of participant's vested account balance to a maximum of \$50,000.

However, the maximum \$50,000 amount is reduced by the excess of participant's highest outstanding balance of loans from the Plan during the one-year period ending on the day before the date of the new loan, over the participant's current outstanding balance of loans as of the date of the new loan.

The maximum repayment period is generally not more than 5 years for a general-purpose loan. If the loan is obtained for the purpose of purchasing a primary residence, the loan will be repaid within a period not to exceed 30 years. The loan will bear interest at the prime rate plus 2%. Principal and interest is paid ratably through each pay period. All loans must be secured by not more than 50% of the participant's vested account balance.

j. Payment of Benefits

Upon separation from service due to termination of employment, death, disability, retirement or attainment of the age of 59½, the participant may receive their entire vested portion in a lump sum. A participant generally has two options concerning the account balance when a distribution is made:

- The participant may elect to roll-over the vested account balance to another qualified retirement plan or to an individual retirement account; or
- The participant may elect to have the vested account balance paid directly to him and income taxes will be withheld accordingly.

If the value of the vested account (minus any rollover contribution account but including any outstanding loan balance) is less than \$5,000 when the participant employment is terminated, the participant will receive a distribution of the entire vested portion of the account balance and the non-vested portion will be forfeited.

The Plan allows for hardship or in-service withdrawals but is subject to the approval of the Plan administrator.

Note 2 – Summary of Significant Accounting Policies

a. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts.

b. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expense when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivables are recorded as benefit payments based on terms of the Plan document.

e. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

f. Payment of Benefits

Benefits are recorded when paid.

g. Excess Contributions Payable

Account payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan did not pass the Actual Deferral Percentage ("ADP") Test for the 2024 plan year. The excess contribution of \$70,736 and \$79,457 were accrued as of December 31, 2024 and 2023, respectively, the Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and 2024, respectively.

h. Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

i. Date of Management's Review of Subsequent Events

The Plan management has evaluated subsequent events through September 19, 2025, the date at which the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- inputs other than quoted prices that are observable for the asset or liability;

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual fund.** Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4 – Related-Party Transactions and Party in Interest Transactions

ADP Company is the record keeper for the Plan, therefore, these transactions qualify as party-in-interest transactions. The Company pays directly for other expenses related to the Plan’s operation.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 6 – Income Tax Status

The Plan obtained its latest determination letter on March 31, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan was amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
