1. Description of the Plan

The following description of the Box N Save of MD, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

- A. General – The Plan is a defined contribution plan covering substantially all employees of Box N Save of MD, Inc (the Company). Employees are allowed to enter the Plan after completing at least one year of service before the last day of the Plan year, and have completed 1,000 hours of service in the first year of employment or upon first calendar year. Participants must also reach the age of 21 to become eligible to make salary deferrals or to receive employer matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company oversees governance of the Plan, the appropriateness of the Plan's investment offerings, and monitors investment performance.
- B. Contributions – Each year, participants may contribute up to 90% of their eligible annual compensation, as defined by the Plan. Effective July 1, 2020, participants may also make after-tax Roth contributions. Effective January 1, 2019, eligible employees are automatically enrolled in the Plan with deferrals at 1%. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make contributions representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and common collective trusts as investment options for participants. The Company may also make discretionary non-elective contributions to the Plan to be allocated to all employees eligible to participate in the Plan. The Company made no discretionary non-elective contributions to the plan for the year ended December 31, 2024. Contributions are subject to certain statutory limitations.
- C. Participant Accounts – Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

- D. Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Participants are vested in the Company’s discretionary non-elective contributions according to the following graduated vesting schedule:

- E. Notes Receivables from Participants – Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant’s account and bear interest at the Prime rate as reported in the *Wall Street Journal* plus 2%. Principal and interest are paid ratably through payroll deductions. At December 31, 2024 and 2023, notes receivable from participants totaled \$59,433 and \$69,114, respectively.
- F. Payment of Benefits – Upon termination of service, retirement, death, disability, or attainment of age 59 ½, a participant or their beneficiary, in the event of death, is entitled to a distribution of their vested account balance, as defined by the Plan agreement. Distributions from the Plan are payable in the form of a lump sum payment. Upon proof, to the satisfaction of the plan administrator, of an immediate and heavy financial need, contributed deferral amounts may be withdrawn for hardship purposes. Distributions are subject to the applicable provisions of the plan agreement. In all cases, certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½. If a participant's vested account balance upon termination is less than \$1,000, and no distribution election is made by the participant, the plan administrator will direct the trustee to process a direct rollover into an individual retirement plan for the benefit of the participant. As of December 31, 2024 and 2023, no amounts were payable to participants who had elected to withdraw from the Plan but had not received such distributions prior to year-end.
- G. Forfeited Accounts – Upon a participant terminating from the Plan, non-vested Company contributions can be used to reduce future Company contributions to the Plan and to pay for administrative expenses of the Plan. As of December 31, 2024 and 2023, there were no forfeited non-vested accounts and no forfeitures were used to reduce the Company’s contributions during the year ended December 31, 2024.

2. Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants – Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management of the Company determines the Plan's valuation policies utilizing information provided by the trustee and the Plan's investment advisor. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Certain expenses to maintain the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments. Fees for the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

4. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1), Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs were used when Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of the mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Common Collective Trust Funds

Valued at the NAV of units of the common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value.

The Plan's policy is to recognize transfers between Level 1 and Level 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no significant transfers between Level 1 and Level 2 or into or out of Level 3.

5. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its participation at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Company's contributions.

6. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore believes that the Plan is qualified, and the related trust is tax-exempt.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, and the level of uncertainty related to changes in the value of such investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
