### Report on the Audit of the Financial Statements

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Retirement Plan for Salaried Employees of Tinius Olsen Testing Machine Company (the Plan) provides only general information. Participants should refer to the Plan document for more complete information.

**General**

The Plan is a noncontributory defined benefit pension plan established in 1973 to provide benefits for eligible employees of Tinius Olsen Testing Machine Company (the Company) who have completed one year of service and are age 21 or older. The Plan excludes leased employees, any employee who is included in a collective bargaining unit, or any individual who is a "payroll service or agency employee" of the Company. The Plan was restated as of January 1, 2015, to comply with tax legislation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. On July 6, 2016, the Board of Directors voted to cease all future benefit accruals and freeze participant entry into the Plan as of July 31, 2016.

The Plan is administered by the Plan administrator. The Plan administrator has overall responsibility for the operation and administration of the Plan. The Plan administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Company's Board of Directors.

**Pension Benefits**

Employees are entitled to annual pension benefits beginning at normal retirement age 65 equal to:

1. two-thirds of 1% of his/her earnings each year as an active member of the Plan after February 1, 1989, and
2. one-half of 1% of the first \$9,000 of his/her earnings plus two-thirds of 1% of his/her earnings as an active member of the Plan in excess of \$9,000 for service after July 1, 1973, but prior to February 1, 1989, and
3. one-fourth of 1% of the first \$9,000 of "average earnings" plus one-half of 1% of "average earnings" in excess of \$9,000 times the number of years of service prior to July 1, 1973, but not service prior to July 1, 1958.

The Plan permits early retirement from ages 55 to 64. The amount of benefit provided for a participant who retires on an early retirement date is based on an actuarially reduced early retirement pension. The Plan also provides a benefit after late retirement, equal to the amount the participant would have received had he retired from service on his normal retirement date, plus for each Plan year that he is a late retirement participant, an additional annuity credit.

**Pension Benefits (Continued)**

Participants become fully vested in the Plan upon attaining normal retirement age or a participant's early retirement date, death, total disability, or upon the completion of seven years of vesting service. Normal retirement age is defined as the older of age 65 or the age of the participant on the date five years after the first day of the Plan year in which his Plan entry date occurred. A participant's early retirement date is the first day of the month on which the participant ceases to be an employee, and has attained age 55, and completed 10 years of vesting service.

**Death and Disability Benefits**

If an active employee dies at age 55 or older, a death benefit equal to the value of the employee's accumulated pension benefits is paid to the employee's beneficiary. Active employees who become totally disabled receive annual disability benefits that are equal to the normal retirement benefits they have accumulated as of the time they become disabled. Disability benefits are paid until normal retirement age, at which time disabled participants begin receiving normal retirement benefits computed as though they had been employed to normal retirement age, with their annual compensation remaining the same as at the time they became disabled.

**Funding Policy**

The Plan's funding policy is for the Company to contribute an amount which will meet or exceed the annual ERISA minimum funding requirement. During 2024, the Company made contributions of \$117,927, which met the minimum funding requirements of ERISA.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with the accounting principles generally accepted in the United States of America (U.S. GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, disclosure of contingent assets, liabilities, and the actuarial present value of accumulated Plan benefits and changes therein at the date of the financial statements. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value.

**Investment Valuation and Income Recognition (Continued)**

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

The Plan's expenses are paid either by the Plan or the Company as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits.

**Subsequent Events**

The Plan has evaluated subsequent events through September 23, 2025, the date the financial statements were available to be issued.

**NOTE 3 ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS**

Accumulated Plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provision for the service employees have rendered. Accumulated Plan benefits include benefits expected to be paid to:

- a) retired or terminated employees or their beneficiaries
- b) beneficiaries of employees who have died
- c) present employees or their beneficiaries

Benefits under the Plan are based on years of service. Benefits payable under all circumstances – retirement, death, disability, and termination of employment – are included to the extent they are deemed attributable to employee service rendered to July 31, 2016.

The actuarial present value of accumulated Plan benefits is determined by an actuary from USI Consulting Group and is the amount that results from applying actuarial assumptions to adjust the accumulated Plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

- a) life expectancy of participants (the Pri-2012 Dataset Table with Scale MP-2021)
- b) retirement age assumptions (normal retirement age of 65 years)
- c) investment return (5.00% for 2024 and 2023)

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. If the Plan decides to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated Plan benefits.

**NOTE 4 CERTIFICATION OF INVESTMENT INFORMATION**

Aetna Life Insurance Company, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 5 FAIR VALUE INVESTMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset and liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The Plan's immediate participation guarantee investment contract with Aetna Life Insurance Company is valued at fair value, which is based on a market value adjustment applied to the book value amount of the annuity guarantee that is available for withdrawal. The market value adjustment factors include maturity period of 7.5 years, contract rate of return, and market yields on U.S. corporate investment grade securities.

Although it has not expressed any intention to so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

**NOTE 6 PLAN TERMINATION (CONTINUED)**

In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

1. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding the Plan termination.
2. Other vested benefits insured by the Pension Benefit Guaranty Corporation (PBGC), a U.S. governmental agency, up to the applicable limitation as discussed below.
3. All other vested benefits; that is, vested benefits not insured by the PBGC.
4. All nonvested benefits

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pension. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the Plan Sponsor and the level of benefits guaranteed by the PBGC.

**NOTE 7 INVESTMENT CONTRACT WITH INSURANCE COMPANY**

In 1973, the Plan entered into an investment contract with Aetna Life Insurance Company (Aetna). Aetna maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Aetna. An annuity allocation account is maintained equal to the amount that would be required to purchase annuities for persons then eligible to receive annuity payments and to provide for any other benefits guaranteed by Aetna. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting rate is based on a formula established by the contract issuer but may not be less than 3.5%. The crediting rate is reviewed on an annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

**NOTE 8 PLAN TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company in a letter dated November 4, 2016, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9 RISKS AND UNCERTAINTIES**

The Plan invests in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions are made and the actuarial present value of accumulated Plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the estimates and assumptions in the near-term would be material to the financial statements.

**NOTE 10 PARTY-IN-INTEREST TRANSACTIONS**

The investments are managed by Aetna Life Insurance Company, the qualified institution of the Plan and, as such, these transactions qualify as party-in-interest transactions.

## Description of Actuarial Methods

### Asset Valuation Method

The Actuarial Value of assets used in the development of plan contributions phases in recognition of the difference between the actual return on Market Value and the expected return on Market Value over a three-year period at 33.33% per year. The Actuarial Value is adjusted, if necessary, to comply with the IRC Sec. 430 requirement that the Actuarial Value of assets be within the range of 90% to 110% of the Market Value of assets. This method is equivalent to the smoothed market value method without phase-in described in Approval 3.16 of Revenue Procedure 2000-40.

### Actuarial Cost Method

Funding Target Liability: Unit Credit Actuarial Cost Method.

Maximum Liability: Projected Unit Credit Actuarial Cost Method. The allocation of projected benefits between past years and future years is in proportion to the applicable rates of benefit accrual under the Plan.

## Description of Actuarial Assumptions

### Changes in Actuarial Assumptions as of January 1, 2024

The valuation reflects changes in the actuarial assumptions listed below. (The assumptions used before and after these changes are more fully described in the next section.)

- Mortality

With the exception of the valuation interest rate, the assumptions indicated were changed to represent the Enrolled Actuary's current best estimate of anticipated experience of the Plan.

### Interest Rates

The American Rescue Plan Act of 2021 (ARPA) was signed into law on March 11, 2021. ARPA continues to use a 24-month bond averaging period methodology for determining the segmented interest rates used in the calculation of the Plan's target liability and a corridor based on a 25-year bond averaging period. However, now the corridor based on 25-year average segment rates and the applicable minimum and maximum percentages used for purposes of calculating the Plan's target liability to adjust the 24-month average segment rates has been extended. In addition, any 25-year average segment rate that is less than 5% is deemed to be 5%.

The Infrastructure Investment and Jobs Act was signed into law on November 15, 2021 that further extended funding stabilization. The corridors under the new laws are as follows:

### Eligibility

The first of the month following the completion of one year of service and attaining age 21. There will be no new entrants after July 31, 2016.

### Employee Contributions

None required or permitted.

### Retirement

Normal: Age 65.

Early: Age 55.

Late: Retirement after age 65.

### Benefit at Retirement

As of July 31, 2016 no future benefits will accrue.

#### *Normal*

For service on and after February 1, 1989:  $\frac{2}{3}$  of 1% of earnings each year as an Active Member of the plan.

For service on and after July 1, 1973 and before February 1, 1989:  $\frac{1}{2}$  of 1% of the first \$9,000 of earnings plus  $\frac{2}{3}$ % of earnings in excess of \$9,000 each year as an Active Member of the plan.

For service prior to July 1, 1973: (a) x (b) where:

(a) =  $\frac{1}{4}$  of 1% of the first \$9,000 of "average earnings" plus  $\frac{1}{2}$  of 1% of "average earnings" in excess of \$9,000. Average Earnings equals the average yearly earnings for the five years prior to July 1, 1973.

(b) = Years of service prior to July 1, 1973, but not service prior to July 1, 1958.

Effective February 1, 1994, the 30 year service limitation was eliminated. All service as an Active Member is reflected.

Optional forms of benefit payment include a Social Security Adjustment Option, and 50%, 66.67%, 75%, and 100% Joint and Survivor Annuity Options and the 10 and 15 year certain and continuous forms of annuity.
