Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following description of the Behavioral Health Services North, Inc. Profit Sharing 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan provides retirement benefits for the employees of Behavioral Health Services North, Inc. (the Company). The Plan is a defined contribution plan, containing both 401(k) and profit-sharing components. Unless otherwise indicated, the provisions of the Plan are identical for both components.

#### **Administration**

The Company sponsors and administers the Plan. Glens Falls National Bank and Trust Company serves as the trustee and custodian of the Plan's assets. Beginning in 2024, EPIC Retirement Plan Services became the recordkeeper for the Plan. Prior to 2024, Glens Falls National Bank and Trust Company served as the recordkeeper.

#### **Eligibility**

Employees of the Company become eligible to participate in the Plan immediately upon employment and the attainment of age 18. Employees are eligible to receive discretionary Company contributions on the first day of the Plan year or the first day of the seventh month of the Plan year following the completion of 1,000 hours of service within 12 months. Employees remain eligible for the Company matching contribution even if they were not employed at year-end.

#### **Contributions**

Participants may make tax-deferred contributions to the Plan subject to certain limitations of the Plan and the Internal Revenue Code. The Company may make discretionary matching contributions on behalf of its participants to the Plan who meet the eligibility criteria. In 2024 and 2023, the Company matched 100% of participant's contributions up to a maximum of 3% of a participant's compensation. The Company may also make discretionary profit-sharing contributions. There were no discretionary profit sharing contributions in 2024 and 2023. The Plan also accepts direct rollover contributions from a qualified plan, as defined by the Plan.

#### **Participant Accounts**

Participants may direct the investment of their vested contributions and the Company's contributions into various investment options offered by the Plan. Participant accounts are credited with the participant contributions, the employer matching contributions, discretionary profit-sharing contributions, and allocations of Plan earnings and losses and charged with an allocation of administrative expenses. Allocations of earnings and losses and administrative expenses are based on account balances according to specific terms defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## 1. DESCRIPTION OF PLAN (Continued)

### **Vesting**

Participants are immediately vested in their contributions and actual earnings and losses thereon. Participants vest in employer matching contributions and discretionary profit-sharing contributions at a rate of 25% per year beginning with the completion of the participant's first year of service.

### **Notes Receivable from Participants**

Participants may borrow from their vested fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, unless the loan is used for the purchase of a primary residence, in which case the term may be up to ten years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the plan administrator. Interest is charged at the prime rate plus 1.0%. Principal and interest is paid ratably through bi-weekly payroll deductions.

### **Forfeitures**

Forfeitures of non-vested account balances are used to reduce Company matching contributions to the Plan or pay for plan administrative expenses at the discretion of the Plan sponsor. The amount of forfeitures used were \$52,571 and \$6,108 for the years ended December 31, 2024 and 2023 respectively. Unallocated forfeitures amounted to \$10,639 and \$14,123 at December 31, 2024 and 2023, respectively.

### **Hardship Withdrawals**

Participants may request hardship withdrawals from the Plan under certain circumstances. Only that portion of a participant's account associated with participant contributions and actual earnings/losses thereon may be eligible for hardship withdrawals.

### **Benefit Payments**

Upon termination of service, participants may receive a distribution of their vested account balance in either a single lump-sum check or in installments subject to certain restrictions, as set forth by the Plan. Upon termination, all participants with vested balances less than \$5,000 will be distributed within an administratively feasible time frame.

### **Plan Termination**

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). In the event of Plan termination, participants will become fully vested in their accounts.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The Plan's financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Investments**

Investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's realized and unrealized gains and losses on investments bought and sold, as well as held during the year.

### **Fair Value**

The Plan uses various valuation techniques in determining fair value. Generally accepted accounting principles establish a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that observable inputs be used when available. Observable inputs are inputs that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs are inputs that reflect the Plan's assumptions about the assumptions market participants would use in pricing the asset or liability, based on the best information available in the circumstances. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations are based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations are based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations are based on inputs that are unobservable and significant to the overall fair value measurement.

The availability of observable inputs can vary and is affected by a wide variety of factors. To the extent that valuation is based on models or inputs that are less observable or unobservable in the market, the determination of fair value requires more judgment. In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes the level in the fair value hierarchy within which the fair value measurement in its entirety falls is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

Fair value of the Plan's money market funds and mutual funds is determined based on quoted market prices. Cash is recorded at cost which approximates fair value. There were no changes in valuation methodologies during 2024 and 2023.

### **Risks and Uncertainties**

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that these changes could materially affect the balance of participant accounts and the amounts reported in the financial statements.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Delinquent participant loans are reclassified as distributions based on the terms of the plan document.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Benefit Payments

Benefit payments are recorded when paid.

### Administrative Expenses

All administrative expenses are paid by the Plan.

### Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and notes. Actual results could differ from those estimates.

#### 5. PARTY-IN-INTEREST TRANSACTIONS

Glens Falls National Bank and Trust Company is the trustee of the Plan and custodian of the Plan's assets, as well as the manager of certain funds in which participants may invest. As such, transactions between Glens Falls National Bank and Trust Company and the Plan qualify as party-in-interest transactions.

In addition, certain Plan assets consist of notes receivable from participants, which qualify as party-in-interest transactions.

#### 6. TAX STATUS

The Plan has received a favorable opinion letter from the Internal Revenue Service, dated June 30, 2020 as a prototype plan's qualified status. The prototype plan's opinion letter has been relied upon by the Plan. The Plan has been amended since the date of the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### 7. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and the changes in net assets available for benefits per the Plan's financial statements agreed to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

#### 8. SUBSEQUENT EVENTS

Subsequent events have been evaluated through September 18, 2025, which is the date the financial statements were available to be issued.
