Years ended December 31, 2024 and 2023

### **1. Description of the Plan**

The following description of the Step Up Suncoast, Inc. 403(b) Plan (the Plan), formerly the Manatee Community Action Agency 403(b), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan established January 1, 1997 and restated effective July 1, 2023, for the benefit of the employees of Step Up Suncoast, Inc. (the Company). The Plan is intended to satisfy all the requirements for a qualified retirement plan under the provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company serves as the Plan's Sponsor and Plan Administrator. The Plan's directed Custodians are Deleware Charter Guarantee & Trust Company d/b/a Pricipal Trust Company (Principal) and Voya Retirement Insurance and Annuity Company (Voya). Its third party administrator is KB Pension Services, Inc., and its investment advisor is Merrill Lynch. The Board of Directors is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Directors.

#### **Eligibility**

The Plan covers all full-time employees of the Company who have attained age 18 and part time employees who have attained the age of 18 and work more than 20 hours per week. All eligible employees may become participants and defer a portion of their annual compensation on the first day of the period coinciding with or following meeting eligibility requirements.

#### **Contributions**

For accounts held with Principal, participants may contribute up to 100% of pre-tax or post-tax annual compensation, as defined in the Plan limited by the provisions of the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make "catch up" contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may elect to make discretionary non-elective contributions to employees who have completed one year of service. For the year ended December 31, 2024, the Company elected to make a discretionary non-elective contribution equal to eight percent of each participant's compensation. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Contributions can no longer be made to accounts held with Voya.

## Notes to Financial Statements

### 1. Description of the Plan (continued)

#### Participant Accounts

Each participant's account is credited with the participant's contributions and Company discretionary nonelective contributions, as well as Plan earnings.

Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately fully vested in their contributions and all Company contributions plus actual earnings thereon.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years and are repaid in equal payroll period installments. The loans are secured by the balance in each participant's account and bear interest at rates of 3.25% to 8.50%. The interest rate on any loan to a participant shall be a reasonable interest rate commensurate with current interest rates charged for loans made under similar circumstances by persons in the business of lending money. For the year ended December 31, 2024, the interest rate equaled the prime interest rate.

#### Payment of Benefits

Upon termination of service due to retirement, death, disability, or termination of employment, a participant with a vested balance greater than \$5,000 may elect to receive a single lump-sum equal to the value of the participant's vested interest in his or her account. A single lump-sum distribution will be made to terminated participants whose vested balance is less than \$5,000 unless alternative instructions are provided by the participant within a reasonable period of time.

#### Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$6,615 and \$6,542, respectively. These accounts will be used to reduce employer contributions or pay qualified plan expenses. Forfeitures used to reduce employer contributions and pay qualified expenses totaled \$356 during the year ended December 31, 2024.

### **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments, other than the fully benefit-responsive investment contracts discussed in Note 3, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, Custodians, and insurance company. See Note 4 for additional discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable or distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

#### **2. Summary of Significant Accounting Policies (continued)**

##### **Subsequent Events**

The Plan has evaluated subsequent events through September 18, 2025, the date the financial statements were available to be issued. During the period from December 31, 2024 to September 18, 2025, the Plan did not have any material recognizable subsequent events.

#### **3. Guaranteed Investment Contracts with Custodians**

The Plan was invested in a Fixed Income Guarantee Option (FIGO) with Principal and a Fixed Account (FA) with Voya. Under the terms of the group annuity contracts, a crediting rate is established for amounts invested in the FIGO and FA, and participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value. Contract value represents contributions plus credited interest less participant withdrawals and fees. Contract value is also often referred to as “book value.” The contracts meet the fully benefit-responsive investment contract criteria, notwithstanding the contract provisions that limit the ability of the Plan to transact at contract value when a market value event occurs.

Because the FIGO and FA are fully benefit-responsive, contract value is the relevant measurement attribute for those portions of the net assets available for benefits attributable to the FIGO and FA. The FIGO and FA are presented on the face of the statements of net assets available for benefits at contract value.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to a participant termination of employment due to: (1) removal of a group of participants from plan coverage as a result of temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the plan; (3) transfer or other change of position in employment by an entity controlling, controlled by, or under other common control with the employer; or (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan sponsor’s business.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include (1) a breach of material obligation under the contract; (2) partial or complete plan termination; (3) plan disqualification; or (4) the issuer provides at least ninety days notice of termination. Consult your Plan’s contract for further information. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their entire account.

#### 6. Tax Status

The Company adopted a volume submitter 403(b) plan sponsored by FIS Business Systems LLC. The volume submitter 403(b) plan has received an opinion letter dated March 31, 2017 from the Internal Revenue Service (IRC), which states that the volume submitter 403(b) plan is designed in accordance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the volume submitter 403(b) plan document, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified.

### **7. Accounting for Uncertainty in Income**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2020.

### **8. Related Party Transactions and Party In Interest Transactions**

Certain Plan investments are managed by the Plan's Custodians. Transactions involving these investments are considered to be party in interest transactions. Total fees paid by the Plan for administrative and investment services were \$46,548 for the year ended December 31, 2024.

### **9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **10. Information Certified by Custodians**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained from management and agreed to or derived from information certified as complete and accurate by Principal and Voya (the Custodians of the Plan), qualified institutions.
