We have performed audits of the financial statements of Heartland Equity Partners 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Heartland Equity Partners 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate.

NOTES TO FINANCIAL STATEMENTS

1. Plan Description and Summary of Significant Accounting Policies

The following description of the Heartland Equity Partners 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General Information

The Plan is a 401(k) salary reduction and profit sharing plan which was established on October 1, 2015. The Plan covers substantially all employees (other than employees covered by a collective bargaining agreement, nonresident aliens and leased employees) of Cass Screw Machine Products, LLC (the Plan Sponsor), Ajax Metal Forming Solutions, LLC, Spectrum Aeromed, LLC, Heartland Equity Management, LLC, and ABM Equipment, LLC (The Companies) who have three months of service and have attained age 18. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Administration

The Custodian of the plan's mutual funds and common/collective trust is Matrix Trust Company. Administrative expenses of the Plan are paid partially by the Plan and partially by the Companies.

Participation

All employees over age 18 (other than employees covered by a collective bargaining agreement, nonresident aliens and leased employees) who have three months of service are eligible to make salary deferral contributions to the Plan. Once eligibility requirements have been met, an eligible employee can enroll on the first day of the following month. Elective deferral contributions may be changed or stopped on any date.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Contributions

Each year, participants may contribute up to the maximum allowable amount not to exceed the limits of Internal Revenue Service (IRS) Code Section 401(k) on a pre-tax or after-tax (Roth) basis, as defined in the Plan. Participants who have attained the age of 50 before the end of the Plan year are also eligible to make catch-up contributions in any amount up to the limits prescribed by law. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their account into various investment options offered by the Plan.

Each Company contributes to the Plan a safe harbor contribution of 3% of a participant's eligible compensation once employees meet the one year of service eligibility requirement. In addition, each Company may contribute a discretionary matching contribution. Each Company may also make a discretionary profit sharing contribution to eligible participants. Participants direct the investment of employer contributions allocated to them into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's elective deferrals, employer contributions and an allocation of Plan earnings and expenses. Allocations of Plan earnings are based on the valuation of the investments held in each participant's account. Participants' accounts are valued on a daily basis. The benefit the participant is entitled to is the benefit that can be provided from the participant's account.

Notes Receivable from Participants

During April 2021, the Plan was amended to allow rollover loans from participants of an adopting employer of the Plan. The Plan does not allow new borrowings from participants' current fund accounts. Loan terms range from one to five years for general purpose loans or up to thirty years for loans for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. The interest rate on the loan outstanding as of December 31, 2024 is 5.75%. Principal and interest is paid ratably through payroll deductions.

HEARTLAND EQUITY PARTNERS 401(K) PLAN

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Vesting

Participants are immediately vested in their elective deferral contributions, rollover contributions and employer matching and safe harbor contributions plus actual earnings thereon. Vesting in Company profit sharing contributions (if any) plus earnings thereon is based on years of continuous service. Participants begin vesting after two years of service, earn 25% vesting for each additional year of service and become 100% vested after completing five years of service or upon reaching age 65, upon death or upon permanent disability.

Forfeited Accounts

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures totaled \$528 and \$361 for the years ended December 31, 2024 and 2023, respectively. There was \$769 and \$236 of unallocated forfeitures at December 31, 2024 and 2023, respectively. The Plan used \$4 and \$1,260 of forfeitures for paying reasonable Plan expenses, the restoration of participants' forfeitures or reducing the employer's contribution to the Plan during the years ended December 31, 2024 and 2023, respectively.

Payment of Benefits

Upon termination of employment, death, disability or reaching normal retirement age, participants or their beneficiary(ies), where applicable, may receive the value of the accrued vested benefit in the form of a lump sum payment; installment or partial payments or may elect to defer the distribution in accordance with Plan guidelines if the balance in the participant's account exceeds \$1,000. Balances less than \$1,000 may only be distributed in the form of a lump sum payment.

The Plan allows for hardship withdrawals from the fully vested portion of the participant's account, including Roth deferral accounts. The Plan also allows for in-service distributions of the fully vested portion the participant's account if the participant has reached the age of 59 and ½ years old. Benefit payments are recorded upon distribution to participants.

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

Investments are reported at fair. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

All purchases and sales of securities have been recorded on a trade-date basis. Income is recorded as earned. The increase or decrease in the fair value of investments represents the net difference between the current value of securities held at the beginning of the year or cost of securities purchased during the year and the current value of securities held at the end of the year.

Administrative Expenses

Each Company pays certain administrative expenses on behalf of the Plan. Expenses paid by the Plan are included in the statement of changes in net assets available for benefits.

Plan Termination

Although they have not expressed any intent to do so, the Plan Sponsor has the right under the plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants become 100 percent vested in their accounts.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events

In preparing these financial statements, Plan management has evaluated events and transactions for potential recognition or disclosure through September 24, 2025, the date the financial statements were available to be issued.

The SECURE 2.0 ACT of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2024 and beyond. Plan management is evaluating the impact of the adoption and implementation of this legislation on the Plan.

2. Certification of Investments

The Trustees of the Plan appointed Matrix Trust Company as Custodian of the Plan's mutual funds and common/collective trust account. Matrix Trust Company has supplied the Plan Administrator with certifications as to the completeness and accuracy of Plan investments aggregating \$21,465,172 and \$17,470,927 as of December 31, 2024 and 2023, respectively, and the related investment income of \$2,572,959 and \$2,788,729 for the years then ended. Such amounts and all related financial data are included in the accompanying financial statements and supplemental schedule based on the certification from Matrix Trust Company.

Under the terms of the Custodial agreement, the Custodian manages investment funds on behalf of the Plan. The Custodian has been granted discretionary authority concerning the purchases and sales of the investment of the investment funds.

3. Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Observable market-based inputs or unobservable inputs that are corroborated by market data. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

3. Fair Value Measurements (Continued)

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Investments in common/collective trust: The collective trust fund is valued at the net asset value of units of a bank collective trust. The net asset value, as provided by the trustee, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In addition, withdrawals from and transfers among the common/collective trusts may be subject to postponement for any period during which trading on the New York Stock Exchange is restricted or any period during which an emergency exists, as determined by the Securities and Exchange Commission, as a result of which it is not reasonably practical to dispose of securities in the common/collective trusts or to fairly determine the value of the assets of the common/collective trusts.

4. Party-in-interest Transactions

Transactions resulting in Plan assets being transferred to or used by a related party are considered prohibited transactions under ERISA unless a specific exemption exists. The Plan Custodians manage certain Plan investment transactions, and the Plan auditor fees are paid from Plan assets; therefore, the transactions qualify as party-in-interest transactions and are indicated as such on the supplemental Schedule of Assets Held at End of Year and the Plan's Form 5500 as applicable. However, the transactions are not considered prohibited transactions as ERISA regulations provide for a specific exemption for such transactions. The Plan also issues loans to participants, which are secured by the participant account balances. These qualify as party-in-interest transactions but are permitted under ERISA regulations. Additionally, certain employees of the Company provide certain accounting and administrative services to the Plan for which no fee is charged. These transactions are also permitted under ERISA regulations.

5. Plan Tax Status

The Plan has adopted a prototype plan document, which has received an opinion letter from the Internal Revenue Service stating that the plan document and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

The Plan evaluates all significant tax positions as required by generally accepted accounting principles in the United States. As of December 31, 2024, the Plan does not believe that it has taken any tax positions that would require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months.

The Plan's informational returns are subject to examination by the appropriate regulatory authorities as of December 31, 2024, and the Plan's federal informational returns generally remain open for a period of three years.

6. Risk and Uncertainties

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
