### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **Clare Holdings, LLC 401(k) Plan** (formerly known as Euclid Beverage, LLC 401(k) Before Tax Savings Plan) (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### 1. Description of Plan

The following brief description of the Clare Holdings, LLC 401(k) Plan (formerly known as the Euclid Beverage, LLC 401(k) Before Tax Savings Plan) (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution plan covering all eligible employees of Clare Holdings, LLC, Euclid Beverage, LLC, Merchants Export, LLC, Merchants Market Group, LLC, Merchants Market, LLC, Merchants Market St. Croix, LLC, and Island Saints, LLC (collectively, the Company), except for collective bargaining employees hired after July 1, 2006, non-resident aliens, and part-time employees whose regularly scheduled service is less than 1,000 hours. Such employees are eligible to participate in the Plan immediately upon employment commencement date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** – Each year, participants may contribute pre-tax annual compensation, as defined by the Plan, subject to statutory limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company may make discretionary matching contributions to Plan participants, as defined by the Plan. During 2024, the Company made a discretionary match of up to 50% of 6% of eligible compensation deferred to the Plan by the participants.

**Participants' Accounts** – Each participant's account is credited with the participant's contribution and allocations of: (a) the Company's discretionary contribution, if any, (b) Plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances or compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – Participants are immediately vested in their contributions and rollovers, plus actual earnings thereon. Participants become vested in their discretionary profit sharing contribution account balances based on years of continuous service. The Plan provides for a six-year vesting period for discretionary profit sharing contributions with 20% vested after year 2, and an additional 20% vesting each year thereafter. A participant who incurs a severance from employment as a result of death or disability is entitled to 100% of their vested account balance.

**Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or fifty (50) percent of their vested account balance. The loans are secured by the balance in the participant's account. Loan terms range from one to five years. However, loans used to acquire the primary residence shall provide for periodic repayment over a reasonable period of time that may exceed five (5) years but not ten (10) years. The loans are secured by the balance in the participant's account, and bear interest at 4.25% - 9.50%, which is equal to the prime rate plus one percent as published by *The Wall Street Journal* on the first business day of the month. Principal and interest are paid ratably through monthly payroll deductions; however, lump-sum repayments are permitted.

1. **Description of Plan** (cont'd)

**Payment of Benefits** – On termination of service upon attaining 65 years of age or due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount or periodic installments equal to the value of the participant's vested interest in his or her account. Upon attaining 59½ years of age, a participant has the option to take an in-service distribution for any reason. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. The Plan allows participants to take hardship withdrawals only from the participant's elective deferrals.

**Forfeitures** – Forfeited balances of terminated participants' nonvested accounts are used to reduce employer contributions or pay Plan expenses. There were forfeited nonvested balances of \$25,907 at December 31, 2024 (\$11,439 at December 31, 2023). During 2024, no forfeitures were used to reduce employer contributions of the Plan (none in 2023), and, \$15,028 were used to pay Plan expenses during 2024 (\$13,675 in 2023).

**Plan Amendment** – On March 27, 2020, President Trump signed into law the Coronavirus Aid, Relief, and Economic Security Act, (CARES Act). The Plan adopted an amendment to address the provisions of the CARES Act. As a result, changes were made related to Plan withdrawals and loans to participants, for impacted participants, their spouse and dependent(s) who have been diagnosed with virus SARS-CoV-2 or with COVID-19, as well as participants that have experienced adverse financial consequences. The changes applicable to the Plan are summarized below:

- Impacted participants may receive up to \$100,000 in aggregate withdrawals before December 31, 2020.
- 10% penalty tax for early withdrawal is waived.
- Mandatory 20% withholding on distributions will not apply.
- No limit to the number of withdrawals an impacted participant can make.
- Repayment of withdrawal amount is permitted if repayment occurs within three years of the distribution.
- Impacted participants may borrow up to the lesser of \$100,000 or 100% of their vested balance for 180 days beginning March 27, 2020.
- Impacted participant loan payments due from March 27, 2020 through December 31, 2020, including those due following a severance from employment, may be delayed for one year.
- Required Minimum Distribution (RMD) rules for distributions required for the 2020 calendar year are temporarily waived.

On Aug. 3, 2022, the IRS issued Notice 2022-33, which extends the deadlines for qualified retirement plans to adopt amendments reflecting certain optional and required changes under the SECURE, CARES, and Miners Acts. Plan sponsors of defined contribution plans generally have until December 31, 2025, to amend their plans if they took advantage of benefit changes permitted by these laws, including changes allowed by the CARES Act as part of COVID-19 relief. The Plan will formally adopt an amendment to address these changes at a later date in accordance with applicable law and IRS guidance.

**2. Summary of Significant Accounting Policies**

**Basis of Presentation** – The accompanying financial statements have been prepared on the accrual basis of accounting.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee, and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable From Participants** – Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

**Payment of Benefits** – Benefits are recorded when paid.

**Subsequent Events** – Subsequent events have been evaluated through September 24, 2025, which is the date the financial statements were available to be issued.

**Expenses** – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's accounts. Investment related expenses are included in net appreciation of fair value of investments.

**4. Fair Value of Financial Instruments**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, "Fair Value Measurements and Disclosures," provides the framework for measuring fair value. That framework provides a three-level valuation hierarchy that prioritizes the inputs to valuation techniques used to measure fair value as follows:

**Level 1** – Valuations are based on unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.

**Level 2** – Valuations are based on quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in markets that are not active; and model-derived valuations whose significant inputs are observable.

**Level 3** – Valuations are based on unobservable inputs for the asset or liability that reflect the reporting entity's own data and assumptions that market participants would use in pricing the asset or liability. These unobservable inputs are significant to the fair value measurement.

**4. Fair Value of Financial Instruments (cont'd)**

Following is a description of valuation methodologies used for investments measured at fair value on the statement of net assets available for Plan benefits, and the classification of such investments pursuant to the valuation hierarchy.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust's participation units fair value is based upon the net asset values of such fund, as reported in the audited financial statements of the fund. Subject to certain restrictions, withdrawals from the stable value fund are generally permitted daily at contract value.

**5. Related-Party and Party-in-Interest Transactions**

Certain Plan investments are under a contract managed by JP Morgan Chase Bank, N.A. (JP Morgan). JP Morgan is the custodian of the Plan's contract; therefore, these transactions qualify as party-in-interest transactions and are allowed under a waiver. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the third-party administrator of \$65,765 which was not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**7. Tax Status**

The Internal Revenue Service issued an opinion letter dated March 31, 2014, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt except as noted below.

Accounting principles generally accepted in the United States of America, require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by federal and state taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements except as noted below. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.
