### NOTE 1 PLAN DESCRIPTION

The following description of The Ford Meter Box Company, Inc. Employee Benefit Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan provides health benefits covering substantially all employees and qualifying retired employees of The Ford Meter Box Company, Inc. (the "Employer"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### Benefits

The Plan provides medical, dental, vision, and prescription drug benefits covering full-time employees of the Employer who have completed eligibility requirements and provided such benefits are not payable by any other plan or policy. In addition, the Plan provides group life and accidental death and dismemberment insurance, long-term disability insurance and business travel accident insurance under a flexible benefit plan. The Plan also covers dependents of eligible employees. Employees whose service with the Employer has been temporarily or permanently terminated may continue to receive benefits under the Consolidated Omnibus Budget Reconciliation Act of 1985 ("COBRA") by paying monthly premiums to the Plan. Retired employees and their spouses are entitled to health benefits provided they are between 60 and 65 years of age and meet certain plan requirements.

The Plan has acquired specific excess liability insurance that covers claims in excess of \$275,000 per family, with an aggregating specific deductible of \$330,000 for the period May 1, 2024 through April 30, 2025 and \$300,000 for the period May 1, 2023 through April 30, 2024. There is no lifetime maximum coverage per person.

The Plan records estimated recoveries under terms of the insurance coverage when receivable and reasonably determinable. Estimated recoveries from stop-loss carriers are reported as a separate addition to net assets rather than a net reduction of benefit claims paid. All other refunds, including subrogation refunds are reported as a net reduction of benefit claims paid. As of December 31, 2024 and 2023, the estimated amount of recoveries receivable was \$31,660 and \$106,921, respectively.

#### Contributions

An employee of the Employer can elect coverage when the employee becomes eligible under the Plan. Employee contributions are based on the employee's desired coverage. Contributions range from \$17 to \$154 per week before receiving any lifestyle reduction credits. Employer contributions to the Plan are made periodically as monies are needed to cover claims. Participants can also acquire supplemental life insurance for themselves and their spouses through additional contributions based on their desired level of coverage.

### NOTE 2 SUMMARIES OF ACCOUNTING POLICIES

#### Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

#### Cash and Cash Equivalents

Cash and cash equivalents are all highly liquid debt instruments purchased with a maturity of three months or less and include bank accounts and money market accounts.

#### Certificates of Deposit

Certificates of deposit are valued based on original cost plus accrued interest.

#### Funding Policy

The Plan is funded through a separate trust with general assets of the Employer and authorized payroll deductions withheld from employees as well as premiums received from retired employees and employees electing coverage under COBRA. The contributions are made by the Employer and employees to cover benefit payments. The Employer's policy is to fund current medical benefits for employees and retirees as incurred and to fund reserves for accumulated postretirement benefits as allowed under Internal Revenue Code Section 419A, but will not exceed IRS limits.

#### Significant Accounting Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Employer to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Plan obligations at December 31 for benefit claims incurred, but not reported at that date, are estimated based on experience factors compiled by the Plan. The estimated amounts reported in the accompanying financial statements have not been discounted because it has been the Plan's experience that substantially all claims are remitted to the Plan for processing within three months after the related health care services have been rendered.

#### Income Taxes

The Internal Revenue Service has determined and informed the Company by a letter dated August 24, 1977, that the trust established under the Plan is tax-exempt under Internal Revenue Code Section 501(c)(9). The Plan has been amended since that time (most recently the Plan's Summary Plan Description was restated with an effective date of January 1, 2019) and the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable provisions of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

According to the Financial Accounting Standards Board's guidance on accounting for uncertainty in income taxes, management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### Reclassifications

Certain prior year amounts have been reclassified to conform to the current year presentation.

#### Evaluation of Subsequent Events

The Plan has evaluated subsequent events through September 24, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan engaged Allied Benefit Systems, LLC as its new third-party administrator.

Effective January 1, 2025, the Plan was amended to modify its medical benefits schedule with respect to medical deductible, co-insurance, and out-of-pocket maximums for medical coverage, as well as specialty drugs. The Plan was also amended to modify the prescription drug benefits schedule related to deductibles, retail pharmacy benefit schedules, and mail order benefit schedules. Additionally, the amendment modified the Plan's general limitations for cell therapy and certain glucagon-like peptide-1 (GLP-1) medications except for the treatment of diabetes. Furthermore, the amendment allows for access to a telehealth service provider.

### **NOTE 3 PLAN AMENDMENTS**

Effective January 1, 2023, the Plan was amended to modify coverage for preventative wellness benefits with respect to obesity prevention counseling, postpartum visits, breastfeeding equipment and supplies, anxiety screening, suicide risk assessment, sudden cardiac arrest and sudden cardiac death risk assessment, and prostate cancer screening. The Plan was also amended to modify its medical benefits schedule, medical deductible, co-insurance, and out-of-pocket maximums for medical coverage.

Effective June 15, 2023, the Plan was amended to modify coverage for gene therapy treatments.

Effective January 1, 2024, the Plan was amended to modify its general limitations for anti-amyloid therapies for Alzheimer's disease. Furthermore, the amendment also modified the Plan's medical benefits schedule with respect to out-of-pocket maximums for medical coverage.

### **NOTE 4 POSTRETIREMENT BENEFITS**

The Plan provides postretirement medical benefits to retired employees and spouses who have completed ten years of service with the Employer and attained the age of 60. The benefit expires at age 65 or when the retiree obtains coverage from another source. The postretirement health care plan is contributory, with retiree contributions adjusted annually.

The postretirement benefit obligation represents the amount that is to be funded by contributions from the Employer. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service with the Employer rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is the amount that results from applying actuarial assumptions to historical claims-cost data to estimated future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The foregoing assumptions are based on the presumptions that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations.

The weighted-average health care cost-trend rate assumption has a significant effect on the benefit obligations reported in the accompanying financial statements. If the assumed rates increased by one percentage point in the next year, it would increase the obligation as of December 31, 2024 and 2023 by approximately \$66,971 and \$63,169, respectively.

The Employer's policy is to fund current medical benefits for employees and retirees as incurred and to fund reserves for accumulated postretirement benefits as allowed under Internal Revenue Code Section 419A.

### NOTE 5 PARTIES-IN-INTEREST

There were no non-exempt transactions during the year between the Plan and any parties-in-interest as defined by the ERISA. The Employer's personnel, at no charge to the Plan, perform basic accounting functions for the Plan. In addition, the Employer pays for certain expenses of the Plan. Management estimates these costs for the years ended December 31, 2024 and 2023 to be \$478,000 and \$411,000, respectively.

### NOTE 6 CONCENTRATIONS OF CREDIT RISK

The Plan maintains its cash at high credit quality financial institutions. The Wells Fargo debt rating is one of the highest ratings of any financial services company and Crossroads Bank, part of the Promontory Interfinancial Network, which manages the CDAR's program is a leading provider of FDIC-insured deposit placement services. The balances, at times, may exceed federally insured limits, though to date, no losses have been incurred.

### NOTE 8 RECENTLY ADOPTED ACCOUNTING PRONOUNCEMENTS

In June 2016, the FASB issued guidance (FASB ASC 326) which significantly changed how entities will measure credit losses for most financial assets and certain other instruments that are not measured at fair value through net income. The most significant change in this standard is a shift from the incurred loss model to the expected loss model. Under the standard, disclosures are required to provide users of the financial statements with useful information in analyzing an entity's exposure to credit risk and the measurement of credit losses. Financial assets held by the Plan that are subject to the guidance in FASB ASC 326 were insurance recovery receivable. The Plan adopted the standard effective January 1, 2023. The impact of the adoption was not considered material to the financial statements.
