To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of ARDEX, L.P. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Empower Trust Company, LLC, a qualified institution, as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America; and
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of ARDEX, L.P. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the adoption agreement for a more complete description of the Plan's provisions.

General - The Plan, established effective June 1, 1992 and amended and restated effective July 1, 2022, is a defined contribution plan which covers substantially all full-time, non-union employees of ARDEX, L.P. (the "Sponsor") and The W.W. Henry Company, L.P., a related company (collectively the "Employers"). Effective July 1, 2022, the Plan was amended to extend eligibility to non-union, long-term part-time employees beginning in 2024, once certain service requirements are met. Employees who are at least 18 years of age are eligible to participate in the Plan.

Basis of Accounting - The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

Use of Estimates - The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements and the reported amounts of changes in net assets during the reporting periods. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are carried at their fair value based on published quotations or, in the absence of readily ascertainable market values, at such values as the trustee determines. The unrealized appreciation (depreciation) of investments is determined by the change in current market value from the beginning of the year (if held for the entire year) to the end of the year, or from the date of purchase to the end of the year. The realized appreciation (depreciation) of investments is determined by the change in the current market value from the beginning of the year (if held since the beginning of the year) to the date of sale, or from the date of purchase to the date of sale. Gains and losses on securities sold or redeemed are determined on the basis of specific identification. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned and are generally reflected as a component of net appreciation or depreciation in fair value of investments.

Contributions - Participants may elect to contribute between 1% and 75% of compensation as defined by the Plan, subject to certain limitations under the Internal Revenue Code. Eligible participants automatically defer 5% of their compensation into the Plan, increasing each year until a deferral amount of 15% is attained. As further detailed in the adoption agreement, participants are able to make affirmative elections to contribute less or more than would be automatically deferred. The Plan also accepts rollover contributions from other qualified plans.

The Employers may make discretionary matching contributions to the Plan. For the years ended December 31, 2024 and 2023, the matching contribution was 65% of participant salary deferrals, up to 6% of the participant's eligible compensation.

Participant Accounts - Each participant's account is credited with the participant's contribution, an allocation of the employer matching contribution, if applicable, and plan earnings. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options - Participants may direct their contributions and any related earnings into various investment options. The Plan is invested in various funds maintained by Empower Trust Company, LLC.

Risks and Uncertainties - The Plan's funds are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits and statements of changes in assets available for benefits.

Notes Receivable from Participants - Participants are able to borrow up to 50% of their vested account balance up to \$50,000. The amount of the loan is required to be at least \$1,000. Loans are generally required to be repaid over a five year period in equal semi-monthly installments. The interest rate on new participant loans is the prime rate at loan inception plus 2%. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

At December 31, 2024 and 2023, the interest rate on outstanding loans ranged from 5.25% to 10.50%.

Distributions - Upon termination of service due to death, disability, retirement or other termination, participants or their beneficiaries may elect to receive an amount equal to the value of the participant's vested interest in his or her account or IRA rollover. If a participant's vested account balance exceeds \$5,000 (through March 31, 2024) or \$7,000 (effective April 1, 2024), he or she may elect to receive a distribution in a

lump-sum payment (or IRA rollover) or make partial withdrawals. If a participant's vested account balance is less than \$5,000 (through March 31, 2024) or \$7,000 (effective April 1, 2024), his or her account will be automatically distributed.

Vesting - The accounts for all participants' contributions and earnings thereon are fully vested and nonforfeitable at all times. Employer contributions vest according to the following schedule:

Cash and Cash Equivalents – Cash and cash equivalents are categorized as investments in the statements of assets available for benefits and include a forfeiture account and an expense account. At December 31, 2024 and 2023, the balance in the forfeiture account was \$28,443 and \$6,839, respectively. The balance may be used to reduce employer contributions. For the years ended December 31, 2024 and 2023, forfeitures were \$27,430 and \$6,879, respectively. No amounts were used from the forfeiture account to reduce employer contributions in 2024. Employer contributions were reduced by \$12,642 from the forfeiture account in 2023. Other activity in the forfeiture account consisted of interest income and fees.

At December 31, 2024 and 2023, the balance in the expense account was \$27,289 and \$39,291, respectively. All revenue sharing income from plan assets is credited to the expense account, and the employers may make additional deposits thereto. The expense account may be used to pay the Plan's administrative expenses; residual amounts may be reallocated to participant accounts. For the years ended December 31, 2024 and 2023, revenue sharing income credited to this account was \$34,560 and \$103,809, respectively. For the years ended December 31, 2024 and 2023, administrative expenses paid out of the expense account were \$46,670 and \$73,955, respectively. For the year ended December 31, 2023, the employers elected to reallocate a total of \$30,000 from the expense account to each participant's account based on the ratio of the participant's account balance to all participants' account balances. Other activity in the expense account consisted of interest income and miscellaneous withdrawals.

Administrative Expenses - The Plan's expenses, which mainly consist of investment advisory, audit fees and other fees (see Note 6), are paid by the Employers or by the Plan, at the Employers' discretion.

Fair Value Measurements - U.S. GAAP establishes a framework for measuring fair value of financial assets. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1

measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs are not quoted prices in active markets but they are observable either directly or indirectly.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodology used at December 31, 2024 and 2023.

Mutual Funds: Valued using quoted prices in an active market (Level 1 measurement).

Group Annuity Contract: The group annuity contract is a public investment vehicle that is not fully benefit-responsive, and the fund is valued using the value provided by the trustee on the last day of the Plan's year end. That value is based on the value of the underlying assets owned by the trust, minus its liabilities, and then divided by the number of shares outstanding. Participants can redeem units daily for the purpose of funding benefit payments, making participant loans, transferring the participant's interest in the Plan to another investment election or paying trustee fees. The units of participation are valued at the fair value of the trusts' underlying assets. Because the investment is measured at fair value using the net asset value per share practical expedient, it is not classified in the fair value hierarchy.

These methods may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the plan administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting dates.

Subsequent Events - The Sponsor has analyzed subsequent events for recognition and disclosure purposes through September 25, 2025, the date which the financial statements were available to be issued.

2. PLAN TERMINATION

The Sponsor anticipates and believes that the Plan will continue without interruption but reserves the right to discontinue the Plan at its discretion. In the event that such discontinuance results in the termination of the Plan, all amounts credited to participant accounts become 100% vested. The net assets of the Plan will be distributed by the trustee in accordance with the trust agreement in a uniform and nondiscriminatory manner.

3. INCOME TAX STATUS

The Plan is a standardized, pre-approved plan sponsored by Empower Trust Company, LLC. The Internal Revenue Service has stated in a letter dated November 14, 2022 that the plan is designed in accordance with the applicable regulations of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Management believes there is no liability related to uncertain tax positions at December 31, 2024 and 2023. The Plan is no longer subject to U.S. federal or state income tax examinations by tax authorities for tax years before 2021.

4. CERTIFIED FINANCIAL INFORMATION

Empower Trust Company, LLC, the trustee, has certified that the following data included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of assets available for benefits as of December 31, 2024 and 2023.
- Income on investments and notes receivable from participants, as shown in the statements of changes in assets available for benefits for the years ended December 31, 2024 and 2023.
- The schedule of assets held for investment purposes at December 31, 2024, as shown on the accompanying schedule.
