Note 1. Description of the Plan

The following description of the CCC Intelligent Solutions Inc. 401(k) Retirement Savings & Investment Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by CCC Intelligent Solutions Inc. (the Company) for the benefit of its eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended by subsequent legislation.

Third-Party Administrator and Trustee

T. Rowe Price Retirement Plan Services, Inc. (T. Rowe Price) performs certain third-party administrator duties. T. Rowe Price Trust Company (T. Rowe) is the trustee of the Plan's assets.

Participation and Vesting

Generally, all employees of the Company who are not leased employees are eligible to participate if they are at least 18 years of age. Employees of the Company who are 18 years of age shall be eligible to participate upon completion of 1,000 hours of service during the 12-month period that begins on the date on which the employee first completes an hour of service. If an employee does not complete 1,000 hours of service during the initial 12-month period, subsequent eligibility periods will begin on January 1 after that date. The Plan uses an automatic enrollment feature. Under this feature, if a new employee does not proactively make an election into the Plan, or proactively "opt-out" of automatic enrollment, then they are automatically enrolled in the Plan after 45 days of employment. Participants are immediately vested in their voluntary contributions, pre-1999 matching contributions, Company profit-sharing contributions, and rollover contributions plus actual earnings (losses) thereon. Only vesting of post-1998 Company-matching contributions and accumulated earnings (losses) is based on years of service. A year of service is any calendar year in which the employee completed 1,000 hours of service. A participant vests one-third for each year of service and therefore is 100% vested after three years of service. Former Auto Injury Solutions, Inc. (AIS), a wholly owned subsidiary of the Company covered by the plan, employee participants were given credit for prior service time under AIS and vest 20% after the first year and 100% after the second year of credited service.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$67,251 and \$118,084, respectively. The Company may elect to use forfeitures from non-vested accounts to pay the Plan's administrative expenses or to reduce future employer contributions. In 2024, employer contributions were reduced by \$197,165 from forfeited nonvested accounts.

Contributions

Plan participants may contribute (Participant Contributions) an amount ranging between 1% and 50% of eligible compensation up to the IRS limits into any of the Plan's established investment funds, as specified in the Plan agreement. Participant Contributions can be made from: 1) before-tax earnings, which have the effect of reducing current taxable earnings for federal income taxes or 2) after-tax contributions to the Plan. Any participant hired on or after January 1, 2011, that enrolls in the Plan via the auto-enrollment feature has a default contribution rate of 6% and such contributions are made to the T. Rowe Price Retirement Fund investment option with a fund target date that most closely aligns with the year the participant turns age 65. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions

The Company makes matching contributions equal to 50% of Participant Contributions, up to a maximum of 3% of the participant's eligible compensation. Effective July 1, 2024, the maximum was increased to 4%. Participants are eligible to receive Matching Contributions on the first day of the month after commencing employment.

For AIS participants, prior to the merger with the Company on December 31, 2023, the Company made Matching Contributions equal to 100% of the Participant's Contributions up to the first 2% of the AIS participant's compensation, plus 50% of the Participant's Contributions up to the next 4% of compensation.

Effective January 1, 2024, following the merger, AIS participants became subject to the Company's standard matching formula.

The Company, at its sole discretion, may make a discretionary contribution (Profit-Sharing Contribution) for any given year. Any employee who has met the eligibility requirements for participation in the Plan will be eligible to receive a Profit-Sharing Contribution, if any, provided that such employee is employed with the Company or any participating employer on the last day of the Plan year. There were no Profit-Sharing Contributions in 2024 and 2023.

All contributions are subject to limitations imposed by the Internal Revenue Code (IRC) and the regulations promulgated thereunder and ERISA.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution and allocations of (a) the Company's Profit-Sharing contributions and (b) plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The participant is entitled to a benefit that equals his/her vested account.

Notes Receivable from Participants and Hardship Distributions

The Plan provides loans to participants in certain situations governed by the Plan's loan procedures. Loans to participants shall be the lesser of \$50,000 or 50% of their vested account balance. Loans must be repaid within a five-year period, unless the loan is for acquisition of a primary residence, in which case it may be repaid over a period of up to 15 years. No more than one loan may be outstanding at any time. The loan repayment terms and interest rates are approved by the Plan trustee. Principal and interest on loans are paid ratably through monthly payroll deductions. As of December 31, 2024, the interest rates on the outstanding loans ranged from 4.25% to 9.50%.

The Plan also provides for hardship distributions in certain situations, including the purchase of a participant's primary residence, for payment of post-secondary education tuition, for the payment of certain medical expenses, to prevent eviction or foreclosure from the participant's primary residence, payment of burial or funeral expenses for the participant's deceased parent, spouse, child or dependent, payment of expenses to repair damage to the participant's principal residence that would qualify for the casualty deduction under IRC Section 165, and any other event or expense deemed an immediate and heavy financial need by the Internal Revenue Service (IRS). Any loans or in-service distribution reduces participant investments in their respective selected invested funds.

Investment Options

The Plan allows participants to allocate their contributions to various investment options available under the Plan. Investment elections must be made in 1% increments. Participants are allowed to reallocate their entire account balance in multiples of 1% among the Plan's investment options once each business day.

Withdrawals

The Plan provides that a participant may receive a distribution only in the following circumstances: (1) the participant attains age 70½; (2) the participant retires; (3) the participant separates from the Company; (4) the participant dies; (5) the participant becomes disabled; (6) the participant encounters a financial hardship as

specified in the Plan; or (7) there is a Qualified Domestic Relations Order issued by a court against the participant. In addition, participants who have attained age 59½ may make a withdrawal from the portion of their account attributable to Participant Contributions.

Upon termination of service with the Company, participants become eligible for a lump-sum distribution of the vested portion of their account. Participants may also elect to receive a distribution in substantially equal annual installment payments. Retired and terminated participants who have an account balance in excess of \$1,000 may elect various forms of deferred distribution. If the vested balance is equal to or less than \$1,000, a lump sum distribution without the participant's consent will be made.

Revenue Sharing Account

The Plan shares in investment related revenue, which T. Rowe, the trustee, receives from mutual funds or common or collective trusts attributable to the Plan assets invested in such mutual funds and trusts. The Plan receives a credit for the revenue share on a quarterly basis which is deposited into an ERISA Budget Account. The Plan Sponsor can use the funds in the account to pay for certain approved plan related expenses. During 2024, the total revenue share deposited into the ERISA Budget Account was \$139,234, all of which was applied to Plan administrative expenses in 2024.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are on the accrual method of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investments in shares registered investment companies are valued at quoted market prices of shares held by the Plan at year end. The common or collective trust funds are valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by each fund less its liability. The Plan's interests in the common or collective trust funds are valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year end. There are no participant redemption restrictions for these investments, and participant redemptions are allowed daily. A redemption notice period is applicable only at the plan level. There are no unfunded commitments at December 31, 2024 and 2023.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments are recorded upon distribution. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not yet been paid at December 31, 2024 or 2023.

Expenses

The Company has paid certain expenses incurred by the Plan in the administration of the Plan and are excluded from these financial statements.

Note 3. Risks and Uncertainties

The Plan utilizes various investment instruments, including shares in registered investment companies and common or collective trust funds. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 4. Information Certified by the Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, T. Rowe Price Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 5. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) *Topic 820 Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Recurring Measurements

The following is a description of the valuation methodologies used for assets measured at fair value:

- Shares of registered investment companies are valued using quoted market prices in an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Note 6. Tax Status

The IRS has determined and informed the Company by a letter dated July 3, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Party-In-Interest Transactions

Certain Plan investments are shares of registered investment companies and common or collective trusts managed by T. Rowe Price Trust Company. T. Rowe is the trustee of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Administrative fees and expenses paid by the Plan to T Rowe for administrative and investment management services, net of revenue sharing income, were \$288,209 for the year December 31, 2024. The Company provides certain administrative services at no cost to the Plan.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their employer contributions.

Note 9. Subsequent Events

Subsequent events have been evaluated through September 22, 2025, which is the date the financial statements were available to be issued.
