**Note 1. Description of the Plan**

The following description of the Hudson Scenic Studio, Inc. TPU Local #1 Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**Note 2. General and Eligibility**

The Plan is a defined contribution plan covering all full-time employees that belong to the TPU Local #1 Union of Hudson Scenic Studio, Inc. (the Company). There are no age or service requirements in order to be eligible to participate in the Plan. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

**Contributions**

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. The Plan also permits Roth elective deferrals. A participant's total contribution in any year may not exceed the maximum amounts for that year as specified in Sections 401(k) of the Internal Revenue Code and regulations thereunder. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may also make a discretionary contribution in an amount to be determined from year to year. The Company matched 100% of employee contributions up to a maximum of 7% of their annual eligible compensation during 2024. Contributions are subject to certain limitations.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, annual installments, or annuity contracts. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Notes Receivable from Participants**

Participants are limited to one outstanding loan at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance, whichever is less. Loan terms are generally up to five years and loans are secured by the balance in the participant's account. Interest rates are determined by the Plan Administrator by reference to the prevailing interest rates charged by commercial lenders under similar circumstances on the date the loan is made. Principal and interest are paid ratably through payroll deductions or by direct repayments from the participant if the participant is temporarily laid-off. Notes receivable from participants were \$61,837 and \$100,959 as of December 31, 2024 and 2023, respectively.

**Participant Accounts**

Each participant account is credited with the participant's contributions, the Company's discretionary matching contributions and investment earnings thereon. Contributions to the Plan are invested by the trustee as directed by the participants. Each participant may elect from one or more of the investment options offered pursuant to the provisions of the Plan. The benefit to which a participant is entitled is the vested benefit in the participant's account.

***Vesting***

Participants are vested immediately in their contributions and all Company matching contributions, if any, plus actual earnings thereon.

**Note 3. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Payment of Benefits***

Benefits are recorded when paid.

***Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the date received. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

***Notes Receivable from Participants***

Participant loans are classified as notes receivable from participants and are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses have been recorded as of December 31, 2024 and 2023.

***Administrative Expenses***

Administrative expenses of the Plan are paid by the Plan to the extent not paid by the Plan's sponsor.

***Subsequent Events***

The Plan and management have evaluated events and transactions for potential recognition or disclosure through August 18, 2025, the date the financial statements were available to be issued.

**Note 4. Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 5. Fair Value Measurements**

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, establishes a framework for measuring fair value that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are summarized as follows:

- Level 1** Valuations based on unadjusted quoted prices in active markets for identical assets or liabilities that the Plan can access. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these securities does not entail a significant degree of judgment
- Level 2** Valuations based on quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active or inputs other than quoted prices that are observable, either directly or indirectly
- Level 3** Valuations based on inputs that are unobservable and significant to the overall fair value measurement that reflect the assumptions that market participants would use

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023:

*Mutual funds:* Valued at quoted prices reported in an active market at year-end

*Money market fund:* Valued using the net asset value (NAV) of the fund shares

*Stable value collective trust fund:* Composed primarily of fully benefit-responsive investment contracts, including primarily guaranteed and synthetic investment contracts issued by banks, insurance companies, and other issuers, and is valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund

will sell the investment for an amount different from the report net asset value. Participant transactions (purchases and sales) may occur daily. There are no participant redemption restrictions for these investments; the redemption notice period of twelve months is applicable only to the Plan.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **Note 6. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain plan investments are money market funds or shares of mutual funds managed by Fidelity. Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Certain administrative expenses for the Plan are paid directly by the Company. Certain services are rendered to the Plan by the Company at no cost to the Plan. Additionally, record-keeping fees for the Plan are paid to Fidelity directly from mutual fund companies whose investments are included in the Plan.

## **Note 7. Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Fidelity Management Trust Company. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## **Note 9. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.
