## Reasonable Cause – Missing Independent Qualified Public Accountant’s Opinion

The Plan Sponsor, The Mitchell Gold Co., LLC (the “Debtor”), filed a voluntary petition for relief under Chapter 11 of the United States Bankruptcy Code on September 6, 2023. The Plan Sponsor converted to Chapter 7 of the United States Bankruptcy Code on October 6, 2023. George L. Miller was appointed Chapter 7 Trustee (the “Trustee”) of the Plan Sponsor. As a result of the bankruptcy proceeding and cessation of operations, the Plan has been terminated and distributed by the Trustee, acting on behalf of the Plan Administrator and Plan Sponsor.

The 2024 annual informational return was prepared by Principal Financial Group, the Plan Asset Custodian, from the best information available; that is, data provided by the Debtor’s former personnel and the Debtor’s payroll service. Due to the cessation of business and the filing of the bankruptcy, certain key financial records, subsidiary ledgers, and documentation supporting various policies, transactions, and other matters that would normally be expected to be present in an operating enterprise, are missing or unavailable.

This Plan requires audited financial statements along with a Schedule of Assets, but as a result of the bankruptcy and requirement of the U.S. Bankruptcy Code, the Debtor has no funds available to pay for the audit. Bankruptcy regulations and ERISA require that Plan expenses be paid from Plan Assets. In an effort to minimize costs and preserve participants’ funds, the annual audit will not be prepared. Given that the Plan is terminated and all funds distributed to participants, the Trustee, as Plan Administrator, believes that not preparing an audit is in the best interests of the Plan’s participants. In addition, the Debtor’s former personnel have only provided limited financial records and additional records are no longer available. Accordingly, any additional records needed to complete the audit are no longer available. The Plan’s prior auditors for periods prior to 2023 have resigned and have no interest in performing the audits for 2024 or thereafter. Accordingly, due to lack of information caused by the bankruptcy and the need to preserve Plan Assets for participants’



### 1. Description of Plan

The following description of the Mitchell Gold + Bob Williams 401(k) Plan (the "Plan") provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan's provisions.

#### **General**

The Plan was a defined contribution plan available to eligible employees of The Mitchell Gold Co. (the "Company"). Employees who attained age 21 were immediately eligible to participate in the Plan. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

In August 2023, the Company ceased operations and subsequently filed for bankruptcy. As a result, the Plan was terminated effective September 1, 2023, with full liquidation of the Plan to be completed in 2025. See Note 6.

#### **Contributions**

Prior to August 2023, eligible employees were automatically enrolled at a 3% pre-tax deferral percentage, which would increase by increments of 0.5% annually up to a maximum of 4%, unless they elected an alternative percentage or declined participation. Participants could otherwise elect to contribute up to 75% of their pre-tax and/or after-tax ("Roth") compensation, as defined by the Plan, not to exceed the limits set by the Internal Revenue Service ("IRS"). Participants who attained age 50 were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified plans ("rollovers"). The Company could match the participants' contributions at a rate to be determined annually. The Plan also allowed annual profit sharing contributions that were discretionary and determined by the Board of Directors. The participant must have been employed on the last day of the Plan year and have completed 1,000 hours of service to be eligible for any profit sharing contributions. However, no matching or profit sharing contributions were made during the year ended December 31, 2024.

Upon enrollment in the Plan, a participant could direct participant contributions in any of the investment options offered through the Plan. Participants were able to change their deferral percentages and investment options at any time.

#### **Participant Accounts**

Each participant's account was credited with the participant's and Company's contributions and an allocation of the Plan's net earnings, forfeitures, and administrative expenses. Allocations were based upon participant contributions, earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that would be provided from the participant's vested account.

#### **Vesting**

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and profit sharing contributions, plus actual earnings thereon, was based on years of service. Vesting in discretionary Company matching and profit sharing contributions was in increments of 25% per year with 100% vesting after four years.

However, effective September 1, 2023, participants became fully vested in their accounts including Company matching and profit sharing contributions due to the Plan's termination. See Note 6.

#### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement, or separation, a participant could elect to receive either a partial or lump-sum distribution equal to the value of the participant's vested interest as specified in the Plan. In-service distributions could be made to participants who reached age 59½. Withdrawals from the Plan could also be made upon circumstances of financial hardship, in accordance with provisions specified by the Plan.

#### ***Notes Receivable from Participants***

Plan participants could borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes were secured by the balance in the participants' accounts and bore interest at the prime rate on the first business day of the month in which the loan was requested. The repayment period for general purpose and primary residence loans could not exceed five and 15 years, respectively. Participants could have up to two outstanding loans at any time. Principal and interest were paid ratably through payroll deductions.

#### ***Forfeitures***

Forfeitures of non-vested participant accounts were used to reduce future Company contributions or offset administrative expenses. Forfeitures of approximately \$50,000 and \$38,000 were used to offset Company contributions and administrative expenses, respectively in 2024. Forfeited non-vested accounts of \$0 and approximately \$144,000 were available as of December 31, 2024 and 2023.

#### ***Administrative Expenses***

The Company absorbed certain expenses incidental to the administration of the Plan including internal administrative costs. The Plan absorbed substantially all direct expenses of the Plan, including trustee and asset fees. Distribution and note receivable fees were paid out of affected participants' accounts.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

As a result of a Chapter 11 bankruptcy filed by the Company in 2023, the financial statements of the Plan have been prepared on a liquidation basis, in accordance with accounting principles generally accepted in the United States of America ("GAAP") as of December 31, 2024 and 2023, and for the year ended December 31, 2024. This basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable and the net realizable value of assets is reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value and liabilities are stated at their anticipated settlement amounts.

#### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America required management to make estimates and assumptions that affect the amounts reported in the accompanying financial statements, and notes. Actual results could differ from those estimates.

### 2. Summary of Significant Accounting Policies (Concluded)

#### ***Investment Valuation and Income Recognition***

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable were reclassified as distributions based upon the terms of the Plan document.

#### ***Payment of Benefits***

Benefits were recorded when paid.

#### ***Subsequent Events***

Management has evaluated events occurring subsequent to the date of the financial statements through September 22, 2025, the date the financial statements were available to be issued, and has determined that no additional events have occurred that require adjustments to or additional disclosure in the financial statements.

### 3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company ("Principal"), the trustee of the Plan.

### 4. Risks and Uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 5. Income Tax Status

The Plan has adopted a prototype plan document sponsored by Principal Life Insurance Company ("PLIC"). The IRS has determined and informed PLIC by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

### 6. Plan Termination

In August 2023, the Company filed for Chapter 11 bankruptcy. As a result of this filing, the Plan was terminated September 1, 2023 and participants became fully vested in their account balances. Liquidation of the Plan is expected to be completed during 2025.

### 7. Party-in-Interest Transactions

Fees paid by the Plan to PLIC, an affiliate of the Plan's trustee for recordkeeping services, were approximately \$32,000 during 2024.

Fees paid by the Plan to BNA Wealth, Inc. for investment advisory services were approximately \$10,000 during 2024.

Fees paid by the Plan to Smith Leonard PLLC for accounting and audit services were approximately \$26,000.

Fees paid to other various contract plan administrators, through the Plan's termination, were approximately \$15,000 during 2024.

### 8. Fair Value Measurements

The Plan has adopted Accounting Standards Codification, "Fair Value Measurements and Disclosures" ("ASC 820"), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

#### ***Basis of Fair Value Measurement***

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Mutual funds:*** Valued at the net asset value ("NAV") of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

***Common collective trust funds:*** Valued at NAV as determined by the issuer using estimated fair value of the underlying assets held in the fund, minus liabilities, which are primarily valued through the use of directly and indirectly observable inputs. As the value of these investments is readily determinable, these funds are classified within Level 2 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
