Report of Independent Auditors

To the Participants and Administrative Council of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Global Infrastructure Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America; and
- The information in the accompanying financial statements related to assets held by and certified to by the qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Mergers and Transfers of Net Assets

As described in Note 8, during the years ended December 31, 2024 and 2023, several affiliated companies merged their retirement plans into the Plan, resulting in transfers of net assets totaling \$55,611,984 and \$105,170,878 respectively. Our opinion is not modified with respect to this matter.

Other Matter - 2023 Financial Statements

Other auditors performed an audit of the 2023 financial statements of the Plan. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the Plan that were certified by a qualified institution. Their report dated December 11, 2024 indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, as described in Note 6 to the financial statements, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of an ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Responsibilities of Management for the Financial Statements (continued)

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit;
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements;
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed;

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Auditors' Responsibilities for the Audit of the Financial Statements (continued)

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

December 31, 2024 and 2023

Note 1. Summary of Significant Accounting Policies

Method of Accounting - The accompanying financial statements of Global Infrastructure Savings Plan (the Plan) have been prepared using the accrual basis of accounting.

Investments - The Plan's investments are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset (or paid to transfer a liability) in an orderly transaction between market participants at the measurement date (the exit price). Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Purchases and sales of investments are reflected on a trade-date basis.

Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of either December 31, 2024 or 2023. Related fees are recorded as administrative expenses when incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Payment of Benefits - Benefit payments to participants are recorded upon distribution. There were no participants who elected to withdraw from the Plan but were not yet paid at either December 31, 2024 or 2023.

Expenses - Certain management and administrative services are paid either by the Plan or the Plan sponsor, as provided by the Plan document. Expenses paid directly by the Plan sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation in fair value of investments.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Note 1. Summary of Significant Accounting Policies (continued)

Subsequent Events - Subsequent events have been evaluated through September 24, 2025, which is the date the financial statements were available to be issued.

Note 2. Description of the Plan

The following description provides only general information regarding the provisions of Global Infrastructure Savings Plan (the Plan). Participants should refer to the summary plan description for more complete information.

The Plan was established to provide retirement benefits for eligible employees of T.Y. Lin International Group, Ltd. and its affiliates (collectively, the Company). The Plan is a defined contribution retirement plan covering substantially all salaried and hourly domestic employees of the Company who have completed the eligibility requirements as detailed in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Benefits under the Plan are not insured by the Pension Benefit Guaranty Corporation.

Employees may participate in the Plan after meeting the eligibility requirements as described in the Plan document. Eligible employees include those who have attained the age of 18, hold the status of a United States resident, and are considered to be a full-time or part-time employee, excluding leased and temporary employees, with the exception that the latter completes 1,000 hours during the eligibility period. Eligible employees may become participants in the Plan for purposes of making pre-tax or Roth contributions upon hire. New employees who are eligible to participate in the Plan and do not make alternative elections are automatically enrolled at a 3% contribution rate.

Participants may elect to contribute up to a maximum of 90% of their pre-tax compensation as defined by the Plan, subject to Internal Revenue Code limitations. Salary deferrals may also be designated as (after-tax) Roth deferrals by participants. Participants may also roll over amounts representing distributions from other qualified retirement plans.

The Company may make discretionary matching contributions which are determined annually. The discretionary employer matching contribution is equal to \$.50 for each \$1.00 of salary deferral up to the first 6% of each participant's eligible compensation. For the years ended December 31, 2024 and 2023, the Company elected to make discretionary matching contributions of \$7,260,734 and \$5,879,195 respectively. The Company may also elect to make discretionary profit-sharing contributions to the Plan. Such contributions are allocated in the ratio that each participant's eligible compensation bears to the total compensation paid to all eligible participants for the Plan year. There were no such contributions for the years ended December 31, 2024 and 2023.

Note 2. Description of the Plan (continued)

Individual accounts are maintained for each participant to reflect the participant's contributions and Company matching contributions, as well as allocations of investment earnings or losses and administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Contributions to the Plan are invested as directed by the participants in various investment options. In the absence of participant direction, contributions are invested in a designated target date fund until changed by the participant. Participants must evaluate their own investment goals and objectives and choose the investments best suited to achieve those goals and objectives. Poor investment performance by the investment options selected by the participants may cause their account balance to be lower than contributions made to the Plan.

Participants are immediately fully vested in their elected deferrals, rollovers and actual earnings thereon. Under current Plan provisions, employer matching contributions are fully vested after one year of vesting service. No vesting is earned for less than one year of service. A year of vesting service is earned upon working 1,000 hours in a Plan year. In the event that an eligible participant dies, becomes disabled, or reaches a normal retirement age while still employed, a participant will become 100% vested.

Participants of plans that were merged as a result of acquisitions should refer to the Plan agreement for more specific vesting schedules of the Company's discretionary and profit-sharing contributions.

Upon termination of service due to death, disability or retirement after age 59½, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested account, partial account distributions or annual installments. For termination of service for other reasons, a participant may receive a lump-sum distribution. Account balances of terminated participants that are less than \$7,000 are automatically distributed. Distributions of balances between \$1,000 and \$7,000 are subject to automatic rollover requirements, as defined in the Plan document.

Participants in service may make hardship withdrawals, subject to a \$500 minimum, from their vested contributions upon demonstrating immediate and heavy financial need, as allowed under federal rules.

Note 2. Description of the Plan (continued)

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. A participant may have only one outstanding note at any time and may apply for only one loan each calendar year. Loan terms can range up to 60 months, unless the proceeds are used to acquire the participant's principal residence, in which case, the loan may be repaid over a period longer than 60 months. The interest rate is based on prevailing market conditions and is fixed over the life of the note. The interest rate on outstanding participant notes as of December 31, 2024 and 2023 ranged from 4.25% to 10.25%. Principal and interest are repaid ratably by the participants through payroll deductions. Upon termination of employment with the Company, a participant's outstanding principal balance and accrued interest will not become immediately due and payable. The participant has the option to continue to repay the loan through Fidelity's electronic loan payment service after separation with the Company.

Included in net assets available for benefits are forfeited nonvested accounts of \$56,923 and \$112,470 as of December 31, 2024 and 2023, respectively. Forfeited nonvested accounts may be used to reduce employer contributions or to offset Plan administrative expenses. During the years ended December 31, 2024 and 2023, nonvested amounts of \$72,268 and \$54,697 respectively, were forfeited. The Company's matching contributions were reduced by \$103,773 and \$14,160 from forfeited nonvested accounts for the years ended December 31, 2024 and 2023, respectively.

Note 3. Priorities upon Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants will become 100% vested in their account balances.

Note 4. Tax Status

The Company adopted a volume submitter prototype plan. The Plan is not required to receive a determination letter directly from the Internal Revenue Service, and therefore, the Plan has not received a determination specific to the Plan itself. The prototype plan determination letter has been relied upon by the Plan. The Plan sponsor believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Fair Value Measurements

The *Fair Value Measurements and Disclosures* Topic of the FASB Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Basis of Fair Value Measurement

Level 1	Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities
Level 2	Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly
Level 3	Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

The following tables set forth, by level within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. As required, assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. In accordance with generally accepted accounting principles, certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the following tables are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

Level 1 Measurements

The fair values of the mutual funds are determined by reference to the funds' underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are traded on national securities exchanges and are valued at the net asset value on the last business day of each period presented.

The self-directed brokerage accounts are invested in money market funds, mutual funds, common stocks, preferred stocks, and unit investment trusts. The following is a description of the valuation methodologies used for investments in self-directed brokerage accounts:

- The money market funds represent shares held in short-term fixed income mutual funds.
- The fair values of the mutual funds are determined by reference to the funds' underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are traded on national securities exchanges and are valued at the net asset value on the last business day of each period presented.
- Common and preferred stocks are traded in active markets on national and international securities exchanges and are valued at closing prices on the last business day of each period presented.
- Unit investment trusts are traded in active markets and are valued at closing prices on the last business day of each period presented.

Note 5. Fair Value Measurements (continued)

Measurements Using Net Asset Value as a Practical Expedient

The collective investment trusts are valued at the net asset value per share (or its equivalent), used as a practical expedient to estimate fair value. The net asset value is based on the fair values of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will redeem the investment for an amount different than the reported net asset value.

The collective investment trusts are direct filing entities (DFE) and file a Form 5500 annual report with the U.S. Department of Labor. The Plan is not required to disclose the significant investment strategies of DFE investments. Redemptions are available on a daily basis with no notice period.

Note 6. Information Certified by Plan Trustee

Note 7. Risks and Uncertainties

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.

Note 9. Party-in-Interest Transactions

Certain Plan investments are managed or held by Fidelity Management Trust Company, the Trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions under ERISA.

Fidelity Management Trust Company provides certain administrative services to the Plan pursuant to a service agreement. Administrative services are primarily paid through a quarterly administrative fee charged to participants.

Note 10. Delinquent Participant Contributions

U.S. Department of Labor (DOL) regulations provide that participant contributions to retirement plans must be made on the earliest date that they can reasonably be segregated from the employer's general assets, but in no event later than 15 business days following the month in which the participant contributions were withheld. An employer can be held liable for investment losses and interest incurred during the period of any delay in remitting the contributions to the Plan, and the late deferrals would be considered prohibited transactions that must be reported on the Plan's Form 5500 until corrected. During the years ended December 31, 2024, 2023, 2022, and 2021, the Company remitted contributions totaling \$21,254,196, \$17,583,550, \$10,300,520 and \$3,291,471, respectively, in a timeframe that did not comply with the timeliness requirements prescribed by DOL regulations. As of the date the financial statements were available to be issued, the Plan had corrected the delinquent contributions by making a contribution for lost earnings to the Plan. The corrections and any excise taxes, if applicable, will be made from the Company's assets and not from assets of the Plan.

Note 11. Reconciliation of Financial Statements to Form 5500
