Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Ag Business Solutions, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a multiple employer, defined contribution plan sponsored by Ag Business Solutions, LLC (the Company), with cash or deferred provisions in Section 401(k) of the Internal Revenue Code (the Code). The Plan was established effective January 1, 1997 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). There have been multiple amendments since the inception of the plan to incorporate additional employers, allow Roth contributions, and amend the definition of compensation. Subsequently, effective January 1, 2025, and September 1, 2025, the Plan was amended to provide coverage to additional entities. As of the effective date, the additional entities have adopted the Plan.

Contributions: The Plan allows participants to contribute up to 100% of their compensation, as defined, subject to certain limitations. The amount of the Company matching contribution, if any, is determined each plan year. For 2024, the Company matched 50% up to 15% of participants' eligible compensation, as defined. Participants have the ability to direct both employee and Company contributions to the investment option of their choice.

Participant Accounts: Each participant's account is credited with the participant's own contribution and an allocation of the Company's contribution and Plan earnings and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Eligibility: All employees of the Company are eligible to participate in the Plan after completing six months of service and attaining age 18. Additionally, employees must complete one year of service to be eligible for the Company matching contribution.

Vesting and Forfeitures: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer contribution portion of their accounts is based on years of continuous service. Employer contributions and actual earnings thereon vest over a six-year period at 20% per year, beginning after the second year of service. Forfeitures are used to pay Plan expenses and reduce future Company contributions. As of December 31, 2024 and 2023, there was \$3,371 and \$21,608 of forfeitures, respectively, available to pay Plan expenses and reduce Company contributions. During the year ended December 31, 2024, \$25,885 of forfeitures were used to reduce Plan expenses.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the net appreciation reported by the Plan.

Benefit Payments: The Plan provides benefits for eligible participants upon retirement, death, termination, or permanent disability according to the form of payment elected by the participant within the limitations defined in the Plan. Distributions shall be made in the form of a lump sum or in equal annual installments. The Plan allows hardship withdrawals in accordance with Internal Revenue Service (IRS) regulations. Among other things, the withdrawal must be necessary in light of immediate and heavy financial needs of the participant and is limited to certain purposes.

Notes Receivable from Participants: The Plan provides that a participant can borrow funds against his or her account balance. The amount of a loan is limited to the lesser of \$50,000 or 50% of their vested account balance. The loan amount must be a minimum of \$1,000. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid through payroll deductions.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Investment management fees are also paid by the Plan and reflected as a reduction of applicable investment returns. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investment securities. The underlying investment securities are exposed to various risks, such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participants' individual account balances.

Subsequent Events: Plan management has performed an analysis of activities and transactions subsequent to December 31, 2024 to determine the need for any adjustment to and/or disclosures within these financial statements for the year ended December 31, 2024. Plan management has performed their analysis through September 4, 2025, which was the date that the financial statements were available to be issued and has determined there are no subsequent events to recognize or disclose.

NOTE 3 – CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company ("PLIC"), Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, and PLIC as agent for Principal Global Investors Trust Company.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents of the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Collective Trusts: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement. The fund invests in a diversified portfolio of assets such as equities, fixed income securities, and other investments in accordance with its stated investment strategy.

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted market prices on nationally recognized securities exchanges (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value for certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated March 16, 2023 that the Plan is designed and operating in accordance with applicable sections of the Internal Revenue Code. The Plan has been subsequently amended and the Plan administrator still believes the Plan is being operated in compliance with the applicable regulations.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by employees or officers of the Company. Certain professional fees for the administration and audit of the Plan were paid by the Company. Investment management and custodial fees paid by the Plan to PLIC and affiliates of PLIC qualify as party-in-interest transactions. Fees of \$22,540 were paid by the Plan to the Plan's recordkeeper during the Plan year for certain services related to the Plan.

All of the Plan's units of participation in pooled separate accounts managed by Principal Life Insurance Company, mutual funds managed by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, and units of participation in a stable value collective trust and other collective investment trusts managed by Principal Global Investors Trust Company, an affiliate of PLIC, qualify as party-in-interest investments. Notes receivable from participants also qualify as party-in-interest transactions.
