Report of Independent Auditors

To the Administrator of Infios US., Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Körber Supply Chain US, Inc. 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, including the related notes (collectively referred to as the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Notes to Financial Statements

December 31, 2024 and 2023

1. Description of Plan

The following description of the Körber Supply Chain US, Inc. 401(k) Savings Plan (the “Plan”) provides only general information. Detailed descriptions of the Plan’s benefits and provisions are contained in the Plan documents, which can be obtained from Körber Supply Chain US, Inc. (the “Company”). On March 4, 2025, the name of the Company was changed to Infios US, Inc. Effective April 1, 2025, the name of the Plan was changed to the Infios US., Inc. 401(k) Plan.

General

The Plan is a defined contribution plan offered to all full-time employees of the Company and Körber Supply Chain NA, LLC who are age 21 or older (“Participants”). Effective July 1, 2023, Körber Supply Chain NA, LLC merged into Körber Supply Chain, LLC. The now-former employees of Körber Supply Chain NA, LLC continued to actively participate in the Plan through December 31, 2023, after which they became eligible to participate in another plan and their balances within the Plan were transferred, as described in Note 9. The Plan excludes employees covered under a collective bargaining agreement, nonresident aliens who do not receive any compensation from U.S. sources, independent contractors, and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”), and the Internal Revenue Code of 1986, as amended (“IRC”).

Administration

The Plan is administered by the Company through its Retirement Plan Committee (the “Committee” or “Plan Administrator”). The Committee has been given all powers necessary to carry out its duties, including, but not limited to, the power to administer and interpret the Plan, to answer all questions affecting eligibility of participants in the Plan, and to authorize disbursements for the payment of Plan benefits.

The Company entered into an agreement with Principal Life Insurance Company (“Principal Life”), a member of Principal Financial Group, to provide an array of core services, most notably recordkeeping, transaction processing and compliance testing. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (“Principal Trust”), also a member of Principal Financial Group, is the trustee of the Plan and has the authority to invest and control all contributions made to it under the Plan.

Contributions

Each year, participants may make salary deferral contributions up to 100% of pre-tax or after-tax annual compensation, as defined in the Plan, up to the maximum allowed by the IRC. The maximum annual deferral for 2024 was \$23,000. Participants age fifty and over were eligible to make additional catchup contributions of up to \$7,500 in 2024. The Plan provides for an automatic enrollment, with a pre-tax contribution election of 6%. The Plan also provides an auto escalation feature for auto-enrolled participants whereby the pre-tax contribution election increases 1% each year to a maximum of 10%. Participants have the option to opt out of automatic enrollment. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company may make discretionary matching contributions to the Plan. During the year ended December 31, 2024, the Company matched 50% of the first 6% of each Participant’s compensation contributed as elective deferrals.

Notes to Financial Statements

Participants' Accounts

Each Participant's account is credited with the participant's contributions and allocations of (a) the employer contributions, (b) Plan earnings or losses, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is equal to the vested balance in the participant's account.

Investment Options

Upon enrollment in the Plan, a Participant may direct contributions in a variety of investment options. All funds vary in types of investments, rates of return, and investment risk. Participants may elect, on a daily basis, to have all or part of their account balances and future contributions transferred from one fund to another or in any combination.

Vesting

Participants vest in Company matching contributions at a different rate based on the entity the participant originated from. All Körber Supply Chain US, Inc. and Körber Supply Chain NA, LLC employees vest at a rate of 40% after the first year of service and at a rate of 30% per year thereafter until 100% vested after three years. All legacy Accellos, Inc. and legacy Redtail Solutions, Inc. employees are vested 100% for employer contribution. All legacy enVista, LLC employees who transferred into the Plan on December 1, 2022 vest in existing enVista matching contributions under enVista's vesting schedule (a rate of 50% after one year of service and 100% after two years). For any new matching contributions received under the Plan following transfer, these employees vest in accordance with the schedule of Körber Supply Chain US, Inc. noted above. Participants are always 100% vested in their salary deferral contributions.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$500 up to the lesser of 50% of their vested account balance or \$50,000, reduced by any outstanding notes. Participants are limited to no more than two outstanding loans. Note terms range from one to five years or extend to a reasonable period of time consistent with commercial home loan practices for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan's management. Principal and interest are paid ratably through semimonthly payroll deductions. Interest rates on outstanding participant loans ranged between 5.25% and 10.50% at December 31, 2024 and 2023.

Payments of Benefits

Upon termination of service, death, disability, or attainment of normal retirement at age 65, a participant may elect to receive a lump-sum distribution, installment payments equal to the vested value of the participant's account, or transfer these amounts to another qualified retirement plan or individual retirement account. Participants may also take voluntary in-service withdrawals upon reaching age 59½, qualified reservist distributions, and hardship withdrawals if certain criteria are met as outlined in the Plan document. In addition, the plan allows withdrawals where financial hardship can be demonstrated by the Participant as defined in the Plan document.

Forfeited Accounts

Forfeitures of nonvested participant balances are used to pay administrative expenses and reduce employer matching contributions for the Plan year in which the forfeiture occurs. At December 31, 2024 and 2023, forfeited nonvested accounts were \$98,268 and \$86,824, respectively. Forfeitures of \$68,628 and \$68,966 were utilized during the years ended December 31, 2024 and 2023, respectively. The remaining unused forfeiture balance was \$8,867 and \$65 as of December 31, 2024 and 2023, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by Principal Trust. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments, and the Plan Administrator deems the participant's loan to be in default, the participant's loan balance is reduced, and a benefit payment is recorded.

Contributions

Employer and participant contributions are accrued by the Plan in the year in which they are withheld from compensation or become obligations of the Company.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

3. Information Certified by Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the United States Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan Administrator obtained certifications from Principal Trust that the information provided to the Plan Administrator by Principal Trust related to the following information included in the accompanying financial statements and supplemental schedule required by ERISA is complete and accurate:

4. Fair Value Measurements

Fair value is defined as the price that will be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value is based on a three-level hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts ("PSAs")

Pooled separate accounts are valued at the net asset value ("NAV") of the underlying assets as reported by the investment manager, Principal Trust, at year end. The NAV of these investments is determined using the market value or fair value of the underlying securities if market data are unavailable. The PSAs are invested in a broad mix of underlying mutual funds. In order to prevent excessive or abusive trading, the Company may prescribe rules that limit the number of transfers that participants can make between funds.

Registered Investment Companies

Registered investment companies are valued at the quoted market prices of shares held by the Plan at year end in the active market on which the individual securities are traded.

Common Collective Trusts

The common collective trusts are valued at the NAV as reported by the investment manager at year end based upon audited financial statements. The funds' underlying assets consist of investment contracts and security-backed contracts.

The methods described above may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Related-Party and Party-in Interest Transactions

Certain Plan investments are shares of registered investment companies, pooled separate accounts, and common collective trusts managed by affiliates of Principal Trust as defined by the Plan. Fees paid by the Plan for investment management services were included as a reduction of the return of each fund. The Plan also issues loans to participants, which are secured by the vested balances of the participants' accounts. As such, transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. In addition, the Company provides certain accounting, recordkeeping and administrative services to the Plan for which it is not compensated.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. Income Tax Status

The Plan document is a prototype basic savings plan sponsored by Principal Financial Group. In an opinion letter dated June 30, 2020, the Internal Revenue Service (the "IRS") stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress, and the plan believes it is no longer subject to income tax examinations for years prior to 2021.

8. Risks and Uncertainties

The Plan utilizes various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Plan Transfers

Effective January 1, 2024, the former employees of Körber Supply Chain NA, LLC who were Participants in the Plan became eligible to participate in a benefit plan under Körber Supply Chain, LLC, the Koerber Supply Chain Savings Plan. These participants were no longer eligible to participate in the Plan on this date. The account balances of these participants were transferred out of the Plan on January 19, 2024, totaling \$2,076,942. This amount consisted of a cash transfer of \$2,031,303 and a participant loan transfer of \$45,639.

10. Subsequent Events

The Company has evaluated subsequent events through September 19, 2025, which is the date the financial statements were available to be issued. There were no events or transactions discovered during the evaluation that require recognition or disclosure in the financial statements other than those described below.

On October 1, 2024, the Company acquired MercuryGate International, Inc. ("MGI"). Effective January 1, 2025, MGI was added as a participating employer to the Plan. On that date, the

acquired employees of MGI became eligible to participate in the Plan. The MercuryGate International, Inc. 401(k) Plan merged into the Plan on March 1, 2025, and Participant balances transferred into the Plan on March 3, 2025 totaled \$35,556,009. This amount consisted of a cash transfer of \$35,492,247 and an in-kind transfer of \$63,762 for the Fidelity Managed Income Portfolio fund.

Effective April 1, 2025, the Plan's automatic enrollment provision was amended to change the initial pre-tax contribution rate from 6% to 8%.
