Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Jeff Belzer 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 1. DESCRIPTION OF THE PLAN

The following description of the Jeff Belzer 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan adoption agreement for a more complete description of the Plan's provisions.

General - The Plan is a single-employer defined contribution 401(k) plan covering substantially all employees of Jeff Belzer's Todd Chevrolet, Inc., Jeff Belzer New Prague Auto, Inc., and Jeff Belzer's Roseville Auto, Inc. (collectively, the Company) who have completed one year of service and are age twenty-one or older. An employee enters the Plan the first day of the Plan year (January 1) or the first day of the 7th month of the Plan year (July 1) coinciding with or next following the date eligibility requirements are met. The Plan excludes employees who are collective bargaining (union) employees, non-resident aliens and leased employees.

The Company is the Plan Sponsor and Plan Administrator. Ascensus Trust Company has been appointed Plan Custodian (the Custodian). Professional Pension Services provided recordkeeping services for the Plan. Effective January 1, 2024, DWC ERISA Consultants LLC began providing recordkeeping services for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan was adopted effective January 1, 1995, and was restated and amended effective March 1, 2024.

Investments held with Ascensus Trust Company are invested in mutual funds and a common/collective trust fund.

Participant Accounts - Each participant's account is credited with the participant's contributions plus an allocation of (a) the Company's discretionary matching contributions, if any, (b) the Company's additional matching contributions, if any, and (c) Plan earnings or losses, net of expenses. Allocations are based on account balances or elective deferrals as defined in the Plan.

1. DESCRIPTION OF THE PLAN (Continued)

Contributions - Participants are allowed to make elective pretax (traditional 401(k)) or after-tax (Roth 401(k)) deferral contributions up to IRS limits and not to exceed 100% of annual compensation, as defined in the Plan. The Plan includes an automatic enrollment feature, whereby participants are enrolled in the Plan at a 6% deferral rate with no automatic escalation. Participants that are automatically enrolled that do not make an investment election will have their deferrals invested in a default fund that is selected by Plan officials. The Plan allows participants age 50 and older to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

Participants are eligible for Company discretionary matching contributions equal to a uniform percentage of the participant's elective deferrals. The Company will determine the discretionary percentage semi-annually, and the total discretionary matching contribution made will be based on forfeitures available at the time the match is made. During 2024, the Company made matching contributions for eligible employees of Jeff Belzer's Roseville Auto, Inc. equal to 50% of each participant's eligible contributions to the Plan up to 5% of that participant's compensation. No matching contributions were made for employees of Jeff Belzer's Todd Chevrolet, Inc. or Jeff Belzer New Prague Auto, Inc. in 2024.

Each year, at its discretion, the Company may choose to make an additional matching contribution allocated to all eligible participants equal to a uniform percentage of participant salary deferrals. A participant must complete a year of service (1,000 hours of service) during the Plan year and be employed on the last day of the Plan year in order to be eligible for the Company additional matching contribution, unless the participant terminates employment because of death, disability, or normal retirement. There were no Company additional matching contributions made to the Plan for the year ended December 31, 2024.

Vesting - The participant's elective deferral and earnings thereon are always 100% vested. For the Company's matching contributions and earnings thereon, vesting is based on years of service. A participant is 100% vested after six years of credited service which includes years of service with the Company prior to the effective date of the Plan. Notwithstanding the above, a participant's account will be fully vested upon death, disability or retirement.

Forfeitures - Forfeitures may be used to pay administrative expenses of the Plan and/or reduce future employer contributions payable under the Plan. At December 31, 2024 and 2023, forfeitures available to pay administrative expenses or reduce future employer contributions payable were \$9,478 and \$4,804. In 2024, \$1,612 was used to pay administrative expenses of the Plan. No forfeitures were used to reduce employer contributions payable in 2024.

Fee Credit Account - Monthly revenue sharing payments are credited to the Plan by Ascensus Trust Company and are tracked in a fee credit account to be used to pay expenses of the Plan. At December 31, 2024 and 2023, the balance of the account was \$ - and \$32,078. In 2024, \$50,992 was used to pay administrative expenses of the Plan.

Payment of Benefits - On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's account in a lump-sum amount, or in minimum required distributions as specified in the Plan. For termination of service due to other reasons, participants with vested accounts of less than \$5,000 will have their vested balance distributed as soon as administratively possible. Participants with vested accounts greater than \$5,000 may receive the value of the vested interest in his or her account as a lump-sum distribution or minimum required distributions. The Plan also allows for in-service withdrawals and hardship withdrawals subject to Plan provisions.

Investment Options - Participants are allowed to direct the investment of their contributions among the various investment options offered by the Plan. Company contributions are allocated on the same basis as employee contributions.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting.

Estimates - The preparation of any financial statements in accordance with U.S. generally accepted accounting principles may require management to make estimates and assumptions that affect certain amounts reported and disclosed in the financial statements. Actual results could differ from such estimates.

Valuation of Investments - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - The Company pays certain administrative expenses on behalf of the Plan. Expenses that are paid from Plan assets are reflected in the statement of changes in net assets available for benefits.

4. INCOME TAX STATUS

The plan document adopted by the Plan obtained its latest opinion letter on September 6, 2023, in which the Internal Revenue Service stated that the plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself. The Plan has been amended since receiving the opinion letter; however, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected.

5. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from, or corroborated by, observable market data by correlation or other means; and Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement and have the lowest priority.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the methodologies used to measure the fair value of the Plan's investments.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust fund: A stable value fund that is composed primarily of fully benefit-responsive contracts that is valued at the net asset value of units in the collective trust. Plan management believes using net asset value as a practical expedient to estimate fair value is appropriate for investments in the common/collective trust. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. The Plan's investment in the common/collective trust fund is subject to the withdrawal and redemption restrictions listed in the Offering Statement. The Plan has no unfunded commitments relating to the common/collective trust fund at December 31, 2024 and 2023.

The method used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of the common/collective trust fund could result in a different fair value measurement at the reporting date.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all of the assets will be distributed to the participants based upon the balance in their respective accounts.

7. PARTY-IN-INTEREST TRANSACTIONS

The Plan paid Ascensus Trust Company, the Custodian of the Plan, \$22,866 during 2024.

The Plan Sponsor pays certain administrative expenses of the Plan.

8. SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 16, 2025, the date on which the financial statements were available for issue, and identified no further significant events or transactions to disclose.
