## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Chilton Investment Company, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### Basis for Opinion

## Notes to Financial Statements

December 31, 2024

### **1. Description of Plan**

The following description of the Chilton Investment Company, Inc. 401(k) Plan (the “Plan”) provides general information about the Plan’s provisions. Chilton Investment Company, Inc. (the “Plan Sponsor” and “Plan Administrator”) is the Plan sponsor. Participants should refer to the Plan Document and Summary Plan Description for a more complete description of the Plan’s provisions, copies of which may be obtained from the Plan Sponsor.

#### **General**

The Plan is a contributory savings plan for the benefit of all eligible employees of Chilton Investment Company, Inc. and its affiliates (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Chilton Investment Company, Inc. 401(k) Plan Committee (the “Committee”) is responsible for the general administration of the Plan. Fidelity Management Trust Company is the record-keeper and trustee of the Plan (the “Trustee”).

#### **Eligibility of Participants**

The Plan is a defined contribution plan covering substantially all full-time employees of the Company who have met the eligibility requirements, as defined in the Summary Plan Description. Eligible employees can become participants on the first day of the month following attainment of eligibility. Employees of the Plan Sponsor are eligible to become participants on the first day of the month following the attainment of age 21.

#### **Contributions**

Each year, participants may contribute up to the lesser of 60% of pretax annual compensation or \$23,000 (the contribution limit for 2024 determined by the Internal Revenue Service), as defined in the Plan’s provisions. Contributions may also be designated as Roth 401(k) or after-tax contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Unless affirmatively elected otherwise, all newly eligible employees are auto-enrolled into the Plan at a 4% salary deferral rate.

### Notes to Financial Statements (continued)

#### **1. Description of Plan (continued)**

Discretionary employer matching contributions may be made at the discretion of the Company. The employer matching contribution for 2024 is equal to 25% of the employee contribution (excluding catch-up contributions) up to a maximum of \$4,500. In 2024, the Company made discretionary matching contributions of \$296,292.

Additionally, the Plan provides for a discretionary non-elective employer contribution that requires the participant be employed on the last day of the Plan year and have worked 1,000 hours during the Plan year, unless they retire, become disabled, or die during the Plan year. In 2024, the Company made zero non-elective employer contributions.

All contributions are subject to certain limitations of the Internal Revenue Code (the “Code”).

Participants direct their elective contributions into various investment options offered by the Plan and can change their investment options on a daily basis. The Company’s discretionary matching and non-elective employer contributions, if any, are allocated in the same manner as that of the participants’ elective contributions.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s contributions and employer contributions, if any, as well as an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses incurred by the Plan with the exception of loan origination and other participant-directed expenses, which are charged directly to the respective participant’s account. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Employees hired subsequent to February 1, 2020, vest in the employer matching contribution and their discretionary non-elective employer contribution, if any, over two years, 50% in year 1 and 50% in year 2. Participants hired prior to February 1, 2020, who had a balance in the employer match source, will continue to immediately vest in the Company’s contributions and earnings thereon. For the purposes of calculating vesting, the Plan uses a participant’s original date of hire.

#### 1. Description of Plan (continued)

##### **Forfeited Amounts**

Forfeited balances may be used to pay administrative expenses or reduce future employer contributions. Unallocated forfeiture balances as of December 31, 2024 and 2023, totaled \$12,927 and \$8,952, respectively. During the year ended December 31, 2024, \$11 of previously forfeited balances was used to pay administrative expenses and \$0 was used to reduce employer contributions.

##### **Notes Receivable from Participant**

Participants may borrow from their accounts up to the lesser of \$50,000 or 50% of their vested account balance. A participant may have only one loan outstanding at any given time. Loan terms cannot exceed beyond 5 years unless such loan is for the purchase of a participant's primary residence. The \$50,000 limit is reduced by the participant's highest outstanding loan balance during the preceding 12-month period. The loans bear interest at a rate commensurate with local prevailing rates based upon the "prime" rate as determined quarterly by the Plan Administrator. Principal and interest is paid ratably through payroll deductions. Interest income on loan balances is reinvested into the investment election determined by the Plan participants. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded. As of December 31, 2024 and 2023, participant loans outstanding were \$68,936 and \$28,109, respectively, with rates ranging from 8.00% to 9.50% and maturity dates through 2029. Interest income earned on notes receivable from participants is recorded on the accrual basis.

##### **Payment of Benefits**

Upon separation from service with the Company due to death, disability, retirement or termination, a participant has the option of receiving a lump sum distribution or remaining in the Plan as long as the vested account balance is greater than \$7,000 (\$5,000 prior to modification allowed by the SECURE 2.0 Act of 2022). Vested account balances of \$7,000 (\$5,000 prior to modification allowed by the SECURE 2.0 Act of 2022) or less will automatically be distributed.

In-service withdrawals are available in certain limited circumstances, as prescribed in the Plan's provisions. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined in the Plan's provisions. Hardship withdrawals are strictly regulated by the Internal Revenue Service (the "IRS").

#### **1. Description of Plan (continued)**

##### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan's provisions to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in their accounts, including any employer contributions for which they were not already vested and the Plan Administrator will facilitate the distribution of account balances in single lump sum payments to each participant.

#### **2. Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

##### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

##### **Contributions**

Contributions from Plan participants and discretionary matching contributions, if any, from the Company are recorded in the year in which the employee contributions are withheld from compensation. Discretionary non-elective employer contributions, if any, are recorded in the year earned.

##### Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price).

*Money market funds:* Valued at the net asset value (“NAV”) of the fund (Level 1 inputs).

*Mutual funds (including mutual funds held by self-directed brokerage account):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1 inputs).

*Self-directed brokerage accounts:* Investments held in the self-directed brokerage account are mutual funds, ETFs and money market funds. Mutual funds and money market funds are valued at NAV of the fund as detailed above. Exchange traded funds are valued at the year-end closing price reported on the active markets on which the individual securities are traded (Level 1 inputs).

*Common collective trusts:* Valued at the NAV or equivalent based on units of the common collective trusts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the common collective trust less its liabilities. This practical expedient is not used when it is determined to be probable that the common collective trust will sell the investment for an amount different than the reported NAV.

See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan’s gains and losses on investments bought and sold during the year as well as investments held at the end of the year.

##### Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related expenses are recorded as administrative expenses when they are incurred.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Administrative Expenses**

Expenses of maintaining the Plan are paid directly by the Plan, unless the Company elects to pay the expenses. Expenses that are paid by the Company are excluded from these financial statements. Expenses related to the administration of notes receivable and other participant-specific expenses are charged directly to the participant's account. Plan expenses are included in administrative expenses on the Statement of Changes in Net Assets Available for Benefits. Investment related expenses are included in the net appreciation in fair value of investments on the Statement of Changes in Net Assets Available for Benefits.

#### **3. Information Certified by a Qualified Institution**

The Plan Sponsor having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental Schedule of Assets (Held at End of Year) was obtained or derived from information obtained by the Plan Sponsor and certified as complete and accurate by Fidelity Management Trust Company ("Fidelity"), a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, and notes receivable from participants, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Investment activity, including net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- The information for all mutual funds, money market, self-directed brokerage accounts, common collective trusts and participant loans listed in the Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown in the ERISA-required supplemental schedule.

#### 4. Fair Value Measurements

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs, other than Level 1 quoted prices in active markets, for assets and liabilities that are observable, either directly or indirectly. Level 2 inputs include the following:

- quoted prices for similar assets and liabilities in active markets
- quoted prices for identical or similar assets or liabilities in markets that are not active
- observable inputs other than quoted prices that are used in the valuation of the asset
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own inference about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety.

The Plan is applying the practical expedient as of December 31, 2024 and 2023, to its investments in three common collective trusts. Each trust seeks specific investment goals highlighted below as follows:

- T. Rowe Price Stable Value Fund – seeks principal preservation, liquidity and a steady competitive return by investing in a diversified portfolio of guaranteed investment contracts.
- Pimco Total Return Fund – seeks to maximize total return through a diversified portfolio of fixed income instruments while preserving investment capital.
- Clearbridge International Growth Fund – aims for long-term capital appreciation by investing in common stocks of foreign companies.

These common collective trust funds are redeemable at net asset value under agreements with the underlying funds. However, it is possible that these redemption rights may be restricted by the funds in the future in accordance with underlying fund agreements. Due to the nature of the investments held by the funds, changes in market conditions and the economic environment may significantly impact the net asset value of the funds, and consequently, the fair value of the Plan's interest in the funds. Furthermore, changes in the liquidity provisions of the funds may significantly impact the fair value of the Plan's investments.

#### 5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

#### 6. Related-Party Transactions and Party-In-Interest Transactions

Certain of the investments held by the Plan as of December 31, 2024 and 2023, are shares of investment funds managed by the Trustee. Additionally, for participants who have elected to take a participant loan, the loans are secured by the respective participant's account balance. Therefore, the Plan's transactions related to such investments and participant loans qualify as party-in-interest transactions; however, such transactions are exempt from prohibited transaction rules of ERISA.

#### **7. Tax Status**

Effective July 1, 2022, through the adoption of a Fidelity Pre-Approved Defined Contribution Plan, the Plan was amended and restated. The IRS issued an opinion letter dated June 30, 2020, stating that the pre-approved defined contribution plan document was designed in accordance with applicable requirements of the Code as of that date.

Although the Plan has been amended since receiving the opinion letter, management of the Plan believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### **8. Subsequent Events**

Management evaluated events subsequent to December 31, 2024, for the Plan through September 25, 2025, the date the financial statements were available to be issued. Based on this evaluation, management determined that no events were required to be recognized or disclosed in the Plan's financial statements.
