We have performed an audit of the accompanying financial statements of Drury Southwest Team Member Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## **NOTES TO FINANCIAL STATEMENTS**

**December 31, 2024 and 2023**

### **NOTE 1 — DESCRIPTION OF PLAN**

The following description of the Drury Southwest Team Member Savings Plan (the Plan) (formerly Drury Employee Savings Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all eligible employees of Drury Southwest, Inc. (the Company) who have two months of service and are twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Fidelity Management Trust Company (Fidelity) was the trustee of the Plan as of December 31, 2023, and for the period of January 1, 2024 to June 28, 2024. Effective July 1, 2024, the Plan was amended and restated to appoint Empower Trust Company, LLC (Empower) as the new trustee for the Plan and recordkeeper. As part of the amendment and restatement effective July 1, 2024, the Plan's entry date was changed from immediate upon meeting the eligibility requirements to the first day of the month following the satisfaction of the eligibility requirements. The Company is the plan administrator and has overall responsibility for the operation and administration of the Plan. The plan administrator, along with CBIZ Investment Advisory Services LLC as an ERISA 3(38) advisor, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### **Contributions**

Participants may contribute up to 60% of annual eligible compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also elect to make after-tax contributions to a Roth account.

The Plan provides for safe harbor matching contributions at 100% of the first 3% and 50% of the following 2% of an employee's contribution. The Company's maximum contribution is 4% (on a 5% employee contribution) for the year ended December 31, 2024.

Contributions are subject to certain limitations. Participants may also transfer funds to the Plan from other qualified retirement plans.

Participants of the Plan elect investment accounts in which their contributions, as well as Company contributions, are invested. The investment account options comprise various degrees of risk and return.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, Company contributions, and investment earnings based on their selected investments. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions and Company safe harbor matching contributions plus earnings thereon. Participants are also fully vested in their accounts transferred from other plans.

**Notes Receivable From Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of the participant's vested account balance, whichever is less. The loans are secured by the balance in the participant's account and only one loan may be outstanding at any given time. The loan interest rate is determined by the plan administrator at the time of loan initiation. Principal and interest is paid ratably through monthly payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability or retirement, participants become fully vested and may elect to receive an amount equal to the value of their accounts in either a lump-sum amount or in installments, depending on the size of the participant's account balance at the time of termination. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account in a lump-sum distribution. Participants with a vested account balance of less than \$1,000 must take a lump-sum distribution. The account of a participant with a vested account balance between \$1,000 and \$7,000 who does not request a distribution will be rolled to an individual retirement account in the participant's name.

The Company may authorize certain withdrawals from a participant's account in the event of proven financial hardship or at the age of 59½. Hardship withdrawals are subject to specific statutory and regulatory requirements.

**Reclassifications**

Certain reclassifications have been made to the financial statements for the year ended December 31, 2023 to conform to the presentation for the year ended December 31, 2024.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan were prepared on the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Contributions**

Contributions from participants are recorded in the year in which the employee contributions are withheld from compensation. Contributions from the Company are recorded in the year in which the related participant's wages are paid.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Plan expenses primarily consist of recordkeeping and investment advisory fees. Fees related to the administration of notes receivable from participants and benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

The Plan's administrative and advisory costs are paid via a per participant fee charged quarterly to each participant's account. Plan expenses were \$27,577 for the year ended December 31, 2024.

**Subsequent Events**

Subsequent events were evaluated through September 23, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 — FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds and money market funds:* valued at the daily closing price reported by the fund, which is the quoted net asset value (NAV) of shares.

*Common/collective trusts:* The stable value common/collective trusts invest in funds in which the underlying assets consists primarily of fully benefit-responsive investment contracts. The funds are valued at NAV, the practical expedient to estimate fair value.

**NOTE 4 — INFORMATION CERTIFIED BY TRUSTEE**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity for the period December 31, 2023 to June 28, 2024 and Empower from July 1, 2024 to December 31, 2024.

**NOTE 7 — TAX STATUS**

As this Plan is a volume submitter pre-approved defined contribution plan, the Internal Revenue Service issued a letter dated November 14, 2022, stating that while they do not issue a determination as to whether a specific employer’s plan is qualified, any employer who adopts this Plan will be considered to have a plan qualified under code Section 401(a) provided all the terms are not more favorable for officers, owners, or highly compensated employees than for other employees. Management believes that the Plan is operating in compliance with all the terms provided in the nonstandardized plan agreement.

The Plan is subject to examination by the IRS for the statutory period.

**NOTE 8 — RISKS AND UNCERTAINTIES**

The Plan invests in various types of investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
